1. (S/NF/SK) MISSION: To locate and describe the fishing vessel [redacted] determine whether there is drug-contraband, determine the offload time and place, and present location.

2. (S/NF/SK) CUEING: Encrypted coordinates 422960/351900. Later, the ship's name and the requested EEI.

3. (S/NF/SK) COMMENTS BY MONITOR (018):

a. Inclemencies: Persistant cough.

b. 095 appeared to have good "site contact" from the very start of the session. Impressions were strong and there was little or no detectable analysis on 095's part, except as noted in next item.

c. At one point, when finding the offload time, 095 found two, and experienced quite a bit of confusion about the feeling of "strangeness" concerning the first. Later in the session, while trying to locate the offload place, 095 was following the path of the [redacted] and detected a last minute change of direction. 095 commented at that point (but did not write down) that the previous feeling confusion was now cleared up.

1. The was/is carrying contraband in the form of cocaine. Early into the session, I had a strong feeling that this has already been unloaded.
2. The cocaine is on the right side of the ship between the middle and the stern, in at least three trunk sized boxes, which are below deck and in a row, lengthwise from the bow to the stern. The boxes have some objects on top of them (coils of rope, small plastic boxes, etc), but these are not blocking the view of the boxes nor hindering access to them.
3. The cocaine is stored in tubes/rolls in the base of wooden trunk shaped boxes. The boxes are made out of wood "like" three quarter inch ply wood and are the size of a deep style footlocker. The boxes are painted gray, deep steely gray and have a hasp on them. There are no locks on the hasps though, and this is on purpose. Inside the boxes are trays/racks of black metallic tools. There are two trays/racks/inserts per box. The drug tubes are beneath in an order fashion (see sketch page 7). The boxes are extremely heavy because of the tools and tubes: it took two men per box to load them on the ship.
4. The contraband is/was unloaded in New Orleans. There was a strong feeling that the ship was heading for a different destination (Galveston area) but changed course at the last minute. As to unloading times, I got two different times: on Monday (23 Jan 89) and on Thursday (26 Jan 89).
5. The current ship location is shown on the map. (a circle in the Gulf of Mexico). The path to the unloading point is also shown.
