

(S/NF/SG/LIMDIS) The Special Activity Report is part of on-going taskings in response to a request from Joint Task Force Five (JTF-5) in Alameda, California. The data provided in this report will be used by the J22 division in their assessment effort regarding their counterdrug mission. The information provided in this report was generated by PAG-TA employing remote viewing (RV) methodologies.

SG1B (S/NF/SG/LIMDIS) The data provided in this report concentrated on [REDACTED]. The results were forwarded to JTF-5 by secure fax on 3 August 1994. The JTF-5 evaluation feedback is at Appendix B.

(S/NF/SG/LIMDIS) The methodology used in this activity is exploratory. DATA SUMMARIES

SG1B (S/NF/SG/LIMDIS) Following are the perceived highlights from each source. This is a follow-on tasking to Project 94-252-0 dated 18 July 95 referencing [REDACTED]

- (S/NF/SG/LIMDIS) Source A:

SG1B -- The target [REDACTED] is a dark complected individual who is known for smuggling narcotics. He is a preacher or speaker of sorts and works with a fat caucasian man. He has received a lot of money for large shipments in the past and may be targeting the U.S. arena for drug deliveries by November of this year. Federal authorities can intercept these shipments because he has a known route for making deliveries. "An image of lockers with the number 28 came to mind".

- (S/NF/SG/LIMDIS) Source B:

-- No input.

- (S/NF/SG/LIMDIS) Source C:

-- Target personality has a lot of hidden money. Target personality reports to a higher male individual who has a lot of power. Target will be very active within the next few months. He will be involved with two or three women who will help him in his illegal activities.
