1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. AUTHORIZATION AND APPROPRIATION EXTEN-**
4 **SIONS.**

5 The Omnibus Parks and Public Lands Management
6 Act of 1996 (Public Law 104–333) is amended—

1 (1) in the items in the table of contents relating
2 to title VIII of Division II, by striking “Canal Na-
3 tional Heritage Corridor” each place it appears and
4 inserting “National Heritage Canalway”; and

5 (2) in Division II—

6 (A) in each of sections 107, 208, 310, 408,
7 507, 607, 707, 811, 910, by striking “Sep-
8 tember 30, 2012” and inserting “September 30,
9 2027”;

10 (B) in each of sections 108(a), 209(a),
11 311(a), 409(a), 508(a), 608(a), 708(a), 812(a),
12 by striking “a total of \$10,000,000” and insert-
13 ing “a total of \$20,000,000”;

14 (C) in section 909(c), by striking “not
15 more than \$10,000,000” and inserting “not
16 more than \$20,000,000”; and

17 (D) in title VIII, by striking “Canal Na-
18 tional Heritage Corridor” each place it appears
19 and inserting “National Heritage Canalway”.
