CONCURRENT RESOLUTION

Providing for a correction to the enrollment of the bill, S.
203.

1 *Resolved by the House of Representatives (the Senate*
2 *concurring)*, That in the enrollment of the bill, S. 203,
3 the Secretary of the Senate shall make the following cor-
4 rection: After section 702 insert the following new section
5 (and amend the table of contents accordingly):

6 **SEC. 703. NEW JERSEY COASTAL HERITAGE TRAIL ROUTE.**

7 (a) AUTHORIZATION OF APPROPRIATIONS.—Public
8 Law 100–515 (16 U.S.C. 1244 note) is amended by strik-
9 ing section 6 and inserting the following:

1 **“SEC. 6. AUTHORIZATION OF APPROPRIATIONS.**

2 “(a) IN GENERAL.—There are authorized to be ap-
3 propriated to the Secretary such sums as are necessary
4 to carry out this Act.

5 “(b) USE OF FUNDS.—

6 “(1) IN GENERAL.—Amounts made available
7 under subsection (a) shall be used only for—

8 “(A) technical assistance; and

9 “(B) the design and fabrication of inter-
10 pretative materials, devices, and signs.

11 “(2) LIMITATIONS.—No funds made available
12 under subsection (a) shall be used for—

13 “(A) operation, repair, or construction
14 costs, except for the costs of constructing inter-
15 pretative exhibits; or

16 “(B) operation, maintenance, or repair
17 costs for any road or related structure.

18 “(3) COST-SHARING REQUIREMENT.—

19 “(A) FEDERAL SHARE.—The Federal
20 share of any project carried out with amounts
21 made available under subsection (a)—

22 “(i) may not exceed 50 percent of the
23 total project costs; and

24 “(ii) shall be provided on a matching
25 basis.

1 “(B) FORM OF NON-FEDERAL SHARE.—

2 The non-Federal share of carrying out a project
3 with amounts made available under subsection
4 (a) may be in the form of cash, materials, or
5 in-kind services, the value of which shall be de-
6 termined by the Secretary.

7 “(c) TERMINATION OF AUTHORITY.—The authorities
8 provided to the Secretary under this Act shall terminate
9 on September 30, 2007.”.

10 (b) STRATEGIC PLAN.—

11 (1) IN GENERAL.—Not later than 3 years after
12 the date on which funds are made available, the Sec-
13 retary of the Interior shall prepare a strategic plan
14 for the New Jersey Coastal Heritage Trail Route.

15 (2) CONTENTS.—The strategic plan shall de-
16 scribe—

17 (A) opportunities to increase participation
18 by national and local private and public inter-
19 ests in the planning, development, and adminis-
20 tration of the New Jersey Coastal Heritage
21 Trail Route; and

22 (B) organizational options for sustaining
23 the New Jersey Coastal Heritage Trail Route.
