## CONCURRENT RESOLUTION

1        *Resolved by the House of Representatives (the Senate*  
2 *concurring)*, That when the House adjourns on the legisla-  
3 tive day of Friday, September 29, 2006, Saturday, Sep-  
4 tember 30, 2006, or Sunday, October 1, 2006, on a motion  
5 offered pursuant to this concurrent resolution by its Ma-

1 jority Leader or his designee, it stand adjourned until 2  
2 p.m. on Thursday, November 9, 2006, or until the time  
3 of any reassembly pursuant to section 2 of this concurrent  
4 resolution, whichever occurs first; that when the House  
5 adjourns on the legislative day of Thursday, November 9,  
6 2006, on a motion offered pursuant to this concurrent res-  
7 olution by its Majority Leader or his designee, it stand  
8 adjourned until 2 p.m. on Monday, November 13, 2006,  
9 or until the time of any reassembly pursuant to section  
10 2 of this concurrent resolution, whichever occurs first; that  
11 when the Senate recesses or adjourns on any day from  
12 Friday, September 29, 2006, through Wednesday, October  
13 4, 2006, on a motion offered pursuant to this concurrent  
14 resolution by its Majority Leader or his designee, it stand  
15 recessed or adjourned until noon on Thursday, November  
16 9, 2006, or such other time on that day as may be speci-  
17 fied by its Majority Leader or his designee in the motion  
18 to recess or adjourn, or until the time of any reassembly  
19 pursuant to section 2 of this concurrent resolution, which-  
20 ever occurs first; and that when the Senate recesses or  
21 adjourns on Thursday, November 9, 2006, on a motion  
22 offered by its Majority Leader or his designee, it stand  
23 recessed or adjourned until noon on Monday, November  
24 13, 2006, or Tuesday, November 14, 2006, as may be  
25 specified by its Majority Leader or his designee in the mo-

1 tion to recess or adjourn, or such other time on that day  
2 as may be specified by its Majority Leader or his designee  
3 in the motion to recess or adjourn, or until the time of  
4 any reassembly pursuant to section 2 of this concurrent  
5 resolution, whichever occurs first.

6       SEC. 2. The Speaker of the House and the Majority  
7 Leader of the Senate, or their respective designees, acting  
8 jointly after consultation with the Minority Leader of the  
9 House and the Minority Leader of the Senate, shall notify  
10 the Members of the House and the Senate, respectively,  
11 to reassemble at such place and time as they may des-  
12 ignate if, in their opinion, the public interest shall warrant  
13 it.
