JOINT RESOLUTION

Making further continuing appropriations for the fiscal year
2007, and for other purposes.

1 *Resolved by the Senate and House of Representatives*
2 *of the United States of America in Congress assembled,*
3 That the Continuing Appropriations Resolution, 2007
4 (Public Law 109–289, division B) is further amended by

1 striking the date specified in section 106(3) and inserting
2 “February 15, 2007”.

3 SEC. 2. Section 102(c) of the Continuing Appropria-
4 tions Resolution, 2007 (Public Law 109–289, division B)
5 is amended by adding at the end the following new para-
6 graph:

7 “(5) Activities under the ‘Chemical Demili-
8 tarization Construction, Defense-Wide’ account.”.

9 SEC. 3. Section 114(b) of the Continuing Appropria-
10 tions Resolution, 2007 (Public Law 109–289, division B)
11 is amended by striking “and December 1, 2006,” and in-
12 serting “December 1, 2006, January 1, 2007, February
13 1, 2007, and March 1, 2007,”.

14 SEC. 4. Section 125 of the Continuing Appropriations
15 Resolution, 2007 (Public Law 109–289, division B) is
16 amended by striking “Partner Purchases” and inserting
17 “Partnership Purchases and International Space Station/
18 Multi-User System Support”.

19 SEC. 5. Section 126 of the Continuing Appropriations
20 Resolution, 2007 (Public Law 109–289, division B) is
21 amended by inserting “(1)” after “except that”, and by
22 inserting before the period at the end the following: “, and
23 (2) amounts made available under section 101 for depart-
24 ments and agencies that have been apportioned pursuant

1 to this section prior to November 17, 2006, may be at
2 a rate for operations not exceeding the current rate”.

3 SEC. 6. Section 101 of the Continuing Appropriations
4 Resolution, 2007 (Public Law 109–289, division B) is
5 amended by striking “as of October 1, 2006” each place
6 it appears in subsections (b) through (e) and inserting “as
7 of November 15, 2006”.

8 SEC. 7. The Continuing Appropriations Resolution,
9 2007 (Public Law 109–289, division B) is amended by
10 adding after section 132 the following new sections:

11 “SEC. 133. (a) Section 44302(f)(1) of title 49,
12 United States Code, shall be applied by substituting the
13 date specified in section 106(3) of this division for ‘August
14 31, 2006, and may extend through December 31, 2006’.

15 “(b) Section 44303(b) of title 49, United States
16 Code, shall be applied by substituting the date specified
17 in section 106(3) of this division for ‘December 31, 2006’.

18 “SEC. 134. The authority provided by H. Res. 135
19 (109th Congress), as adopted on March 14, 2005, shall
20 continue in effect through the date specified in section
21 106(3) of this division.

22 “SEC. 135. The rule referenced in section 126 of
23 Public Law 109–54 shall continue in effect for the 2006–
24 2007 winter use season through the date specified in sec-
25 tion 106(3) of this division.

1 “SEC. 136. In addition to any other transfer author-
2 ity of the Department of Veterans Affairs, up to
3 \$683,970,000 of the funds made available to the Depart-
4 ment by this division may be transferred to ‘Veterans
5 Health Administration–Medical Services’ during the pe-
6 riod covered by this division.

7 “SEC. 137. Notwithstanding any other provision of
8 this division and notwithstanding section 601(a)(2) of the
9 Legislative Reorganization Act of 1946 (2 U.S.C. 31), the
10 percentage adjustment scheduled to take effect under such
11 section for 2007 shall not take effect until February 16,
12 2007.”.
