AN ACT

To amend the Reclamation Wastewater and Groundwater Study and Facilities Act to authorize the Secretary of the Interior to participate in the Eastern Municipal Water District Recycled Water System Pressurization and Expansion Project.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Eastern Municipal
3 Water District Recycled Water System Pressurization and
4 Expansion Project”

5 **SEC. 2. PROJECT AUTHORIZATION.**

6 (a) IN GENERAL.—The Reclamation Wastewater and
7 Groundwater Study and Facilities Act (Public Law 102–
8 575, title XVI; 43 U.S.C. 390h et seq.) is amended by
9 adding after section 16 ____ the following:

10 **“SEC. 16 ____ . EASTERN MUNICIPAL WATER DISTRICT RECY-**
11 **CLED WATER SYSTEM PRESSURIZATION AND**
12 **EXPANSION PROJECT, CALIFORNIA.**

13 “(a) AUTHORIZATION.—The Secretary, in coopera-
14 tion with the Eastern Municipal Water District, Cali-
15 fornia, may participate in the design, planning, and con-
16 struction of permanent facilities needed to establish oper-
17 ational pressure zones that will be used to provide recycled
18 water in the district.

19 “(b) COST SHARING.—The Federal share of the cost
20 of the project described in subsection (a) shall not exceed
21 25 percent of the total cost of the project.

22 “(c) LIMITATION.—Funds provided by the Secretary
23 shall not be used for operation or maintenance of the
24 project described in subsection (a).

1 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
2 is authorized to be appropriated to carry out this section
3 \$12,000,000.

4 “(e) SUNSET OF AUTHORITY.—The authority of the
5 Secretary to carry out any provisions of this section shall
6 terminate 10 years after the date of enactment of this sec-
7 tion.”.

8 (b) CLERICAL AMENDMENT.—The table of sections
9 in section 2 of Public Law 102–575 is amended by insert-
10 ing after the item relating to section 16____ the following:

“Sec. 16____. Eastern Municipal Water District Recycled Water System Pres-
surization and Expansion Project, California.”.
