AN ACT

To authorize the Secretary of the Interior to study the suitability and feasibility of designating portions of Ste. Genevieve County in the State of Missouri as a unit of the National Park System, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Ste. Genevieve County
5 National Historic Site Study Act of 2005”.

1 **SEC. 2. DEFINITIONS.**

2 In this Act:

3 (1) AREA.—The term “Area” means Ste. Gene-
4 vieve County, Missouri, which includes the Bequette-
5 Ribault, St. Gemme-Amoureux, and Wilhauk
6 homes, and the related and supporting historical as-
7 sets located in Ste. Genevieve County, Missouri.

8 (2) SECRETARY.—The term “Secretary” means
9 the Secretary of the Interior, acting through the Di-
10 rector of the National Park Service.

11 **SEC. 3. STUDY.**

12 (a) In General.—Not later than 3 years after the date
13 on which funds are made available to carry out this Act,
14 the Secretary shall, in consultation with the State of Mis-
15 souri—

16 (1) complete a study on the suitability and fea-
17 sibility of designating the Area as a unit of the Na-
18 tional Park System, which shall include the potential
19 impact that designation of the area as a unit of the
20 National Park System is likely to have on land with-
21 in the proposed area or bordering the proposed area
22 that is privately owned at the time that the study is
23 conducted; and

24 (2) submit to the Committee on Resources of
25 the House of Representatives and the Committee on

1 Energy and Natural Resources of the Senate a re-
2 port describing the findings of the study.

3 (b) Contents.—The study under subsection (a) shall
4 be conducted in accordance with Public Law 91–383 (16
5 U.S.C. 1a–1 et seq.).
