A BILL

To establish the Commission to Study the Potential Creation
of a National Museum of the American Latino Commu-
nity to develop a plan of action for the establishment
and maintenance of a National Museum of the American
Latino Community in Washington, DC, and for other
purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Commission to Study
3 the Potential Creation of a National Museum of the Amer-
4 ican Latino Community Act of 2005”.

5 **SEC. 2. ESTABLISHMENT OF COMMISSION.**

6 (a) **IN GENERAL.**—There is established the Commis-
7 sion to Study the Potential Creation of a National Mu-
8 seum of the American Latino Community (hereafter in
9 this Act referred to as the “Commission”).

10 (b) **MEMBERSHIP.**—The Commission shall consist of
11 23 members appointed not later than 6 months after the
12 date of the enactment of this Act as follows:

13 (1) The President shall appoint 7 voting mem-
14 bers.

15 (2) The Speaker of the House of Representa-
16 tives, the minority leader of the House of Represent-
17 atives, the majority leader of the Senate, and the mi-
18 nority leader of the Senate shall each appoint 3 vot-
19 ing members.

20 (3) In addition to the members appointed under
21 paragraph (2), the Speaker of the House of Rep-
22 resentatives, the minority leader of the House of
23 Representatives, the majority leader of the Senate,
24 and the minority leader of the Senate shall each ap-
25 point 1 nonvoting member.

1 ~~(e)~~ QUALIFICATIONS.—Members of the Commission
2 shall be chosen from among individuals, or representatives
3 of institutions or entities, who possess either—

4 ~~(1)~~ a demonstrated commitment to the re-
5 search, study, or promotion of American Latino life,
6 art, history, political or economic status, or culture,
7 together with—

8 ~~(A)~~ expertise in museum administration;

9 ~~(B)~~ expertise in fundraising for nonprofit
10 or cultural institutions;

11 ~~(C)~~ experience in the study and teaching of
12 Latino culture and history at the post-sec-
13 ondary level;

14 ~~(D)~~ experience in studying the issue of the
15 Smithsonian Institution's representation of
16 American Latino art, life, history, and culture;
17 or

18 ~~(E)~~ extensive experience in public or elect-
19 ed service; or

20 ~~(2)~~ experience in the administration of, or the
21 planning for the establishment of, museums devoted
22 to the study and promotion of the role of ethnic, ra-
23 cial, or cultural groups in American history.

1 **SEC. 3. FUNCTIONS OF THE COMMISSION.**

2 (a) **PLAN OF ACTION FOR ESTABLISHMENT AND**
3 **MAINTENANCE OF MUSEUM.**—The Commission shall sub-
4 mit a report to the President and the Congress containing
5 its recommendations with respect to a plan of action for
6 the establishment and maintenance of a National Museum
7 of the American Latino Community in Washington, DC
8 (hereafter in this Act referred to as the “Museum”).

9 (b) **FUNDRAISING PLAN.**—The Commission shall de-
10 velop a fundraising plan for supporting the creation and
11 maintenance of the Museum through contributions by the
12 American people, and a separate plan on fundraising by
13 the American Latino community.

14 (c) **REPORT ON ISSUES.**—The Commission shall ex-
15 amine (in consultation with the Secretary of the Smithso-
16 nian Institution), and submit a report to the President
17 and the Congress on, the following issues:

18 (1) The availability and cost of collections to be
19 acquired and housed in the Museum.

20 (2) The impact of the Museum on regional
21 Hispanic- and Latino-related museums.

22 (3) Possible locations for the Museum in Wash-
23 ington, DC and its environs, to be considered in con-
24 sultation with the National Capital Planning Com-
25 mission and the Commission of Fine Arts.

1 (4) Whether the Museum should be located
2 within the Smithsonian Institution.

3 (5) The governance and organizational struc-
4 ture from which the Museum should operate.

5 (6) How to engage the American Latino com-
6 munity in the development and design of the Mu-
7 seum.

8 (d) LEGISLATION TO CARRY OUT PLAN OF AC-
9 TION.—Based on the recommendations contained in the
10 report submitted under subsection (a) and the report sub-
11 mitted under subsection (c), the Commission shall submit
12 for consideration to the Committee on Transportation and
13 Infrastructure of the House of Representatives, the Com-
14 mittee on House Administration of the House of Rep-
15 resentatives, the Committee on Resources of the House
16 of Representatives, the Committee on Energy and Natural
17 Resources of the Senate, and the Committees on Appro-
18 priations of the House of Representatives and the Senate
19 recommendations for a a legislative plan of action to cre-
20 ate and construct the Museum.

21 (e) NATIONAL CONFERENCE.—In carrying out its
22 functions under this section, the Commission shall convene
23 a national conference on the Museum, comprised of indi-
24 viduals committed to the advancement of American Latino

1 life, art, history, and culture, not later than 9 months
2 after the date of the enactment of this Act.

3 **SEC. 4. ADMINISTRATIVE PROVISIONS.**

4 (a) **FACILITIES AND SUPPORT OF SECRETARY OF IN-**
5 **TERIOR.**—The Secretary of the Interior shall provide the
6 administrative services, facilities, and funds necessary for
7 the performance of the Commission's functions.

8 (b) **COMPENSATION.**—Each member of the Commis-
9 sion who is not an officer or employee of the Federal Gov-
10 ernment may receive compensation for each day on which
11 the member is engaged in the work of the Commission,
12 at a daily rate to be determined by the Secretary of the
13 Interior.

14 (c) **TRAVEL EXPENSES.**—Each member shall receive
15 travel expenses, including per diem in lieu of subsistence,
16 in accordance with applicable provisions under subchapter
17 I of chapter 57 of title 5, United States Code.

18 **SEC. 5. DEADLINE FOR SUBMISSION OF REPORTS; TERMI-**
19 **NATION.**

20 (a) **DEADLINE.**—The Commission shall submit final
21 versions of the reports and plans required under section
22 4 not later than 18 months after the date of the enactment
23 of this Act.

1 (b) ~~TERMINATION.~~—The Commission shall terminate
2 not later than 30 days after submitting the final versions
3 of reports and plans pursuant to subsection (a).

4 **SEC. 6. AUTHORIZATION OF APPROPRIATIONS.**

5 There are authorized to be appropriated for carrying
6 out the activities of the Commission ~~\$2,100,000~~ for fiscal
7 year 2006 and ~~\$1,100,000~~ for fiscal year 2007.

22 (2) *The Speaker of the House of Representatives,*
23 *the minority leader of the House of Representatives,*
24 *the majority leader of the Senate, and the minority*

1 *leader of the Senate shall each appoint 3 voting mem-*
2 *bers.*

3 *(3) In addition to the members appointed under*
4 *paragraph (2), the Speaker of the House of Represent-*
5 *atives, the minority leader of the House of Represent-*
6 *atives, the majority leader of the Senate, and the mi-*
7 *nority leader of the Senate shall each appoint 1 non-*
8 *voting member.*

9 *(c) QUALIFICATIONS.—Members of the Commission*
10 *shall be chosen from among individuals, or representatives*
11 *of institutions or entities, who possess either—*

12 *(1) a demonstrated commitment to the research,*
13 *study, or promotion of American Latino life, art, his-*
14 *tory, political or economic status, or culture, together*
15 *with—*

16 *(A) expertise in museum administration;*

17 *(B) expertise in fundraising for nonprofit*
18 *or cultural institutions;*

19 *(C) experience in the study and teaching of*
20 *Latino culture and history at the post-secondary*
21 *level;*

22 *(D) experience in studying the issue of the*
23 *Smithsonian Institution’s representation of*
24 *American Latino art, life, history, and culture;*
25 *or*

1 (E) *extensive experience in public or elected*
2 *service; or*

3 (2) *experience in the administration of, or the*
4 *planning for the establishment of, museums devoted to*
5 *the study and promotion of the role of ethnic, racial,*
6 *or cultural groups in American history.*

7 **SEC. 3. FUNCTIONS OF THE COMMISSION.**

8 (a) *PLAN OF ACTION FOR ESTABLISHMENT AND MAIN-*
9 *TENANCE OF MUSEUM.*—*The Commission shall submit a re-*
10 *port to the President and the Congress containing its rec-*
11 *ommendations with respect to a plan of action for the estab-*
12 *lishment and maintenance of a National Museum of the*
13 *American Latino Community in Washington, DC (here-*
14 *after in this Act referred to as the “Museum”).*

15 (b) *FUNDRAISING PLAN.*—*The Commission shall de-*
16 *velop a fundraising plan for supporting the creation and*
17 *maintenance of the Museum through contributions by the*
18 *American people, and a separate plan on fundraising by*
19 *the American Latino community.*

20 (c) *REPORT ON ISSUES.*—*The Commission shall exam-*

16 *subsection (c), the Commission shall submit for consider-*
17 *ation to the Committee on Transportation and Infrastruc-*
18 *ture of the House of Representatives, the Committee on*
19 *House Administration of the House of Representatives, the*
20 *Committee on Rules and Administration of the Senate, the*
21 *Committee on Resources of the House of Representatives,*
22 *the Committee on Energy and Natural Resources of the Sen-*
23 *ate, and the Committees on Appropriations of the House*
24 *of Representatives and the Senate recommendations for a*

1 *legislative plan of action to create and construct the Mu-*
2 *seum.*

3 (e) *NATIONAL CONFERENCE.*—*In carrying out its*
4 *functions under this section, the Commission shall convene*
5 *a national conference on the Museum, comprised of individ-*
6 *uals committed to the advancement of American Latino life,*
7 *art, history, and culture, not later than 9 months after the*
8 *date of the enactment of this Act.*

9 **SEC. 4. ADMINISTRATIVE PROVISIONS.**

10 (a) *FACILITIES AND SUPPORT OF SECRETARY OF IN-*
11 *TERIOR.*—*The Secretary of the Interior shall provide the*
12 *administrative services, facilities, and funds necessary for*
13 *the performance of the Commission’s functions.*

14 (b) *COMPENSATION.*—*Each member of the Commission*
15 *who is not an officer or employee of the Federal Government*
16 *may receive compensation for each day on which the mem-*
17 *ber is engaged in the work of the Commission, at a daily*
18 *rate to be determined by the Secretary of the Interior.*

19 (c) *TRAVEL EXPENSES.*—*Each member shall receive*
20 *travel expenses, including per diem in lieu of subsistence,*
21 *in accordance with applicable provisions under subchapter*
22 *I of chapter 57 of title 5, United States Code.*

1 **SEC. 5. DEADLINE FOR SUBMISSION OF REPORTS; TERMI-**
2 **NATION.**

3 (a) *DEADLINE.*—*The Commission shall submit final*
4 *versions of the reports and plans required under section 4*
5 *not later than 18 months after the date of the enactment*
6 *of this Act.*

7 (b) *TERMINATION.*—*The Commission shall terminate*
8 *not later than 30 days after submitting the final versions*
9 *of reports and plans pursuant to subsection (a).*

10 **SEC. 6. AUTHORIZATION OF APPROPRIATIONS.**

11 *There are authorized to be appropriated for carrying*
12 *out the activities of the Commission \$2,100,000 for fiscal*
13 *year 2007 and \$1,100,000 for fiscal year 2008.*
