1 **SECTION 1. MIXTURES OF *N,N*-DIMETHYL-2[3-(4,6-**
 2 **DIMETHOXYPYRIMIDIN-2-**
 3 **YL)UREIDOSULFONYL]-4-**
 4 **FORMYLAMINO BENZAMIDE**
 5 **(FORAMSULFURON), METHYL 4-iodo-2-[3-(4-**
 6 **METHOXY-6-METHYL-1,3,5-TRIAZIN-2-**
 7 **YL)UREIDOSULFONYL]BENZOATE, SODIUM**
 8 **SALT (IODOSULFURON), AND APPLICATION**
 9 **ADJUVANTS.**

10 (a) IN GENERAL.—Subchapter II of chapter 99 of
 11 the Harmonized Tariff Schedule of the United States is
 12 amended by inserting in numerical sequence the following
 13 new heading:
