## AN ACT

Making emergency supplemental appropriations to meet immediate needs arising from the consequences of Hurricane Katrina, for the fiscal year ending September 30, 2005, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

1 That the following sums are appropriated, out of any  
2 money in the Treasury not otherwise appropriated, for the  
3 fiscal year ending September 30, 2005, namely:

4 DEPARTMENT OF HOMELAND SECURITY  
5 EMERGENCY PREPAREDNESS AND RESPONSE  
6 DISASTER RELIEF

7 For an additional amount for “Disaster Relief”,  
8 \$10,000,000,000, to remain available until expended: *Pro-*  
9 *vided*, That the amount provided herein is designated as  
10 an emergency requirement pursuant to section 402 of H.  
11 Con. Res. 95 (109th Congress).

12 DEPARTMENT OF DEFENSE  
13 OPERATION AND MAINTENANCE  
14 OPERATION AND MAINTENANCE, DEFENSE-WIDE  
15 (INCLUDING TRANSFER OF FUNDS)

16 For an additional amount for “Operation and Main-  
17 tenance, Defense-Wide”, \$500,000,000 for emergency  
18 hurricane expenses, to support costs of evacuation, emer-  
19 gency repairs, deployment of personnel, and other costs  
20 resulting from immediate relief efforts, to remain available  
21 until September 30, 2006: *Provided*, That the Secretary  
22 of Defense may transfer these funds to appropriations for  
23 military personnel, operation and maintenance, procure-  
24 ment, family housing, Defense Health Program, and work-  
25 ing capital funds: *Provided further*, That funds transferred

1 shall be merged with and be available for the same pur-  
2 poses and for the same time period as the appropriation  
3 or fund to which transferred: *Provided further*, That this  
4 transfer authority is in addition to any other transfer au-  
5 thority available to the Department of Defense: *Provided*  
6 *further*, That upon a determination that all or part of the  
7 funds transferred from this appropriation are not nec-  
8 essary for the purposes provided herein, such amounts  
9 may be transferred back to this appropriation: *Provided*  
10 *further*, That the Secretary of Defense shall, not more  
11 than 5 days after making transfers from this appropria-  
12 tion, notify the congressional defense committees in writ-  
13 ing of any such transfer: *Provided further*, That the  
14 amount provided herein is designated as an emergency re-  
15 quirement pursuant to section 402 of H. Con. Res. 95  
16 (109th Congress).

17 This Act may be cited as the “Emergency Supple-  
18 mental Appropriations Act to Meet Immediate Needs Aris-  
19 ing From the Consequences of Hurricane Katrina, 2005”.
