## A BILL

To redesignate Dayton Aviation Heritage National Historic Park in the State of Ohio as “Wright Brothers-Dunbar National Historic Park”, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Wright Brothers-Dunbar*  
5 *National Historical Park Designation Act”.*

6 **SEC. 2. REDESIGNATION OF DAYTON AVIATION HERITAGE**

7                    **NATIONAL HISTORICAL PARK.**

8        *(a) REDESIGNATION.—The Act titled “An Act to estab-*  
9 *lish the Dayton Aviation Heritage National Historical*  
10 *Park in the State of Ohio, and for other purposes”, ap-*  
11 *proved October 16, 1992 (106 Stat. 2141), is amended—*

12                    *(1) by striking “Dayton Aviation Heritage Na-*  
13 *tional Historical Park” each place it appears and in-*  
14 *serting “Wright Brothers-Dunbar National Historical*  
15 *Park”;*

16                    *(2) by redesignating subsection (b) of section 108*  
17 *as subsection (c); and*

18                    *(3) by inserting after subsection (a) of section*  
19 *108 the following new subsection:*

20        *“(b) GRANT ASSISTANCE.—The Secretary is author-*  
21 *ized to make grants to the parks’ partners, including the*  
22 *Aviation Trail, Inc., the Ohio Historical Society, and Day-*  
23 *ton History, for projects not requiring Federal involvement*  
24 *other than providing financial assistance, subject to the*  
25 *availability of appropriations in advance identifying the*

1 *specific partner grantee and the specific project. Projects*  
2 *funded through these grants shall be limited to construction*  
3 *and development on non-Federal property within the*  
4 *boundaries of the park. Any project funded by such a grant*  
5 *shall support the purposes of the park, shall be consistent*  
6 *with the park's general management plan, and shall en-*  
7 *hance public use and enjoyment of the park.”.*

8 (b) *REFERENCES.—Any reference in any law (other*  
9 *than this Act), map, regulation, document, record, or other*  
10 *official paper of the United States to the “Dayton Aviation*  
11 *Heritage National Historical Park” shall be considered to*  
12 *be a reference to the “Wright Brothers-Dunbar National*  
13 *Historical Park”.*

14 **SEC. 3. NATIONAL AVIATION HERITAGE AREA.**

15 *Title V of division J of the Consolidated Appropria-*  
16 *tions Act, 2005 (16 U.S.C. 1132 note; Public Law 108–447),*  
17 *is amended—*

18 (1) *in section 503(3), by striking “104” and in-*  
19 *serting “504”;*

20 (2) *in section 503(4), by striking “106” and in-*  
21 *serting “506”;*

22 (3) *in section 504, by striking subsection (b)(2)*  
23 *and by redesignating subsection (b)(3) as subsection*  
24 *(b)(2); and*

- 1           (4) *in section 505(b)(1), by striking “106” and*  
2           *inserting “506”.*

Amend the title so as to read: “A bill to redesignate Dayton Aviation Heritage National Historical Park in the State of Ohio as the Wright Brothers-Dunbar National Historical Park, and for other purposes.”.
