1 **SECTION 1. REPLACEMENT OF COASTAL BARRIER RE-**
2 **SOURCES SYSTEM MAP RELATING TO**
3 **GRAYTON BEACH UNIT FL-95P IN WALTON**
4 **COUNTY, FLORIDA.**

5 (a) *IN GENERAL.*—The map described in subsection
6 (b) relating to the Coastal Barrier Resources System unit
7 Grayton Beach Unit FL-95P, located in Walton County,
8 Florida, as included in the set of maps entitled “Coastal
9 Barrier Resources System” referred to in section 4(a) of the
10 Coastal Barrier Resources Act (16 U.S.C. 3503(a)), is here-
11 by replaced by another map relating to that unit entitled
12 “Grayton Beach Unit FL-95P and Draper Lake Unit FL-
13 96” and dated “July 24, 2006”.

14 (b) *REPLACED MAP DESCRIBED.*—The map replaced
15 under subsection (a) is subtitled “COASTAL BARRIER
16 RESOURCES SYSTEM GRAYTON BEACH UNIT FL-
17 95P DRAPER LAKE UNIT FL-96” and dated October 24,
18 1990.

19 (c) *AVAILABILITY.*—The Secretary of the Interior shall
20 keep the maps referred to in subsections (a) on file and
21 available for inspection in accordance with the provisions
22 of section 4(b) of the Coastal Barrier Resources Act (16
23 U.S.C. 3503(b)).
