7 (3) CLOTHING ALLOWANCE.—The dollar
8 amount in effect under section 1162 of such title.

9 (4) NEW DIC RATES.—The dollar amounts in
10 effect under paragraphs (1) and (2) of section
11 1311(a) of such title.

12 (5) OLD DIC RATES.—Each of the dollar
13 amounts in effect under section 1311(a)(3) of such
14 title.

4 (c) DETERMINATION OF INCREASE.—

5 (1) BASE FOR INCREASE.—The increase under
6 subsection (a) shall be made in the dollar amounts
7 specified in subsection (b) as in effect on November
8 30, 2006.

9 (2) PERCENTAGE OF INCREASE.—Except as
10 provided in paragraph (3), each such amount shall
11 be increased by the same percentage as the percent-
12 age by which benefit amounts payable under title II
13 of the Social Security Act (42 U.S.C. 401 et seq.)
14 are increased effective December 1, 2006, as a result
15 of a determination under section 215(i) of such Act
16 (42 U.S.C. 415(i)).

17 (3) ROUNDING.—Each dollar amount increased
18 pursuant to paragraph (2) shall, if not a whole dol-
19 lar amount, be rounded down to the next lower
20 whole dollar amount.

21 (d) SPECIAL RULE.—The Secretary may adjust ad-
22 ministratively, consistent with the increases made under
23 subsection (a), the rates of disability compensation pay-
24 able to persons within the purview of section 10 of Public
25 Law 85–857 (72 Stat. 1263) who are not in receipt of

1 compensation payable pursuant to chapter 11 of title 38,
2 United States Code.

3 *(e) DESIGNATION CORRECTION.—Section 1311 of title*
4 *38, United States Code, is amended by redesignating the*
5 *second subsection (e) (added by section 301(a) of the Vet-*
6 *erans Benefits Improvement Act of 2004 (Public Law 108–*
7 *454; 118 Stat. 3610)) as subsection (f).*

8 **SEC. 3. PUBLICATION OF ADJUSTED RATES.**

9 At the same time as the matters specified in section
10 215(i)(2)(D) of the Social Security Act (42 U.S.C.
11 415(i)(2)(D)) are required to be published by reason of
12 a determination made under section 215(i) of such Act
13 during fiscal year 2006, the Secretary of Veterans Affairs
14 shall publish in the Federal Register the amounts specified
15 in subsection (b) of section 2, as increased pursuant to
16 that section.
