A BILL

To amend the Public Health Service Act to transfer the National Disaster Medical System to the Department of Health and Human Services, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Public Health and
5 Medical Emergency Coordination Act of 2006”.

1 **SEC. 2. TRANSFER OF NATIONAL DISASTER MEDICAL SYS-**
2 **TEM.**

3 (a) AMENDMENT TO PUBLIC HEALTH SERVICE
4 ACT.—Section 2811(b) of the Public Health Service Act
5 (42 U.S.C. 300hh–11(b)) is amended by adding at the end
6 the following:

7 “(4) TRANSFER.—Upon the transfer of the
8 functions, personnel, assets, and liabilities of the Na-
9 tional Disaster Medical System as required by sec-
10 tion 2(b) of the Public Health and Medical Emer-
11 gency Coordination Act of 2006, this section shall be
12 in effect as if sections 502(3)(B) and 503(5) of the
13 Homeland Security Act of 2002 had not been en-
14 acted.”.

15 (b) TRANSFER.—Not later than 9 months after the
16 date of the enactment of this Act, the functions, personnel,
17 assets, and liabilities of the National Disaster Medical
18 System shall be transferred to the Department of Health
19 and Human Services.

20 (c) DEFINITIONS.—For purposes of this section:

21 (1) The term “assets” includes contracts, facili-
22 ties, property, records, unobligated or unexpended
23 balances of appropriations, and other funds or re-
24 sources (other than personnel).

3 (b) PRIMARY AGENCY.—Section 2811 of the Public
4 Health Service Act (42 U.S.C. 300hh–11) is amended—

5 (1) by redesignating subsections (c) through (h)
6 as subsections (d) through (i), respectively;

7 (2) in paragraphs (1) and (2) of subsection (e),
8 by striking the term “subsection (d)” each place
9 such term appears and inserting “subsection (e)”;
10 and

11 (3) by inserting after subsection (b) the fol-
12 lowing:

13 “(c) PRIMARY AGENCY.—The Department of Health
14 and Human Services shall be the primary agency for the
15 coordination of Federal assistance to supplement State,
16 local, and tribal resources for preparing for, or responding
17 to, a bioterrorist attack or other public health or medical
18 emergency.”.
