A BILL

To amend the Balanced Budget and Emergency Deficit Control Act of 1985 to eliminate automatic increases for inflation from CBO baseline projections for discretionary appropriations, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Zero Baseline Budget
5 Act of 2006”.

1 **SEC. 2. CHANGES IN THE BASELINE.**

2 Section 257(c) of the Balanced Budget and Emer-
3 gency Deficit Control Act of 1985 is amended—

4 (1) in the second sentence of paragraph (1), by
5 striking everything that follows “current year,” and
6 inserting “excluding resources designated as an
7 emergency requirement and any resources provided
8 in supplemental appropriation laws.”;

9 (2) by striking paragraphs (2), (3), (4), and
10 (5);

11 (3) by redesignating paragraph (6) as para-
12 graph (2); and

13 (4) by inserting after paragraph (2) the fol-
14 lowing new paragraph:

15 “(3) NO ADJUSTMENT FOR INFLATION.—No
16 adjustment shall be made for inflation or for any
17 other factor.”.

18 **SEC. 3. EXTENSION.**

19 The second sentence of section 275(b) of the Bal-
20 anced Budget and Emergency Deficit Control Act of 1985
21 is amended by inserting “other than subsections (a)
22 through (d) of section 257” after “title”.
