A BILL

To authorize the Government of Ukraine to establish a memorial on Federal land in the District of Columbia to honor the victims of the manmade famine that occurred in Ukraine in 1932–1933.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FINDINGS.**

4 Congress finds the following:

5 (1) Internationally accepted principles of
6 human rights condemn the use of food as a political
7 weapon.

1 (2) In the years 1932–1933, Ukraine was rav-
2 aged and its people brought to the verge of physical
3 extinction by a famine caused not by natural causes
4 such as pestilence, drought, floods, or poor harvest,
5 but as a consequence of a premeditated policy on the
6 part of the Soviet Government led by Joseph Stalin
7 to crush the nationally conscious Ukrainian people
8 and destroy their national, political, cultural, and re-
9 ligious rights.

10 (3) Attempts at intercessions were made by the
11 United States Government during the height of the
12 famine, in the fall/winter of 1932–1933, indicating
13 that it has always been the traditional policy of the
14 United States to recognize events such as the fam-
15 ine-genocide in Ukraine.

16 (4) The United States Commission on the
17 Ukraine Famine found in its report filed in 1988
18 pursuant to Public Law 98–473 that the victims
19 were “starved to death in a man-made famine” and
20 that “Joseph Stalin and those around him com-
21 mitted genocide against Ukraine in 1932–1933”.

22 (5) Ukrainian communities worldwide plan to
23 commemorate the 75th anniversary of the Ukrainian
24 famine-genocide with appropriate observances to pay
25 tribute to the victims of this tragedy.

1 **SEC. 2. AUTHORITY TO ESTABLISH MEMORIAL.**

2 (a) IN GENERAL.—The Government of Ukraine is
3 authorized to establish a memorial on Federal land in the
4 District of Columbia to honor the victims of the Ukrainian
5 famine-genocide of 1932–1933.

6 (b) COMPLIANCE WITH STANDARDS FOR COMMEMO-
7 RATIVE WORKS.—The establishment of the memorial shall
8 be in accordance with the Commemorative Works Act (40
9 U.S.C. 1001 et seq.), except that sections 2(c), 6(b), 8(b),
10 and 10(c) of that Act shall not apply with respect to the
11 memorial.

12 **SEC. 3. LIMITATION ON PAYMENT OF EXPENSES.**

13 The United States Government shall not pay any ex-
14 pense for the establishment of the memorial or its mainte-
15 nance.
