A BILL

To amend part B of title IV of the Social Security Act to reauthorize the safe and stable families program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Child and Family Serv-*
5 *ices Improvement Act of 2006”.*

6 **SEC. 2. FINDINGS.**

7 *The Congress finds as follows:*

8 *(1) For Federal fiscal year 2004, child protective*
9 *services (CPS) staff nationwide reported investigating*
10 *or assessing an estimated 3,000,000 allegations of*
11 *child maltreatment, and determined that 872,000*
12 *children had been abused or neglected by their parents*
13 *or other caregivers.*

14 *(2) Combined, the Child Welfare Services (CWS)*
15 *and Promoting Safe and Stable Families (PSSF)*
16 *programs provide States about \$700,000,000 per year*
17 *for services intended to ensure the safety, permanency,*
18 *and well-being of children. These programs are con-*
19 *sidered the largest source of targeted Federal funding*
20 *in the child protection system for prevention—that is,*
21 *for services to ensure that children are not abused or*
22 *neglected and, whenever possible, help children re-*
23 *main safely with their families.*

24 *(3) States have broad flexibility in directing*
25 *CWS dollars to protect children from abuse and ne-*

1 *glect. Under the PSSF program, States must invest*
2 *significant portions of program funds in family pres-*
3 *ervation services, family support services, time-lim-*
4 *ited reunification services, and post-adoption support*
5 *services.*

6 *(4) However, a 2003 report by the Government*
7 *Accountability Office (GAO) reported that little re-*
8 *search is available on the effectiveness of activities*
9 *supported by CWS funds—evaluations of services sup-*
10 *ported by PSSF funds have generally shown little or*
11 *no effect.*

12 *(5) Further, the Department of Health and*
13 *Human Services recently completed initial Child and*
14 *Family Service Reviews (CFSRs) in each State. No*
15 *State was in full compliance with all measures of the*
16 *CFSRs. The CFSRs also revealed that States need to*
17 *work to prevent repeat abuse and neglect of children,*
18 *improve services provided to families to reduce the*
19 *risk of future harm (including by better monitoring*
20 *the participation of families in services), and*
21 *strengthen upfront services provided to families to*
22 *prevent unnecessary family break-up and protect chil-*
23 *dren who remain at home.*

24 *(6) Federal policy should ensure that States are*
25 *appropriately targeting CWS and PSSF funds to as-*

1 *sist at-risk families and protect abused and neglected*
2 *children to address issues found in the CFSTRs. En-*
3 *couraging States to invest their CWS and PSSF*
4 *funds in services that promote and protect the welfare*
5 *of children, support strong, healthy families, and re-*
6 *duce the reliance on out-of-home care, will help ensure*
7 *all children are raised in safe, loving families.*

8 *(7) CFSTRs also found a strong correlation be-*
9 *tween frequent caseworker visits with children and*
10 *positive outcomes for these children, such as timely*
11 *achievement of permanency and other indicators of*
12 *child well-being.*

13 *(8) However, a December 2005 report by the De-*
14 *partment of Health and Human Services Office of In-*
15 *pector General found that only 20 States were able*
16 *to produce reports to show whether caseworkers actu-*
17 *ally visited children in foster care on at least a*
18 *monthly basis, despite the fact that nearly all States*
19 *had written standards suggesting monthly visits were*
20 *State policy. In fact, 7 of these 20 States indicated*
21 *that fewer than half of the children in foster care were*
22 *visited on a monthly basis.*

23 *(9) The Deficit Reduction Act of 2005 provided*
24 *\$40,000,000 in fiscal year 2006 for the PSSF pro-*
25 *gram which this Act ensures will be available and*

1 *which the Congressional Budget Office estimates will*
2 *increase mandatory budget authority by \$40,000,000*
3 *each year from 2006 through 2015, for a total of*
4 *\$400,000,000.*

5 *(10) A 2003 GAO report found that the average*
6 *tenure for a child welfare caseworker is less than 2*
7 *years and this level of turnover negatively affects safe-*
8 *ty and permanency for children.*

9 *(11) Targeting additional PSSF funds to ensure*
10 *children in foster care are visited on at least a month-*
11 *ly basis will promote better outcomes for vulnerable*
12 *children, including by preventing further abuse and*
13 *neglect.*

14 **SEC. 3. REAUTHORIZATION OF THE SAFE AND STABLE FAM-**
15 **ILIES PROGRAM.**

16 *(a) ELIMINATION OF FINDINGS.—Section 430 of the*
17 *Social Security Act (42 U.S.C. 629) is amended by striking*
18 *all through “(b) PURPOSE.—The purpose” and inserting*
19 *the following:*

20 **“SEC. 430. PURPOSE.**

21 *“The purpose”.*

22 *(b) LIMITATION ON ADMINISTRATIVE COST REIM-*
23 *BURSEMENT.—Section 434 of such Act (42 U.S.C. 629d) is*
24 *amended—*

1 (1) *in subsection (a), by inserting “, subject to*
2 *subsection (d),” after “shall”; and*

3 (2) *by adding at the end the following:*

4 “(d) *LIMITATION ON REIMBURSEMENT FOR ADMINIS-*
5 *TRATIVE COSTS.—The Secretary shall not make a payment*
6 *to a State under this section with respect to expenditures*
7 *for administrative costs during a fiscal year, to the extent*
8 *that the total amount of the expenditures exceeds 10 percent*
9 *of the total expenditures of the State during the fiscal year*
10 *under the State plan approved under section 432.”.*

11 (c) *FUNDING OF MANDATORY GRANTS AT \$345 MIL-*
12 *LION PER FISCAL YEAR.—Section 436(a) of such Act (42*
13 *U.S.C. 629f(a)) is amended by striking “for fiscal year*
14 *2006.” and all that follows and inserting “for each of fiscal*
15 *years 2007 through 2011.”.*

16 (d) *FUNDING OF DISCRETIONARY GRANTS.—Section*
17 *437(a) of such Act (42 U.S.C. 629g(a)) is amended by strik-*
18 *ing “2002 through 2006” and inserting “2007 through*
19 *2011”.*

20 (e) *INCREASE IN SET-ASIDES FOR INDIAN TRIBES.—*

21 (1) *MANDATORY GRANTS.—Section 436(b)(3) of*
22 *such Act (42 U.S.C. 629f(b)(3)) is amended by strik-*
23 *ing “1” and inserting “3”.*

1 (2) *DISCRETIONARY GRANTS*.—Section 437(b)(3)
2 of such Act (42 U.S.C. 629g(b)(3)) is amended by
3 striking “2” and inserting “3”.

4 (f) *COLLECTION OF DATA ON TRIBAL PROMOTING*
5 *SAFE AND STABLE FAMILIES PLANS*.—Section 432(b)(2) of
6 such Act (42 U.S.C. 629b(b)(2)) is amended—

7 (1) by striking subparagraph (A); and

8 (2) in subparagraph (B), by striking “Notwith-
9 standing subparagraph (A) of this paragraph, the”
10 and inserting “The”.

11 (g) *AUTHORITY OF INTERTRIBAL CONSORTIA TO*
12 *APPLY FOR GRANTS*.—Section 432(b)(2) of such Act (42
13 U.S.C. 629(b)(b)(2)), as amended by subsection (f) of this
14 section, is amended—

15 (1) by inserting before subparagraph (B) the fol-
16 lowing:

17 “(A) *INTERTRIBAL CONSORTIA*.—This sub-
18 part shall not be interpreted to preclude the de-
19 velopment and submission of a single tribal plan
20 under this subpart by the participating tribes of
21 an intertribal consortium.”; and

22 (2) in subparagraph (B)—

23 (A) by inserting “or tribal consortium”
24 after “Indian tribe”; and

1 (B) by inserting “and tribal consortia”
2 after “Indian tribes”.

3 (h) *TECHNICAL CORRECTION.*—Section 431(a)(6) of
4 such Act (42 U.S.C. 629a(a)(6)) is amended by striking
5 “1986” and inserting “1996”.

6 **SEC. 4. TARGETING OF INCREASED SAFE AND STABLE FAMI-**
7 **LIES PROGRAM RESOURCES TO SUPPORT**
8 **MONTHLY CASEWORKER VISITS.**

9 (a) *RESERVATION AND USE OF FUNDS.*—

10 (1) *IN GENERAL.*—Section 436(b) of the Social
11 Security Act (42 U.S.C. 629f(b)) is amended by add-
12 ing at the end the following:

13 “(4) *SUPPORT FOR MONTHLY CASEWORKER VIS-*
14 *ITS.*—

15 “(A) *RESERVATION.*—In the case of each of
16 fiscal years 2006 through 2011, the Secretary
17 shall reserve \$40,000,000 for allotment in accord-
18 ance with section 433(e).

19 “(B) *USE OF FUNDS.*—

20 “(i) *IN GENERAL.*—A State to which
21 an amount is paid from amounts reserved
22 under subparagraph (A) shall use the
23 amount to support monthly caseworker vis-
24 its with children who are in foster care
25 under the responsibility of the State, with a

1 *primary emphasis on activities designed to*
2 *improve caseworker retention, recruitment,*
3 *training, and ability to access the benefits*
4 *of technology.*

5 “(ii) *NONSUPPLANTATION.*—*A State to*
6 *which an amount is paid from amounts re-*
7 *served pursuant to subparagraph (A) shall*
8 *not use the amount to supplant any Federal*
9 *funds paid to the State under part E that*
10 *could be used as described in clause (i).”.*

11 (2) *EFFECT ON AMOUNTS RESERVED FOR INDIAN*
12 *TRIBES.*—*Section 436(b)(3) of such Act (42 U.S.C.*
13 *629b(b)(3)) is amended by striking “The” and insert-*
14 *ing “After applying paragraph (4) (but before apply-*
15 *ing paragraphs (1) or (2)), the”.*

16 (b) *ALLOTMENT OF FUNDS.*—*Section 433 of such Act*
17 *(42 U.S.C. 629c) is amended—*

18 (1) *in subsection (d), by inserting “subsection*
19 *(a), (b), or (c) of” before “this section” the 1st and*
20 *2nd places it appears; and*

21 (2) *by adding at the end the following:*

22 “(e) *SPECIAL RULES APPLICABLE TO FUNDS RE-*
23 *SERVED TO SUPPORT MONTHLY CASEWORKER VISITS.*—

24 “(1) *ALLOTMENTS.*—

1 “(A) *TERRITORIES.*—*From the amount re-*
2 *served pursuant to section 436(b)(4)(A) for fiscal*
3 *year 2006 or any succeeding fiscal year, the Sec-*
4 *retary shall allot to each jurisdiction specified in*
5 *subsection (b) of this section that meets the re-*
6 *quirements of paragraph (2) of this subsection*
7 *for the fiscal year an amount determined in the*
8 *same manner as the allotment to each of such ju-*
9 *risdictions is determined under section 423*
10 *(without regard to the initial allotment of*
11 *\$70,000 to each State).*

12 “(B) *OTHER STATES.*—*From the amount*
13 *reserved pursuant to section 436(b)(4)(A) for fis-*
14 *cal year 2006 or any succeeding fiscal year that*
15 *remains after applying subparagraph (A) of this*
16 *paragraph for the fiscal year, the Secretary shall*
17 *allot to each State (other than an Indian tribe)*
18 *not specified in subsection (b) of this section that*
19 *meets the requirements of paragraph (2) of this*
20 *subsection for the fiscal year an amount equal to*
21 *such remaining amount multiplied by the food*
22 *stamp percentage of the State (as defined in sub-*
23 *section (c)(2) of this section) for the fiscal year,*
24 *except that in applying subsection (c)(2)(A) of*

1 *this section, ‘subsection (e)(1)(B)’ shall be sub-*
2 *stituted for ‘such paragraph (1)’.*

3 “(2) *REQUIREMENTS.—The requirements of this*
4 *paragraph are the following:*

5 “(A) *AMOUNTS ALLOTTED FOR FISCAL YEAR*
6 *2007.—In the case of amounts reserved pursuant*
7 *to section 436(b)(4)(A) for fiscal year 2007, the*
8 *State has provided to the Secretary data which*
9 *shows, for the most recent fiscal year for which*
10 *such information is available—*

11 “(i) *the percentage of children in foster*
12 *care under the responsibility of the State*
13 *who were visited by the caseworker handling*
14 *the case of the child at least once each*
15 *month while the child was in such care; and*

16 “(ii) *the percentage of the visits that*
17 *occurred in the residence of the child.*

18 “(B) *AMOUNTS ALLOTTED FOR SUCCEEDING*
19 *FISCAL YEARS.—In the case of amounts reserved*
20 *pursuant to section 436(b)(4)(A) for fiscal year*
21 *2008 or any succeeding fiscal year:*

22 “(i) *DATA SHOWING FREQUENCY AND*
23 *LOCATION OF CASEWORKER VISITS.—The*
24 *State has provided to the Secretary data*

1 *which shows, for the preceding fiscal year,*
2 *that—*

3 *“(I) for at least 90 percent of the*
4 *children in foster care under the re-*
5 *sponsibility of the State—*

6 *“(aa) the caseworker han-*
7 *dling the case of the child visited*
8 *the child at least once each month*
9 *while the child was in such care;*
10 *and*

11 *“(bb) the majority of the vis-*
12 *its occurred in the residence of the*
13 *child; or*

14 *“(II) the State made the requisite*
15 *annual progress, as determined by the*
16 *Secretary, to comply with subclause (I)*
17 *by October 1, 2011.*

18 *“(ii) STATE ABILITY TO VERIFY FRE-*
19 *QUENCY OF CASEWORKER VISITS.—The Sec-*
20 *retary has verified that the State has in ef-*
21 *fect such policies and standards as may be*
22 *necessary to enable the State to determine*
23 *whether, for at least 90 percent of the chil-*
24 *dren in foster care under the responsibility*
25 *of the State, a caseworker visited the child*

1 *at least once each month during the fiscal*
2 *year.*

3 “(iii) *VERIFICATION OF NONSUPPLAN-*
4 *TATION COMPLIANCE.—The State has pro-*
5 *vided to the Secretary such documentation*
6 *as may be necessary to verify that the State*
7 *has complied with section 436(b)(4)(B)(ii)*
8 *during the fiscal year.”.*

9 *(c) PAYMENTS TO STATES.—Section 434(a) of such Act*
10 *(42 U.S.C. 629d(a)), as amended by section 3(b)(1) of this*
11 *Act, is amended by striking “the lesser of—” and all that*
12 *follows and inserting the following: “the sum of—*

13 “(1) *the lesser of—*

14 “(A) *75 percent of the total expenditures by*
15 *the State for activities under the plan during the*
16 *fiscal year or the immediately succeeding fiscal*
17 *year; or*

18 “(B) *the allotment of the State under sub-*
19 *section (a), (b), or (c) of section 433, whichever*
20 *is applicable, for the fiscal year; and*

21 “(2) *the lesser of—*

22 “(A) *75 percent of the total expenditures by*
23 *the State in accordance with section*
24 *436(b)(4)(B) during the fiscal year or the imme-*
25 *diately succeeding fiscal year; or*

1 *community-based agencies and ensures all children are*
2 *raised in safe, loving families, by—*

3 “(1) *protecting and promoting the welfare of all*
4 *children;*

5 “(2) *preventing the neglect, abuse, or exploi-*
6 *tation of children;*

7 “(3) *supporting at-risk families through services*
8 *which allow children, where appropriate, to remain*
9 *safely with their families or return to their families*
10 *in a timely manner;*

11 “(4) *promoting the safety, permanence, and well-*
12 *being of children in foster care; and*

13 “(5) *providing training, professional develop-*
14 *ment and support to ensure a well-qualified child wel-*
15 *fare workforce.”.*

16 *(c) MODIFICATION OF STATE PLAN REQUIREMENTS.—*
17 *Section 422 of such Act (42 U.S.C. 622) is amended—*

18 *(1) in subsection (b)—*

19 *(A) by striking paragraphs (3) through (5)*
20 *and inserting the following:*

21 “(3) *include a description of the services and ac-*
22 *tivities which the State will fund under the State pro-*
23 *gram carried out pursuant to this subpart, and how*
24 *the services and activities will achieve the purpose of*
25 *this subpart;”;*

1 (B) by striking paragraph (6) and inserting
2 after paragraph (3) (as added by subparagraph
3 (A) of this paragraph) the following:

4 “(4) contain a description of—

5 “(A) the steps the State will take to provide
6 child welfare services statewide and to expand
7 and strengthen the range of existing services and
8 develop and implement services to improve child
9 outcomes; and

10 “(B) the child welfare services staff develop-
11 ment and training plans of the State;”;

12 (C) by redesignating paragraphs (7)
13 through (9) as paragraphs (5) through (7), re-
14 spectively;

15 (D) in paragraph (10)—

16 (i) by striking subparagraph (A);

17 (ii) in subparagraph (B)(iii)(II), by
18 inserting “, which may include a residen-
19 tial educational program” after “in some
20 other planned, permanent living arrange-
21 ment”;

22 (iii) by redesignating subparagraph
23 (B) as subparagraph (A); and

1 *(iv) by striking subparagraph (C) and*
2 *inserting after subparagraph (A) the fol-*
3 *lowing:*

4 *“(B) has in effect policies and administra-*
5 *tive and judicial procedures for children aban-*
6 *doned at or shortly after birth which enable per-*
7 *manent decisions to be made expeditiously with*
8 *respect to the placement of the children;”;*

9 *(E) in paragraph (14), by striking “and”*
10 *at the end;*

11 *(F) in paragraph (15), by striking the pe-*
12 *riod and inserting a semicolon;*

13 *(G) by redesignating paragraphs (10)*
14 *through (15) as paragraphs (8) through (13), re-*
15 *spectively; and*

22 *physicians or other appropriate medical professionals*
23 *are actively consulted and involved in—*

1 “(A) assessing the health and well-being of
2 children in foster care under the responsibility of
3 the State; and

4 “(B) determining appropriate medical
5 treatment for the children.”; and

6 (2) by adding at the end the following:

7 “(c) *DEFINITIONS.—In this subpart:*

8 “(1) *ADMINISTRATIVE COSTS.—The term ‘admin-*
9 *istrative costs’ means costs for the following, but only*
10 *to the extent incurred in administering the State plan*
11 *developed pursuant to this subpart: procurement, pay-*
12 *roll management, personnel functions (other than the*
13 *portion of the salaries of supervisors attributable to*
14 *time spent directly supervising the provision of serv-*
15 *ices by caseworkers), management, maintenance and*
16 *operation of space and property, data processing and*
17 *computer services, accounting, budgeting, auditing,*
18 *and travel expenses (except those related to the provi-*
19 *sion of services by caseworkers or the oversight of pro-*
20 *grams funded under this subpart).*

21 “(2) *OTHER TERMS.—For definitions of other*
22 *terms used in this part, see section 475.”.*

23 (d) *PROVISIONS RELATING TO STATE ALLOTMENTS.—*
24 *Section 423 of such Act, as so redesignated by subsection*
25 *(b)(2) of this section, is amended—*

1 (1) *in subsection (a)—*

2 (A) *by inserting “IN GENERAL.—” after*
3 *“(a)”;*

4 (B) *by striking “420” and inserting “425”;*
5 *and*

6 (C) *by striking “He” and inserting “The*
7 *Secretary”;*

8 (2) *in subsection (b)—*

9 (A) *by inserting “DETERMINATION OF*
10 *STATE ALLOTMENT PERCENTAGES.—” after*
11 *“(b)”;* *and*

12 (B) *by striking “per centum” each place it*
13 *appears and inserting “percent”;*

14 (3) *in subsection (c), by inserting “PROMULGA-*
15 *TION OF STATE ALLOTMENT PERCENTAGES.—” after*
16 *“(c)”;*

17 (4) *in subsection (d)—*

18 (A) *by inserting “UNITED STATES DE-*
19 *FINED.—” after “(d)”;* *and*

20 (B) *by striking “fifty” and inserting “50”;*
21 *and*

22 (5) *by adding at the end the following:*

23 “(e) *REALLOTMENT OF FUNDS.—*

24 “(1) *IN GENERAL.—The amount of any allot-*
25 *ment to a State for a fiscal year under the preceding*

1 *provisions of this section which the State certifies to*
2 *the Secretary will not be required for carrying out the*
3 *State plan developed as provided in section 422 shall*
4 *be available for reallocation from time to time, on*
5 *such dates as the Secretary may fix, to other States*
6 *which the Secretary determines—*

7 *“(A) need sums in excess of the amounts al-*
8 *located to such other States under the preceding*
9 *provisions of this section, in carrying out their*
10 *State plans so developed; and*

11 *“(B) will be able to so use such excess sums*
12 *during the fiscal year.*

13 *“(2) CONSIDERATIONS.—The Secretary shall*
14 *make the reallocations on the basis of the State plans*
15 *so developed, after taking into consideration—*

16 *“(A) the population under 21 years of age;*

17 *“(B) the per capita income of each of such*
18 *other States as compared with the population*
19 *under 21 years of age; and*

20 *“(C) the per capita income of all such other*
21 *States with respect to which such a determina-*
22 *tion by the Secretary has been made.*

23 *“(3) AMOUNTS REALLOCATED TO A STATE*
24 *AMOUNTS DEEMED PART OF STATE ALLOTMENT.—*

1 *Any amount so reallocated to a State is deemed part*
2 *of the allotment of the State under this section.”.*

3 *(e) PAYMENTS TO STATES.—*

4 *(1) EXCLUSION OF EXPENDITURES FOR CHILD*
5 *DAY CARE, FOSTER CARE MAINTENANCE PAYMENTS,*
6 *AND ADOPTION ASSISTANCE PAYMENTS FROM ALLOW-*
7 *ABLE EXPENDITURES.—Section 424 of such Act, as so*
8 *redesignated by subsection (b)(2) of this section, is*
9 *amended—*

10 *(A) in subsection (c)—*

11 *(i) in paragraph (1)—*

12 *(I) by striking “No” and inserting*
13 *“Except as provided in paragraph (2),*
14 *no”;*

15 *(II) by striking “, for any fiscal*
16 *year beginning after September 30,*
17 *1979,”;*

18 *(III) in subparagraph (A), by*
19 *striking “necessary” and all that fol-*
20 *lows through “living”; and*

21 *(IV) in subparagraph (C), by*
22 *striking “, to the extent” and all that*
23 *follows through “1979”; and*

24 *(ii) by striking paragraph (2) and in-*
25 *serting the following:*

1 “(2) *In the case of a State which demonstrates to the*
2 *Secretary that the State made an expenditure described in*
3 *paragraph (1) in fiscal year 2005, the Secretary shall not*
4 *make a payment to the State under this part for any fiscal*
5 *year beginning after September 30, 2006, with respect to*
6 *the State expenditures so described, to the extent that the*
7 *Federal payment with respect to the expenditures so de-*
8 *scribed for the fiscal year exceeds the lesser of—*
