## RESOLUTION

Providing for the expenses of certain committees of the House of Representatives in the One Hundred Ninth Congress.

1       *Resolved,*

2       **SECTION 1. COMMITTEE EXPENSES FOR THE ONE HUN-**  
3                               **DRED NINTH CONGRESS.**

4           *(a) IN GENERAL.—With respect to the One Hundred*  
5       *Ninth Congress, there shall be paid out of the applicable*

1 *accounts of the House of Representatives, in accordance*  
2 *with this primary expense resolution, not more than the*  
3 *amount specified in subsection (b) for the expenses (includ-*  
4 *ing the expenses of all staff salaries) of each committee*  
5 *named in such subsection.*
