## RESOLUTION

Waiving points of order against the conference report to accompany the concurrent resolution (H. Con. Res. 95) establishing the congressional budget for the United States Government for fiscal year 2006, revising appropriate budgetary levels for fiscal year 2005, and setting forth appropriate budgetary levels for fiscal years 2007 through 2010, and for other purposes.

- 1       *Resolved*, That upon adoption of this resolution it
- 2 shall be in order to consider the conference report to ac-

1 company the concurrent resolution (H. Con. Res. 95) es-  
2 tablishing the congressional budget for the United States  
3 Government for fiscal year 2006, revising appropriate  
4 budgetary levels for fiscal year 2005, and setting forth ap-  
5 propriate budgetary levels for fiscal years 2007 through  
6 2010. All points of order against the conference report and  
7 against its consideration are waived. The conference re-  
8 port shall be considered as read. The conference report  
9 shall be debatable for one hour equally divided and con-  
10 trolled by the chairman and ranking minority member of  
11 the Committee on the Budget.

12       SEC. 2. (a) During the One Hundredth Ninth Con-  
13 gress, except as provided in subsection (c), a motion that  
14 the Committee of the Whole rise and report a bill to the  
15 House shall not be in order if the bill, as amended, exceeds  
16 an applicable allocation of new budget authority under sec-  
17 tion 302(b) of the Congressional Budget Act of 1974, as  
18 estimated by the Committee on the Budget.

19       (b) If a point of order under subsection (a) is sus-  
20 tained, the Chair shall put the question: “Shall the Com-  
21 mittee of the Whole rise and report the bill to the House  
22 with such amendments as may have been adopted notwith-  
23 standing that the bill exceeds its allocation of new budget  
24 authority under section 302(b) of the Congressional Budg-  
25 et Act of 1974?” Such question shall be debatable for 10

1 minutes equally divided and controlled by a proponent of  
2 the question and an opponent but shall be decided without  
3 intervening motion.

4 (c) Subsection (a) shall not apply—

5 (1) to a motion offered under clause 2(d) of  
6 rule XXI; or

7 (2) after disposition of a question under sub-  
8 section (b) on a given bill.

9 (d) If a question under subsection (b) is decided in  
10 the negative, no further amendment shall be in order ex-  
11 cept—

12 (1) one proper amendment, which shall be de-  
13 batable for 10 minutes equally divided and con-  
14 trolled by the proponent and an opponent, shall not  
15 be subject to amendment, and shall not be subject  
16 to a demand for division of the question in the  
17 House or in the Committee of the Whole; and

18 (2) pro forma amendments, if offered by the  
19 chairman or ranking minority member of the Com-  
20 mittee on Appropriations or their designees, for the  
21 purpose of debate.
