Mr. SESSIONS, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 2360) making appropriations for the Department of Homeland Security for the fiscal year ending September 30, 2006, and for other purposes.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 2(b) of  
3 rule XVIII, declare the House resolved into the Committee  
4 of the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 2360) making appropriations for  
6 the Department of Homeland Security for the fiscal year

1 ending September 30, 2006, and for other purposes. The  
2 first reading of the bill shall be dispensed with. All points  
3 of order against consideration of the bill are waived. Gen-  
4 eral debate shall be confined to the bill and shall not ex-  
5 ceed one hour equally divided and controlled by the chair-  
6 man and ranking minority member of the Committee on  
7 Appropriations. After general debate the bill shall be con-  
8 sidered for amendment under the five-minute rule. Points  
9 of order against provisions in the bill for failure to comply  
10 with clause 2 of rule XXI are waived except as follows:  
11 beginning with the colon on page 6, line 8, through “Of-  
12 fice” on page 7, line 7; beginning with “of” on page 7,  
13 line 17, through the semicolon on line 23; beginning with  
14 the colon on page 8, line 19, through “108–541” on page  
15 9, line 15; beginning with the colon on page 9, line 23,  
16 through “checkpoint” on page 10, line 3; beginning with  
17 the colon on page 10, line 9, through “Office” on page  
18 11, line 6; beginning with the colon on page 11, line 24,  
19 through “Representatives” on page 12, line 7; beginning  
20 with the colon on page 17, line 2, through “intent” on  
21 line 11; page 17, lines 21 through 24; beginning with the  
22 colon on page 18, line 5, through “Act” on line 18; begin-  
23 ning with the colon on page 21, line 2, through “assets”  
24 on page 22, line 12; beginning with the comma on page  
25 26, line 22, through “law” on line 23; beginning with the

1 colon on page 27, line 2, through “funds” on page 27,  
2 line 13: page 27, line 19, through page 28, line 5; begin-  
3 ning with the colon on page 28, line 15, through “funds”  
4 on page 29, line 2; beginning with the colon on page 29,  
5 line 6, through “2005” on page 30, line 8; beginning with  
6 the comma on page 36, line 19, through “funds” on line  
7 22; and sections 507, 512, 515, 517, 518, 522, 523, 524,  
8 525, 527, 529, 530, 532, and 534. Where points of order  
9 are waived against part of a paragraph or section, points  
10 of order against a provision in another part of such para-  
11 graph or section may be made only against such provision  
12 and not against the entire paragraph or section. During  
13 consideration of the bill for amendment, the Chairman of  
14 the Committee of the Whole may accord priority in rec-  
15 ognition on the basis of whether the Member offering an  
16 amendment has caused it to be printed in the portion of  
17 the Congressional Record designated for that purpose in  
18 clause 8 of rule XVIII. Amendments so printed shall be  
19 considered as read. When the committee rises and reports  
20 the bill back to the House with a recommendation that  
21 the bill do pass, the previous question shall be considered  
22 as ordered on the bill and amendments thereto to final  
23 passage without intervening motion except one motion to  
24 recommit with or without instructions.
