Mr. PUTNAM, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2744) making appropriations for Agriculture, Rural Development, Food and Drug Administration, and Related Agencies for the fiscal year ending September 30, 2006, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 2744) making appropriations for

1 Agriculture, Rural Development, Food and Drug Adminis-
2 tration, and Related Agencies for the fiscal year ending
3 September 30, 2006, and for other purposes. The first
4 reading of the bill shall be dispensed with. All points of
5 order against consideration of the bill are waived. General
6 debate shall be confined to the bill and shall not exceed
7 one hour equally divided and controlled by the chairman
8 and ranking minority member of the Committee on Appro-
9 priations. After general debate the bill shall be considered
10 for amendment under the five-minute rule. Points of order
11 against provisions in the bill for failure to comply with
12 clause 2 of rule XXI are waived except as follows: begin-
13 ning with the colon on page 54, line 4, through “overseas”
14 on line 9; section 749; page 81, lines 1 through 7; and be-
15 ginning with “and” on page 81, line 11, through “pro-
16 grams” on line 17. Where points of order are waived
17 against part of a paragraph or section, points of order
18 against a provision in another part of such paragraph or
19 section may be made only against such provision and not
20 against the entire paragraph or section. During consider-
21 ation of the bill for amendment, the Chairman of the Com-
22 mittee of the Whole may accord priority in recognition on
23 the basis of whether the Member offering an amendment
24 has caused it to be printed in the portion of the Congres-
25 sional Record designated for that purpose in clause 8 of

1 rule XVIII. Amendments so printed shall be considered
2 as read. When the committee rises and reports the bill
3 back to the House with a recommendation that the bill
4 do pass, the previous question shall be considered as or-
5 dered on the bill and amendments thereto to final passage
6 without intervening motion except one motion to recommit
7 with or without instructions.
