Mr. GINGREY, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2862) making appropriations for Science, the Departments of State, Justice, and Commerce, and related agencies for the fiscal year ending September 30, 2006, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 2862) making appropriations for

1 Science, the Departments of State, Justice, and Com-
2 merce, and related agencies for the fiscal year ending Sep-
3 tember 30, 2006, and for other purposes. The first reading
4 of the bill shall be dispensed with. All points of order
5 against consideration of the bill are waived. General de-
6 bate shall be confined to the bill and shall not exceed one
7 hour equally divided and controlled by the chairman and
8 ranking minority member of the Committee on Appropria-
9 tions. After general debate the bill shall be considered for
10 amendment under the five-minute rule. Points of order
11 against provisions in the bill for failure to comply with
12 clause 2 of rule XXI are waived except for section 607.
13 During consideration of the bill for amendment, the Chair-
14 man of the Committee of the Whole may accord priority
15 in recognition on the basis of whether the Member offering
16 an amendment has caused it to be printed in the portion
17 of the Congressional Record designated for that purpose
18 in clause 8 of rule XVIII. Amendments so printed shall
19 be considered as read. When the committee rises and re-
20 ports the bill back to the House with a recommendation
21 that the bill do pass, the previous question shall be consid-
22 ered as ordered on the bill and amendments thereto to
23 final passage without intervening motion except one mo-
24 tion to recommit with or without instructions.
