Mr. BISHOP of Utah, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2745) to reform the United Nations, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 2745) to reform the United Na-
6 tions, and for other purposes. The first reading of the bill
7 shall be dispensed with. All points of order against consid-

1 eration of the bill are waived. General debate shall be con-
2 fined to the bill and shall not exceed 20 minutes equally
3 divided and controlled by the chairman and ranking mi-
4 nority member of the Committee on International Rela-
5 tions. After general debate the bill shall be considered for
6 amendment under the five-minute rule.

7 SEC. 2. (a) It shall be in order to consider as an origi-
8 nal bill for the purpose of amendment under the five-
9 minute rule the amendment in the nature of a substitute
10 recommended by the Committee on International Rela-
11 tions now printed in the bill. The committee amendment
12 in the nature of a substitute shall be considered as read.
13 All points of order against the committee amendment in
14 the nature of a substitute are waived.

15 (b) Notwithstanding clause 11 of rule XVIII, no
16 amendment to the committee amendment in the nature
17 of a substitute shall be in order except those printed in
18 the report of the Committee on Rules accompanying this
19 resolution and amendments en bloc described in section
20 3 of this resolution.

21 (c) Each amendment printed in the report of the
22 Committee on Rules shall be considered only in the order
23 printed in the report, may be offered only by a Member
24 designated in the report, shall be considered as read, shall
25 be debatable for the time specified in the report equally

1 divided and controlled by the proponent and an opponent,
2 shall not be subject to amendment, and shall not be sub-
3 ject to a demand for division of the question in the House
4 or in the Committee of the Whole.

5 (d) All points of order against amendments printed
6 in the report of the Committee on Rules or amendments
7 en bloc described in section 3 of this resolution are waived.

8 (e)(1) Consideration of amendments printed in sub-
9 part A of part 1 of the report of the Committee on Rules
10 shall begin with an additional period of general debate,
11 which shall be confined to the subject of accountability of
12 the United Nations and shall not exceed 20 minutes equal-
13 ly divided and controlled by the chairman and ranking mi-
14 nority member of the Committee on International Rela-
15 tions.

16 (2) Consideration of amendments printed in subpart
17 B of part 1 of the report of the Committee on Rules shall
18 begin with an additional period of general debate, which
19 shall be confined to the subject of United Nations peace-
20 keeping operations and shall not exceed 10 minutes equal-
21 ly divided and controlled by the chairman and ranking mi-
22 nority member of the Committee on International Rela-
23 tions.

24 (3) Consideration of amendments printed in subpart
25 C of part 1 of the report of the Committee on Rules shall

1 begin with an additional period of general debate, which
2 shall be confined to the subject of the International Atom-
3 ic Energy Agency and shall not exceed 10 minutes equally
4 divided and controlled by the chairman and ranking mi-
5 nority member of the Committee on International Rela-
6 tions.

7 (4) Consideration of amendments printed in subpart
8 D of part 1 of the report of the Committee on Rules shall
9 begin with an additional period of general debate, which
10 shall be confined to the subject of human rights and shall
11 not exceed 20 minutes equally divided and controlled by
12 the chairman and ranking minority member of the Com-
13 mittee on International Relations.

14 (5) Consideration of amendments printed in subpart
15 E of part 1 of the report of the Committee on Rules shall
16 begin with an additional period of general debate, which
17 shall be confined to the subject of the Oil-for Food Pro-
18 gram and shall not exceed 20 minutes equally divided and
19 controlled by the chairman and ranking minority member
20 of the Committee on International Relations.

21 SEC. 3. It shall be in order at any time for the chair-
22 man of the Committee on International Relations or his
23 designee to offer amendments en bloc consisting of amend-
24 ments printed in part 2 of the report of the Committee
25 on Rules not earlier disposed of or germane modifications

1 of any such amendment. Amendments en bloc offered pur-
2 suant to this section shall be considered as read (except
3 that modifications shall be reported), shall be debatable
4 for 20 minutes equally divided and controlled by the chair-
5 man and ranking minority member of the Committee on
6 International Relations or their designees, shall not be
7 subject to amendment, and shall not be subject to a de-
8 mand for division of the question in the House or in the
9 Committee of the Whole. For the purpose of inclusion in
10 such amendments en bloc, an amendment printed in the
11 form of a motion to strike may be modified to the form
12 of a germane perfecting amendment to the text originally
13 proposed to be stricken. The original proponent of an
14 amendment included in such amendments en bloc may in-
15 sert a statement in the Congressional Record immediately
16 before the disposition of the amendments en bloc.

17 SEC. 4. At the conclusion of consideration of the bill
18 for amendment the Committee shall rise and report the
19 bill to the House with such amendments as may have been
20 adopted. Any Member may demand a separate vote in the
21 House on any amendment adopted in the Committee of
22 the Whole to the bill or to the committee amendment in
23 the nature of a substitute. The previous question shall be
24 considered as ordered on the bill and amendments thereto

- 1 to final passage without intervening motion except one
- 2 motion to recommit with or without instructions.
