13 eral Government, including the executive and legisla-
14 tive branches, relating to any existing or previous
15 agreement between the Department of Homeland
16 Security and Shirlington Limousine;

17 (3) all records indicating or discussing any ne-
18 gotiations between the Department of Homeland Se-
19 curity and Shirlington Limousine relating to any ex-
20 isting or previous agreement between the Depart-
21 ment of Homeland Security and Shirlington Lim-
22 ousine;

23 (4) all records indicating or discussing any ne-
24 gotiations between the Department of Homeland Se-
25 curity and ADCS, Incorporated, including its cur-

1 rent and former principals, relating to any existing
2 or previous agreement between the Department of
3 Homeland Security and Shirlington Limousine;

4 (5) all records indicating or discussing any ne-
5 gotiations between the Department of Homeland Se-
6 curity and MZM, Incorporated, including its current
7 and former principals, relating to any existing or
8 previous agreement between the Department of
9 Homeland Security and Shirlington Limousine; and

10 (6) all records indicating or discussing any ne-
11 gotiations between the Department of Homeland Se-
12 curity and Athena Innovative Solutions, Incor-
13 porated, including its current and former principals,
14 or its parent company, including its current and
15 former principals, relating to any existing or pre-
16 vious agreement between the Department of Home-
17 land Security and Shirlington Limousine.
