Mr. BISHOP, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 5386) making appropriations for the Department of the Interior, environment, and related agencies for the fiscal year ending September 30, 2007, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 5386) making appropriations for
6 the Department of the Interior, environment, and related

1 agencies for the fiscal year ending September 30, 2007,
2 and for other purposes. The first reading of the bill shall
3 be dispensed with. All points of order against consider-
4 ation of the bill are waived. General debate shall be con-
5 fined to the bill and shall not exceed one hour equally di-
6 vided and controlled by the chairman and ranking minor-
7 ity member of the Committee on Appropriations. After
8 general debate the bill shall be considered for amendment
9 under the five-minute rule. Points of order against provi-
10 sions in the bill for failure to comply with clause 2 of rule
11 XXI are waived except as follows: page 73, lines 3 through
12 8; section 425; and title V. During consideration of the
13 bill for amendment, the Chairman of the Committee of
14 the Whole may accord priority in recognition on the basis
15 of whether the Member offering an amendment has caused
16 it to be printed in the portion of the Congressional Record
17 designated for that purpose in clause 8 of rule XVIII.
18 Amendments so printed shall be considered as read. When
19 the committee rises and reports the bill back to the House
20 with a recommendation that the bill do pass, the previous
21 question shall be considered as ordered on the bill and
22 amendments thereto to final passage without intervening
23 motion except one motion to recommit with or without in-
24 structions.

1 SEC. 2. Upon adoption of House Concurrent Resolu-
2 tion 376, and until a concurrent resolution on the budget
3 for fiscal year 2007 has been adopted by the Congress,
4 the provisions of House Concurrent Resolution 376 and
5 its accompanying report shall have force and effect in the
6 House for all purposes of the Congressional Budget Act
7 of 1974 as though adopted by the Congress.

8 (b) Nothing in this section may be construed to en-
9 gage rule XXVII.
