Requesting the President and directing the Secretary of Defense and the Attorney General to transmit to the House of Representatives not later than 14 days after the date of the adoption of this resolution, documents relating to the termination of the Department of Justice's Office of Professional Responsibility's investigation of the involvement of Department of Justice personnel in the creation and administration of the National Security Agency's warrantless surveillance program, including documents relating to Office of Professional Responsibility's request for and denial of security clearances.

1 *Resolved, That—*

2 (1) the President is requested to transmit to
3 the House of Representatives not later than 14 days
4 after the date of the adoption of this resolution, all
5 documents, including telephone and electronic mail
6 records, logs and calendars, personnel records, and
7 records of internal discussions in the possession of
8 the President relating to the termination of the De-
9 partment of Justice’s Office of Professional Respon-
10 sibility’s investigation of the involvement of Depart-
11 ment of Justice personnel in the creation and ad-
12 ministration of the National Security Agency
13 warrantless surveillance program, including docu-
14 ments relating to Office of Professional Responsibil-
15 ity’s request for and denial of security clearances;

16 (2) the Secretary of Defense is directed to
17 transmit to the House of Representatives, not later
18 than such date, all documents, including telephone
19 and electronic mail records, logs and calendars, and
20 records of internal discussions in the possession of
21 the Secretary of Defense, relating to that investiga-
22 tion’s termination, including documents relating to
23 the Office of Professional Responsibility’s request
24 for and denial of security clearances; and

1 (3) the Attorney General is directed to transmit
2 to the House of Representatives, not later than such
3 date, all documents, including telephone and elec-
4 tronic mail records, logs and calendars, records of
5 internal discussions, and reports in the possession of
6 the Attorney General, relating to that investigation's
7 termination, including documents relating to Office
8 of Professional Responsibility's request for and de-
9 nial of security clearances.
