Mr. LINCOLN DIAZ-BALART, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 5522) making appropriations for foreign operations, export financing, and related programs for the fiscal year ending September 30, 2007, and for other purposes.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 2(b) of  
3 rule XVIII, declare the House resolved into the Committee  
4 of the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 5522) making appropriations for

1 foreign operations, export financing, and related programs  
2 for the fiscal year ending September 30, 2007, and for  
3 other purposes. The first reading of the bill shall be dis-  
4 pensed with. All points of order against consideration of  
5 the bill are waived. General debate shall be confined to  
6 the bill and shall not exceed one hour equally divided and  
7 controlled by the chairman and ranking minority member  
8 of the Committee on Appropriations. After general debate  
9 the bill shall be considered for amendment under the five-  
10 minute rule. Points of order against provisions in the bill  
11 for failure to comply with clause 2 of rule XXI are waived  
12 except as follows: the number “5” on page 60, line 4; sec-  
13 tion 526; beginning with “Of” on page 86, line 1 through  
14 “That” on line 16; section 538; beginning with the semi-  
15 colon in section 565(a)(2) through “501” in section  
16 565(a)(3); and sections 570 and 579. Where points of  
17 order are waived against part of a paragraph or section,  
18 points of order against a provision in another part of such  
19 paragraph or section may be made only against such pro-  
20 vision and not against the entire paragraph or section.  
21 During consideration of the bill for amendment, the Chair-  
22 man of the Committee of the Whole may accord priority  
23 in recognition on the basis of whether the Member offering  
24 an amendment has caused it to be printed in the portion  
25 of the Congressional Record designated for that purpose

1 in clause 8 of rule XVIII. Amendments so printed shall  
2 be considered as read. When the committee rises and re-  
3 ports the bill back to the House with a recommendation  
4 that the bill do pass, the previous question shall be consid-  
5 ered as ordered on the bill and amendments thereto to  
6 final passage without intervening motion except one mo-  
7 tion to recommit with or without instructions.
