## JOINT RESOLUTION

Making further continuing appropriations for the fiscal year  
2007, and for other purposes.

1       *Resolved by the Senate and House of Representatives*  
2   *of the United States of America in Congress assembled,*  
3   That this joint resolution may be cited as the “Revised  
4   Continuing Appropriations Resolution, 2007”.

1       SEC. 2. The Continuing Appropriations Resolution,  
2   2007 (Public Law 109–289, division B), as amended by  
3   Public Laws 109–369 and 109–383, is amended to read  
4   as follows:

5       “DIVISION B—CONTINUING APPROPRIATIONS  
6                               RESOLUTION, 2007

7       “The following sums are hereby appropriated, out of  
8   any money in the Treasury not otherwise appropriated,  
9   and out of applicable corporate or other revenues, receipts,  
10   and funds, for the several departments, agencies, corpora-  
11   tions, and other organizational units of Government for  
12   fiscal year 2007, and for other purposes, namely:

13               “TITLE I—FULL-YEAR CONTINUING  
14                               APPROPRIATIONS

15       “SEC. 101. (a) Such amounts as may be necessary,  
16   at the level specified in subsection (c) and under the au-  
17   thority and conditions provided in the applicable appro-  
18   priations Act for fiscal year 2006, for projects or activities  
19   (including the costs of direct loans and loan guarantees)  
20   that are not otherwise provided for and for which appro-  
21   priations, funds, or other authority were made available  
22   in the following appropriations Acts:

23               “(1) The Agriculture, Rural Development, Food  
24       and Drug Administration, and Related Agencies Ap-  
25       propriations Act, 2006.

1           “(2) The Energy and Water Development Ap-  
2           propriations Act, 2006.

3           “(3) The Foreign Operations, Export Financ-  
4           ing, and Related Programs Appropriations Act,  
5           2006.

6           “(4) The Department of the Interior, Environ-  
7           ment, and Related Agencies Appropriations Act,  
8           2006.

9           “(5) The Departments of Labor, Health and  
10          Human Services, and Education, and Related Agen-  
11          cies Appropriations Act, 2006.

12          “(6) The Legislative Branch Appropriations  
13          Act, 2006.

14          “(7) The Military Quality of Life and Veterans  
15          Affairs Appropriations Act, 2006.

16          “(8) The Science, State, Justice, Commerce,  
17          and Related Agencies Appropriations Act, 2006.

18          “(9) The Transportation, Treasury, Housing  
19          and Urban Development, the Judiciary, the District  
20          of Columbia, and Independent Agencies Appropria-  
21          tions Act, 2006.

22          “(b) For purposes of this division, the term ‘level’  
23          means an amount.

24          “(c) The level referred to in subsection (a) shall be  
25          the amounts appropriated in the appropriations Acts re-

1   ferred to in such subsection, including transfers and obli-  
 2   gation limitations, except that—

3           “(1) such level shall not include any amount  
 4           designated as an emergency requirement, or to be  
 5           for overseas contingency operations, pursuant to sec-  
 6           tion 402 of H. Con. Res. 95 (109th Congress), the  
 7           concurrent resolution on the budget for fiscal year  
 8           2006; and

9           “(2) such level shall be calculated without re-  
 10          gard to any rescission or cancellation of funds or  
 11          contract authority, other than—

12           “(A) the 1 percent government-wide rescis-  
 13          sion made by section 3801 of division B of Pub-  
 14          lic Law 109–148;

15           “(B) the 0.476 percent across-the-board  
 16          rescission made by section 439 of Public Law  
 17          109–54, relating to the Department of the Inte-  
 18          rior, environment, and related agencies; and

19           “(C) the 0.28 percent across-the-board re-  
 20          scission made by section 638 of Public Law  
 21          109–108, relating to Science, State, Justice,  
 22          Commerce, and related agencies.

23          “SEC. 102. Appropriations made by section 101 shall  
 24          be available to the extent and in the manner that would  
 25          be provided by the pertinent appropriations Act.

1       “SEC. 103. Appropriations provided by this division  
2 that, in the applicable appropriations Act for fiscal year  
3 2006, carried a multiple-year or no-year period of avail-  
4 ability shall retain a comparable period of availability.

5       “SEC. 104. Except as otherwise expressly provided in  
6 this division, the requirements, authorities, conditions,  
7 limitations, and other provisions of the appropriations  
8 Acts referred to in section 101(a) shall continue in effect  
9 through the date specified in section 106.

10       “SEC. 105. No appropriation or funds made available  
11 or authority granted pursuant to section 101 shall be used  
12 to initiate or resume any project or activity for which ap-  
13 propriations, funds, or other authority were specifically  
14 prohibited during fiscal year 2006.

15       “SEC. 106. Unless otherwise provided for in this divi-  
16 sion or in the applicable appropriations Act, appropria-  
17 tions and funds made available and authority granted pur-  
18 suant to this division shall be available through September  
19 30, 2007.

20       “SEC. 107. Expenditures made pursuant to this divi-  
21 sion prior to the enactment of the Revised Continuing Ap-  
22 propriations Resolution, 2007, shall be charged to the ap-  
23 plicable appropriation, fund, or authorization provided by  
24 this division (or the applicable regular appropriations Act  
25 for fiscal year 2007) as in effect following such enactment.

1       “SEC. 108. Funds appropriated by this division may  
2 be obligated and expended notwithstanding section 10 of  
3 Public Law 91–672 (22 U.S.C. 2412), section 15 of the  
4 State Department Basic Authorities Act of 1956 (22  
5 U.S.C. 2680), section 313 of the Foreign Relations Au-  
6 thorization Act, Fiscal Years 1994 and 1995 (22 U.S.C.  
7 6212), and section 504(a)(1) of the National Security Act  
8 of 1947 (50 U.S.C. 414(a)(1)).

9       “SEC. 109. With respect to any discretionary account  
10 for which advance appropriations were provided for fiscal  
11 year 2007 or 2008 in an appropriations Act for fiscal year  
12 2006, the levels established by section 101 shall include  
13 advance appropriations in the same amount for fiscal year  
14 2008 or 2009, respectively, with a comparable period of  
15 availability.

16       “SEC. 110. (a) For entitlements and other mandatory  
17 payments whose budget authority was provided in appro-  
18 priations Acts for fiscal year 2006, and for activities under  
19 the Food Stamp Act of 1977, the levels established by sec-  
20 tion 101 shall be the amounts necessary to maintain pro-  
21 gram levels under current law.

22       “(b) In addition to the amounts otherwise provided  
23 by section 101, the following amounts shall be available  
24 for the following accounts for advance payments for the  
25 first quarter of fiscal year 2008:

1           “(1) ‘Department of Labor, Employment  
2           Standards Administration, Special Benefits for Dis-  
3           abled Coal Miners’, for benefit payments under title  
4           IV of the Federal Mine Safety and Health Act of  
5           1977, \$68,000,000, to remain available until ex-  
6           pended.

7           “(2) ‘Department of Health and Human Serv-  
8           ices, Centers for Medicare and Medicaid Services,  
9           Grants to States for Medicaid’, for payments to  
10          States or in the case of section 1928 on behalf of  
11          States under title XIX of the Social Security Act,  
12          \$65,257,617,000, to remain available until ex-  
13          pended.

14          “(3) ‘Department of Health and Human Serv-  
15          ices, Administration for Children and Families, Pay-  
16          ments to States for Child Support Enforcement and  
17          Family Support Programs’, for payments to States  
18          or other non-Federal entities under titles I, IV–D,  
19          X, XI, XIV, and XVI of the Social Security Act and  
20          the Act of July 5, 1960 (24 U.S.C. ch. 9),  
21          \$1,000,000,000, to remain available until expended.

22          “(4) ‘Department of Health and Human Serv-  
23          ices, Administration for Children and Families, Pay-  
24          ments to States for Foster Care and Adoption As-  
25          sistance’, for payments to States or other non-Fed-

1       eral entities under title IV–E of the Social Security  
2       Act, \$1,810,000,000.

3           “(5) ‘Social Security Administration, Supple-  
4       mental Security Income Program’, for benefit pay-  
5       ments under title XVI of the Social Security Act,  
6       \$16,810,000,000, to remain available until ex-  
7       pended.

8       “SEC. 111. (a)(1) In addition to any amounts other-  
9       wise provided by this division, such sums as may be nec-  
10      essary are hereby appropriated to fund, for covered em-  
11      ployees under a statutory pay system (as defined by sec-  
12      tion 5302 of title 5, United States Code), 50 percent of  
13      any increase in rates of pay which became effective under  
14      sections 5303 through 5304a of such title 5 in January  
15      2007.

16       “(2)(A) In addition to any amounts otherwise pro-  
17      vided by this division, such sums as may be necessary are  
18      hereby appropriated to provide the amount which would  
19      be necessary to fund, for covered employees not described  
20      in paragraph (1), 50 percent of the cost of an increase  
21      in rates of pay, calculated as if such employees were cov-  
22      ered by paragraph (1) and as if such increase had been  
23      made on the first day of the first pay period beginning  
24      in January 2007 based on the rates that were in effect  
25      for such employees as of the day before such first day.

1       “(B) Subparagraph (A) is intended only to provide  
2 funding for pay increases for covered employees not de-  
3 scribed in paragraph (1). Nothing in subparagraph (A)  
4 shall be considered to modify, supersede, or render inappli-  
5 cable the provisions of law in accordance with which the  
6 size or timing of any pay increase actually provided with  
7 respect to such employees is determined.

8       “(b) Appropriations under this section shall include  
9 funding for pay periods beginning on or after January 1,  
10 2007, and the pay costs covered by this appropriation  
11 shall include 50 percent of the increases in agency con-  
12 tributions for employee benefits resulting from the pay in-  
13 creases described in subsection (a).

14       “(c) For purposes of this section, the term ‘covered  
15 employees’ means employees whose pay is funded in whole  
16 or in part (including on a reimbursable basis) by any ac-  
17 count for which funds are provided by this division (other  
18 than by chapters 2 and 11 of title II of this division) after  
19 October 4, 2006.

20       “SEC. 112. Any language specifying an earmark in  
21 a committee report or statement of managers accom-  
22 panying an appropriations Act for fiscal year 2006 shall  
23 have no legal effect with respect to funds appropriated by  
24 this division.

1       “SEC. 113. Within 30 days of the enactment of this  
2 section, each of the following departments and agencies  
3 shall submit to the Committees on Appropriations of the  
4 House of Representatives and the Senate a spending, ex-  
5 penditure, or operating plan for fiscal year 2007 at a level  
6 of detail below the account level:

7               “(1) Department of Agriculture.

8               “(2) Department of Commerce, including the  
9 United States Patent and Trademark Office.

10              “(3) Department of Defense, with respect to  
11 military construction, family housing, the Depart-  
12 ment of Defense Base Closure accounts, and ‘De-  
13 fense Health Program’.

14              “(4) Department of Education.

15              “(5) Department of Energy.

16              “(6) Department of Health and Human Serv-  
17 ices.

18              “(7) Department of Housing and Urban Devel-  
19 opment.

20              “(8) Department of the Interior.

21              “(9) Department of Justice.

22              “(10) Department of Labor.

23              “(11) Department of State and United States  
24 Agency for International Development.

25              “(12) Department of Transportation.

1           “(13) Department of the Treasury.

2           “(14) Department of Veterans Affairs, includ-  
3 ing ‘Construction, Major Projects’.

4           “(15) National Aeronautics and Space Adminis-  
5 tration.

6           “(16) National Science Foundation.

7           “(17) The Judiciary.

8           “(18) Office of National Drug Control Policy.

9           “(19) General Services Administration.

10          “(20) Office of Personnel Management.

11          “(21) National Archives and Records Adminis-  
12 tration.

13          “(22) Environmental Protection Agency.

14          “(23) Indian Health Service.

15          “(24) Smithsonian Institution.

16          “(25) Social Security Administration.

17          “(26) Corporation for National and Community  
18 Service.

19          “(27) Corporation for Public Broadcasting.

20          “(28) Food and Drug Administration.

21          “SEC. 114. Within 15 days after the enactment of  
22 this section, the Director of the Office of Management and  
23 Budget shall submit to the Committees on Appropriations  
24 of the House of Representatives and the Senate—

1           “(1) a report specifying, by account, the  
2           amounts provided by this division for executive  
3           branch departments and agencies; and

4           “(2) a report specifying, by account, the  
5           amounts provided by section 111 for executive  
6           branch departments and agencies.

7           “SEC. 115. Notwithstanding any other provision of  
8           this division and notwithstanding section 601(a)(2) of the  
9           Legislative Reorganization Act of 1946 (2 U.S.C. 31), the  
10          percentage adjustment scheduled to take effect under such  
11          section for 2007 shall not take effect.

12          “TITLE II—ELIMINATION OF EARMARKS, AD-  
13          JUSTMENTS IN FUNDING, AND OTHER PRO-  
14          VISIONS

15          **“CHAPTER 1—AGRICULTURE, RURAL DE-**  
16          **VELOPMENT, FOOD AND DRUG ADMIN-**  
17          **ISTRATION, AND RELATED AGENCIES**

18          “SEC. 20101. Notwithstanding section 101, the level  
19          for each of the following accounts for Agricultural Pro-  
20          grams of the Department of Agriculture shall be as fol-  
21          lows: ‘Common Computing Environment’, \$107,971,000;  
22          ‘Economic Research Service’, \$74,825,000; ‘National Ag-  
23          ricultural Statistics Service’, \$146,543,000, of which up  
24          to \$36,074,000 shall be available until expended for the  
25          Census of Agriculture; ‘Agricultural Research Service,

1 Buildings and Facilities’, \$0; ‘Cooperative State Research,  
 2 Education, and Extension Service, Research and Edu-  
 3 cation Activities’, \$671,224,000; ‘Cooperative State Re-  
 4 search, Education, and Extension Service, Extension Ac-  
 5 tivities’, \$450,252,000; ‘Animal and Plant Health Inspec-  
 6 tion Service, Salaries and Expenses’, \$841,970,000; ‘Agri-  
 7 cultural Marketing Service, Payments to States and Pos-  
 8 sessions’, \$1,334,000; ‘Grain Inspection, Packers and  
 9 Stockyards Administration, Salaries and Expenses’,  
 10 \$37,564,000; ‘Food Safety and Inspection Service’,  
 11 \$886,982,000; and ‘Farm Service Agency, Salaries and  
 12 Expenses’, \$1,028,700,000.

13       “SEC. 20102. The amounts included under the head-  
 14 ing ‘Cooperative State Research, Education, and Exten-  
 15 sion Service, Research and Education Activities’ in the  
 16 Agriculture, Rural Development, Food and Drug Adminis-  
 17 tration, and Related Agencies Appropriations Act, 2006  
 18 (Public Law 109–97) shall be applied to funds appro-  
 19 priated by this division as follows: by substituting  
 20 ‘\$322,597,000’ for ‘\$178,757,000’; by substituting  
 21 ‘\$30,008,000’ for ‘\$22,230,000’; by substituting ‘for pay-  
 22 ments to eligible institutions (7 U.S.C. 3222),  
 23 \$40,680,000’ for ‘for payments to the 1890 land-grant  
 24 colleges, including Tuskegee University and West Virginia  
 25 State University (7 U.S.C. 3222), \$37,591,000’; by sub-

stituting ‘\$0’ for ‘\$128,223,000’; by substituting ‘competitive grants for agricultural research on improved pest control’ for ‘special grants for agricultural research on improved pest control’; by substituting ‘\$190,229,000’ for ‘\$183,000,000’; by substituting ‘\$1,544,000’ for ‘\$1,039,000’; by substituting ‘competitive grants for the purpose of carrying out all provisions of 7 U.S.C. 3242’ for ‘noncompetitive grants for the purpose of carrying out all provisions of 7 U.S.C. 3242’; by substituting ‘to institutions eligible to receive funds under 7 U.S.C. 3221 and 3222, \$12,375,000’ for ‘to colleges eligible to receive funds under the Act of August 30, 1890 (7 U.S.C. 321–326 and 328), including Tuskegee and West Virginia State University, \$12,312,000’; by substituting ‘\$3,342,000’ for ‘\$2,250,000’; by substituting ‘\$10,083,000’ for ‘\$50,471,000’; by substituting ‘\$2,561,000’ for ‘\$2,587,000’; and by substituting ‘\$2,030,000’ for ‘\$2,051,000’.

“SEC. 20103. The amounts included under the heading ‘Cooperative State Research, Education, and Extension Service, Extension Activities’ in the Agriculture, Rural Development, Food and Drug Administration, and Related Agencies Appropriations Act, 2006 shall be applied to funds appropriated by this division as follows: by substituting ‘\$285,565,000’ for ‘\$275,730,000’; by sub-

stituting ‘\$3,321,000’ for ‘\$3,273,000’; by substituting  
‘\$63,538,000’ for ‘\$62,634,000’; by substituting ‘at insti-  
tutions eligible to receive funds under 7 U.S.C. 3221 and  
3222, \$16,777,000’ for ‘at the 1890 land-grant colleges,  
including Tuskegee University and West Virginia State  
University, as authorized by section 1447 of Public Law  
95–113 (7 U.S.C. 3222b), \$16,777,000’; by substituting  
‘\$3,000,000’ for ‘\$1,196,000’; by substituting ‘payments  
for cooperative extension work by eligible institutions (7  
U.S.C. 3221), \$35,205,000’ for ‘payments for cooperative  
extension work by the colleges receiving the benefits of the  
second Morrill Act (7 U.S.C. 321–326 and 328) and  
Tuskegee University and West Virginia State University,  
\$33,868,000’; and by substituting ‘\$6,922,000’ for  
‘\$25,390,000’.

“SEC. 20104. Notwithstanding section 101, the level  
for each of the following accounts for Conservation Pro-  
grams of the Department of Agriculture shall be as fol-  
lows: ‘Natural Resources Conservation Service, Conserva-  
tion Operations’, \$759,124,000; and ‘Natural Resources  
Conservation Service, Watershed and Flood Prevention  
Operations’, \$0.

“SEC. 20105. Notwithstanding section 101, the level  
for each of the following accounts for Rural Development  
Programs of the Department of Agriculture shall be as

1 follows: ‘Rural Development Salaries and Expenses’,  
2 \$160,349,000; ‘Rural Business-Cooperative Service, Rural  
3 Cooperative Development Grants’, \$26,718,000; and  
4 ‘Rural Utilities Service, Rural Telephone Bank Program  
5 Account’, \$0.

6 “SEC. 20106. Notwithstanding section 101, the level  
7 for ‘Rural Housing Service, Rental Assistance Program’  
8 shall be \$616,020,000, to remain available through Sep-  
9 tember 30, 2008, and the second and third provisos under  
10 such heading shall not apply to funds appropriated by this  
11 division. Using funds available in such account, the Sec-  
12 retary of Agriculture may enter into or renew contracts  
13 under section 521(a)(2) of the Housing Act of 1949 (42  
14 U.S.C. 1490a(a)(2)) for two years. Any unexpended bal-  
15 ances remaining at the end of such two-year agreements  
16 may be transferred and used for the purposes of any debt  
17 reduction; maintenance, repair, or rehabilitation of any ex-  
18 isting projects; preservation; and rental assistance activi-  
19 ties authorized under title V of such Act (42 U.S.C. 1471  
20 et seq.).

21 “SEC. 20107. Notwithstanding section 101, the level  
22 for ‘Food and Nutrition Service, Child Nutrition Pro-  
23 grams’ shall be \$13,345,487,000, of which  
24 \$7,614,414,000 is appropriated funds and  
25 \$5,731,073,000 shall be derived by transfer from funds

1 available under section 32 of the Act of August 24, 1935  
 2 (7 U.S.C. 612c).

3       “SEC. 20108. Notwithstanding section 101, the level  
 4 for each of the following accounts for Foreign Assistance  
 5 and Related Programs of the Department of Agriculture  
 6 shall be as follows: ‘Foreign Agricultural Service, Salaries  
 7 and Expenses’, \$155,422,000; ‘Foreign Agricultural Serv-  
 8 ice, Public Law 480 Title I Ocean Freight Differential  
 9 Grants’, \$0; and ‘Foreign Agricultural Service, Public  
 10 Law 480 Title II Grants’, \$1,214,711,000.

11       “SEC. 20109. Notwithstanding section 101, the level  
 12 for ‘Food and Drug Administration, Salaries and Ex-  
 13 penses’ shall be \$1,965,207,000, of which \$352,200,000  
 14 shall be derived from prescription drug user fees author-  
 15 ized by 21 U.S.C. 379h, shall be credited to this account  
 16 and remain available until expended, and shall not include  
 17 any fees pursuant to 21 U.S.C. 379h(a)(2) and (a)(3) as-  
 18 sessed for fiscal year 2008 but collected in fiscal year  
 19 2007, \$43,726,000 shall be derived from medical device  
 20 user fees authorized by 21 U.S.C. 379j and shall be cred-  
 21 ited to this account and remain available until expended,  
 22 and \$11,604,000 shall be derived from animal drug user  
 23 fees authorized by 21 U.S.C. 379j and shall be credited  
 24 to this account and remain available until expended: *Pro-*  
 25 *vided*, That fees derived from prescription drug, medical

1 device, and animal drug assessments received during fiscal  
2 year 2007, including any such fees assessed prior to the  
3 current fiscal year but credited during the current year,  
4 shall be subject to the fiscal year 2007 limitation: *Provided*  
5 *further*, That none of these funds shall be used to develop,  
6 establish, or operate any program of user fees authorized  
7 by 31 U.S.C. 9701: *Provided further*, That of the total  
8 amount appropriated: (1) \$453,180,000 shall be for the  
9 Center for Food Safety and Applied Nutrition and related  
10 field activities in the Office of Regulatory Affairs; (2)  
11 \$567,594,000 shall be for the Center for Drug Evaluation  
12 and Research and related field activities in the Office of  
13 Regulatory Affairs, of which not less than \$34,900,000  
14 shall be for the Office of Generic Drugs; (3) \$209,180,000  
15 shall be for the Center for Biologics Evaluation and Re-  
16 search and for related field activities in the Office of Regu-  
17 latory Affairs; (4) \$103,544,000 shall be for the Center  
18 for Veterinary Medicine and for related field activities in  
19 the Office of Regulatory Affairs; (5) \$253,710,000 shall  
20 be for the Center for Devices and Radiological Health and  
21 for related field activities in the Office of Regulatory Af-  
22 fairs; (6) \$41,751,000 shall be for the National Center  
23 for Toxicological Research; (7) \$68,609,000 shall be for  
24 Rent and Related activities, of which \$25,552,000 is for  
25 relocation expenses, other than the amounts paid to the

1 General Services Administration for rent; (8)  
2 \$146,013,000 shall be for payments to the General Serv-  
3 ices Administration for rent; and (9) \$121,626,000 shall  
4 be for other activities, including the Office of the Commis-  
5 sioner, the Office of Management, the Office of External  
6 Relations, the Office of Policy and Planning, and central  
7 services for these offices.

8 “SEC. 20110. Notwithstanding section 101, the level  
9 for ‘Food and Drug Administration, Buildings and Facili-  
10 ties’ shall be \$4,950,000.

11 “SEC. 20111. Notwithstanding any other provision of  
12 this division, the following provisions included in the Agri-  
13 culture, Rural Development, Food and Drug Administra-  
14 tion, and Related Agencies Appropriations Act, 2006 shall  
15 not apply to funds appropriated by this division: the last  
16 proviso under the heading ‘Common Computing Environ-  
17 ment’; the provisos under the heading ‘Economic Research  
18 Service’; the third, fourth, sixth, and eighth through  
19 twelfth provisos under the heading ‘Agricultural Research  
20 Service, Salaries and Expenses’; the set-aside of funds  
21 under the heading ‘Agricultural Marketing Service, Pay-  
22 ments to States and Possessions’; the set-aside of  
23 \$753,252,000 under the heading ‘Food Safety and Inspec-  
24 tion Service’ and the first three provisos under such head-  
25 ing; the first proviso under the heading ‘Natural Re-

1 sources Conservation Service, Resource Conservation and  
2 Development'; the set-aside of \$5,600,000 in the seventh  
3 proviso under the heading 'Rural Development Programs,  
4 Rural Community Advancement Program'; the first pro-  
5 viso under the heading 'Rural Development Salaries and  
6 Expenses'; the second proviso in the second paragraph  
7 under the heading 'Rural Housing Service, Rural Housing  
8 Insurance Fund Program Account'; the last paragraph  
9 under the heading 'Rural Business-Cooperative Service,  
10 Rural Economic Development Loans Program Account';  
11 the set-aside of \$2,500,000 under the heading 'Rural  
12 Business-Cooperative Service, Rural Cooperative Develop-  
13 ment Grants'; the proviso under the heading 'Rural Busi-  
14 ness-Cooperative Service, Rural Empowerment Zones and

13 paragraph under the heading ‘Rural Housing Service,  
14 Rural Housing Insurance Fund Program Account’; the  
15 proviso under the heading ‘Rural Housing Service, Mutual  
16 and Self-Help Housing Grants’; the fourth proviso under  
17 the heading ‘Rural Housing Service, Rural Housing As-  
18 sistance Grants’; the three availability of funds clauses  
19 under the heading ‘Rural Business-Cooperative Service,  
20 Rural Development Loan Fund Program Account’; the  
21 second proviso under the heading ‘Food and Nutrition

5 783.

6 “SEC. 20117. Of the unobligated balances under sec-  
7 tion 32 of the Act of August 24, 1935 (7 U.S.C. 612c),  
8 \$37,601,000 is rescinded.

9 “SEC. 20118. Of the unobligated balances of funds  
10 provided pursuant to section 16(h)(1)(A) of the Food  
11 Stamp Act of 1977 (7 U.S.C. 2025(h)(1)(A)),  
12 \$11,200,000 is rescinded.

13 “SEC. 20119. Of the funds derived from interest on  
14 the cushion of credit payments, as authorized by section  
15 313 of the Rural Electrification Act of 1936 (7 U.S.C.  
16 940c), \$74,000,000 shall not be obligated and  
17 \$74,000,000 is rescinded.

18 “SEC. 20120. In addition to amounts otherwise ap-  
19 propriated or made available by this division, \$31,000,000  
20 is appropriated to the Secretary of Agriculture for the  
21 costs of loan and loan guarantees under the Rural Devel-  
22 opment Mission Area to ensure that the fiscal year 2006  
23 program levels for such loan and loan guarantee programs  
24 are maintained for fiscal year 2007. The Secretary may  
25 transfer funds, to the extent practicable, among loan and

11 “(3) For an additional amount for ‘Military  
12 Personnel, Marine Corps’, \$1,241,965,000, to be  
13 available for the basic allowance for housing for  
14 members of the Marine Corps on active duty.

15 “(4) For an additional amount for ‘Military  
16 Personnel, Air Force’, \$3,278,835,000, to be avail-  
17 able for the basic allowance for housing for members  
18 of the Air Force on active duty.

19 “(5) For an additional amount for ‘Reserve  
20 Personnel, Army’, \$321,642,000, to be available for  
21 the basic allowance for housing for members of the  
22 Army Reserve on active duty.

23 “(6) For an additional amount for ‘Reserve  
24 Personnel, Navy’, \$204,115,000, to be available for

1 the basic allowance for housing for members of the  
2 Navy Reserve on active duty.

3 “(7) For an additional amount for ‘Reserve  
4 Personnel, Marine Corps’, \$43,082,000, to be avail-  
5 able for the basic allowance for housing for members  
6 of the Marine Corps Reserve on active duty.

7 “(8) For an additional amount for ‘Reserve  
8 Personnel, Air Force’, \$76,218,000, to be available  
9 for the basic allowance for housing for members of  
10 the Air Force Reserve on active duty.

11 “(9) For an additional amount for ‘National  
12 Guard Personnel, Army’, \$457,226,000, to be avail-  
13 able for the basic allowance for housing for members  
14 of the Army National Guard on active duty.

17 available for the basic allowance for housing for  
18 members of the Air National Guard on active duty.

19 “(11) For an additional amount for ‘Operation  
20 and Maintenance, Army’, \$1,810,774,000, to be  
21 available for facilities sustainment, restoration and  
22 modernization.

23 “(12) For an additional amount for ‘Operation  
24 and Maintenance, Navy’, \$1,202,313,000, to be

1       available for facilities sustainment, restoration and  
2       modernization.

3           “(13) For an additional amount for ‘Operation  
4       and Maintenance, Marine Corps’, \$473,141,000, to  
5       be available for facilities sustainment, restoration  
6       and modernization.

7           “(14) For an additional amount for ‘Operation  
8       and Maintenance, Air Force’, \$1,684,019,000, to be  
9       available for facilities sustainment, restoration and  
10       modernization.

11          “(15) For an additional amount for ‘Operation  
12       and Maintenance, Defense-Wide’, \$86,386,000, to be  
13       available for facilities sustainment, restoration and  
14       modernization.

15          “(16) For an additional amount for ‘Operation

21       available for facilities sustainment, restoration and  
22       modernization.

23          “(18) For an additional amount for ‘Operation  
24       and Maintenance, Marine Corps Reserve’,

1       \$10,004,000, to be available for facilities  
2       sustainment, restoration and modernization.

3           “(19) For an additional amount for ‘Operation  
4       and Maintenance, Air Force Reserve’, \$53,850,000,  
5       to be available for facilities sustainment, restoration  
6       and modernization.

7           “(20) For an additional amount for ‘Operation  
8       and Maintenance, Army National Guard’,  
9       \$387,579,000, to be available for facilities  
10       sustainment, restoration and modernization.

11          “(21) For an additional amount for ‘Operation  
12       and Maintenance, Air National Guard’,  
13       \$177,993,000, to be available for facilities  
14       sustainment, restoration and modernization.

15       “SEC. 20203. Notwithstanding any other provision of  
16 law or of this division, amounts are appropriated for the  
17 Defense Health Program of the Department of Defense,  
18 as follows:

19           “(1) For expenses, not otherwise provided for,  
20       for medical and health care programs of the Depart-  
21       ment of Defense, as authorized by law,  
22       \$21,217,000,000, of which \$20,494,000,000 shall be  
23       for Operation and Maintenance, of which not to ex-  
24       ceed 2 percent shall remain available until Sep-  
25       tember 30, 2008, and of which up to

1       \$10,887,784,000 may be available for contracts en-  
 2       tered into under the TRICARE program; of which  
 3       \$375,000,000, to remain available for obligation  
 4       until September 30, 2009, shall be for Procurement;  
 5       and of which \$348,000,000, to remain available for  
 6       obligation until September 30, 2008, shall be for Re-  
 7       search, Development, Test and Evaluation.

8           “(2) Of the amount made available in this sec-  
 9       tion for Research, Development, Test and Evalua-  
 10      tion, \$217,500,000 shall be made available only for  
 11      peer reviewed cancer research activities, of which  
 12      \$127,500,000 shall be for breast cancer research ac-  
 13      tivities; of which \$10,000,000 shall be for ovarian  
 14      cancer research activities; and of which \$80,000,000  
 15      shall be for prostate cancer research activities.

16          “(3) Amounts made available in this section are  
 17      subject to the terms and conditions set forth in the  
 18      Department of Defense Appropriations Act, 2007  
 19      (Public Law 109–289).

 7 ons Activities’, \$6,275,103,000; and ‘Department of En-  
 8 ergy, Defense Environmental Cleanup’, \$5,730,448,000.

9 “SEC. 20314. Notwithstanding section 101, the level  
 10 for ‘Department of Energy, Energy Supply and Conserva-  
 11 tion’ shall be \$2,153,627,000, of which not less than  
 12 \$1,473,844,000 shall be for Energy Efficiency and Renew-  
 13 able Energy Resources.

14 “SEC. 20315. Notwithstanding section 101, the level  
 15 for salaries and expenses of the Department of Energy  
 16 necessary for departmental administration in carrying out  
 17 the purposes of the Department of Energy Organization  
 18 Act (42 U.S.C. 7101 et seq.), including the hire of pas-  
 19 senger motor vehicles and official reception and represen-  
 20 tation expenses not to exceed \$35,000, shall be  
 21 \$275,789,000, to remain available until expended, of  
 22 which \$43,075,000 shall be available for cyber-security ac-  
 23 tivities and of which \$7,000,000 shall be available for nec-  
 24 essary administrative expenses of the loan guarantee pro-  
 25 gram authorized in title XVII of the Energy Policy Act

1 of 2005, plus such additional amounts as necessary to  
2 cover increases in the estimated amount of cost of work  
3 for others notwithstanding the provisions of the Anti-Defi-  
4 ciency Act (31 U.S.C. 1511 et seq.): *Provided*, That such  
5 increases in cost of work are offset by revenue increases  
6 of the same or greater amount, to remain available until  
7 expended: *Provided further*, That moneys received by the  
8 Department for miscellaneous revenues estimated to total  
9 \$123,000,000 in fiscal year 2007 may be retained and  
10 used for operating expenses within this account, and may  
11 remain available until expended, as authorized by section  
12 201 of Public Law 95–238, notwithstanding the provisions  
13 of section 3302 of title 31, United States Code: *Provided*  
14 *further*, That the sum herein appropriated shall be reduced  
15 by the amount of miscellaneous revenues received during  
16 2007, and any related appropriated receipt account bal-  
17 ances remaining from prior years’ miscellaneous revenues,  
18 so as to result in a final fiscal year 2007 appropriation  
19 from the general fund estimated at not more than  
20 \$152,789,000.

21 “SEC. 20316. Notwithstanding section 101, the level  
22 for ‘Department of Energy, National Nuclear Security Ad-  
23 ministration, Defense Nuclear Nonproliferation’ shall be  
24 \$1,683,339,000, of which \$472,730,000 shall be for Inter-  
25 national Nuclear Material Protection and Cooperation and

1 of which \$115,495,000 shall be for Global Threat Reduc-  
2 tion Initiative.

3       “SEC. 20317. Notwithstanding section 101, the level  
4 for necessary expenses of the Nuclear Regulatory Commis-  
5 sion in carrying out the purposes of the Energy Reorga-  
6 nization Act of 1974 and the Atomic Energy Act of 1954,  
7 including official representation expenses (not to exceed  
8 \$15,000), and including purchase of promotional items for  
9 use in the recruitment of individuals for employment, shall  
10 be \$813,300,000, to remain available until expended: *Pro-*  
11 *vided*, That of the amount appropriated herein,  
12 \$45,700,000 shall be derived from the Nuclear Waste  
13 Fund: *Provided further*, That revenues from licensing fees,  
14 inspection services, and other services and collections esti-  
15 mated at \$659,055,000 in fiscal year 2007 shall be re-  
16 tained and used for necessary salaries and expenses in this  
17 account, notwithstanding section 3302 of title 31, United  
18 States Code, and shall remain available until expended:  
19 *Provided further*, That the sum herein appropriated shall  
20 be reduced by the amount of revenues received during fis-  
21 cal year 2007 so as to result in a final fiscal year 2007  
22 appropriation estimated at not more than \$154,245,000.

23       “SEC. 20318. The Secretary of Energy may not make  
24 available any of the funds provided by this division or pre-  
25 vious appropriations Acts for construction activities for

1 Project 99–D–143, mixed oxide fuel fabrication facility,  
2 Savannah River Site, South Carolina, until August 1,  
3 2007.

4 “SEC. 20319. Section 302 of Public Law 102–377  
5 is repealed.

6 “SEC. 20320. (a) Notwithstanding section 101, sub-  
7 ject to the Federal Credit Reform Act of 1990, as amend-  
8 ed, commitments to guarantee loans under title XVII of  
9 the Energy Policy Act of 2005 shall not exceed a total  
10 principal amount, any part of which is to be guaranteed,  
11 of \$4,000,000,000: *Provided*, That there are appropriated  
12 for the cost of the guaranteed loans such sums as are here-  
13 after derived from amounts received from borrowers pur-  
14 suant to section 1702(b)(2) of that Act, to remain avail-  
15 able until expended: *Provided further*, That the source of  
16 payments received from borrowers for the subsidy cost  
17 shall not be a loan or other debt obligation that is made  
18 or guaranteed by the Federal government. In addition,  
19 fees collected pursuant to section 1702(h) in fiscal year  
20 2007 shall be credited as offsetting collections to the De-  
21 partmental Administration account for administrative ex-

3 penses shall not be available until appropriated.

4 “(b) No loan guarantees may be awarded under title  
5 XVII of the Energy Policy Act of 2005 until final regula-  
6 tions are issued that include—

7 “(1) programmatic, technical, and financial fac-  
8 tors the Secretary will use to select projects for loan  
9 guarantees;

10 “(2) policies and procedures for selecting and  
11 monitoring lenders and loan performance; and

12 “(3) any other policies, procedures, or informa-  
13 tion necessary to implement title XVII of the Energy  
14 Policy Act of 2005.

15 “(c) The Secretary of Energy shall enter into an ar-  
16 rangement with an independent auditor for annual evalua-  
17 tions of the program under title XVII of the Energy Policy  
18 Act of 2005. In addition to the independent audit, the  
19 Comptroller General shall conduct an annual review of the  
20 Department’s execution of the program under title XVII  
21 of the Energy Policy Act of 2005. The results of the inde-  
22 pendent audit and the Comptroller General’s review shall  
23 be provided directly to the Committees on Appropriations  
24 of the House of Representatives and the Senate.

1       “(d) The Secretary of Energy shall promulgate final  
2 regulations for loan guarantees under title XVII of the  
3 Energy Policy Act of 2005 within 6 months of enactment  
4 of this division.

5       “(e) Not later than 120 days after the date of enact-  
6 ment of this division, and annually thereafter, the Sec-  
7 retary of Energy shall transmit to the Committees on Ap-  
8 propriations of the House of Representatives and the Sen-  
9 ate a report containing a summary of all activities under  
10 title XVII of the Energy Policy Act of 2005, beginning  
11 in fiscal year 2007, with a listing of responses to loan  
12 guarantee solicitations under such title, describing the  
13 technologies, amount of loan guarantee sought, and the  
14 applicants’ assessment of risk.

15       “SEC. 20321. For fiscal year 2007, except as other-  
16 wise provided by law in effect as of the date of enactment  
17 of this division or unless a rate is specifically set by an  
18 Act of Congress thereafter, the Administrators of the  
19 Southeastern Power Administration, the Southwestern  
20 Power Administration, the Western Power Administra-  
21 tion, shall use the ‘yield’ rate in computing interest during  
22 Construction and interest on the unpaid balance of the  
23 cost of Federal power facilities. The yield rate shall be  
24 defined as the average yield during the preceding fiscal  
25 year on interest-bearing marketable securities of the

1 United States which, at the time the computation is made,  
2 have terms of 15 years or more remaining to maturity.

3 “SEC. 20322. The second proviso under the heading  
4 ‘Department of Energy, Energy Programs, Nuclear Waste  
5 Disposal’ in title III of the Energy and Water Develop-  
6 ment Appropriations Act, 2006 (Public Law 109–103)  
7 shall not apply to funds appropriated by this division.

1           “(C) \$7,920,000 shall be available for obliga-  
2           tion for the period July 1, 2007, through June 30,  
3           2010, for necessary expenses of construction, reha-  
4           bilitation and acquisition of Job Corps centers.

5           “(3) The Secretary of Labor shall award the fol-  
6           lowing grants on a competitive basis: (A) Community Col-

18 any combination thereof without the explicit approval of  
19 the Committees on Appropriations of the House of Rep-  
20 resentatives and the Senate.

21 “SEC. 21063. Notwithstanding section 101—

22 “(1) the aggregate amount of new obligational  
23 authority provided under the heading ‘General Serv-  
24 ices Administration, Real Property Activities, Fed-  
25 eral Buildings Fund, Limitations on Availability of

1 Revenue' for Federal buildings and courthouses and  
2 other purposes of the Fund shall be \$7,598,426,000,  
3 including repayment of debt, of which not less than  
4 \$280,872,000 shall be for courthouse construction,  
5 and not less than \$96,539,000 shall be for border  
6 station construction, and of which \$89,061,000 shall  
7 be from the additional amount provided by para-  
8 graph (2) of this subsection;

9 “(2) for an additional amount to be deposited  
10 in the ‘General Services Administration, Real Prop-  
11 erty Activities, Federal Buildings Fund’,  
12 \$89,061,000 is appropriated, out of any money in  
13 the Treasury not otherwise appropriated;

14 “(3) the Administrator of General Services is  
15 authorized to initiate design, construction, repair, al-  
16 teration, leasing, and other projects through existing  
17 authorities of the Administrator: *Provided*, That the  
18 General Services Administration shall submit a de-  
19 tailed plan, by project, regarding the use of funds to  
20 the Committees on Appropriations of the House of  
21 Representatives and the Senate within 30 days of  
22 enactment of this section; and

23 “(4) none of the funds appropriated or other-  
24 wise made available in this division for the ‘General  
25 Services Administration, Real Property Activities,

1 Federal Buildings Fund’ may be obligated for the  
2 Coast Guard consolidation and development of St.  
3 Elizabeths campus in the District of Columbia.

4 “SEC. 21064. Notwithstanding section 101, the level  
5 for ‘Merit Systems Protection Board, Salaries and Ex-  
6 penses’ shall be \$35,814,000, together with not to exceed  
7 \$2,579,000 for administrative expenses to adjudicate re-  
8 tirement appeals to be transferred from the Civil Service  
9 Retirement and Disability Fund in amounts determined  
10 by the Merit Systems Protection Board.

11 “SEC. 21065. Notwithstanding section 101, the level  
12 for ‘National Archives and Records Administration, Elec-  
13 tronic Records Archives’ shall be \$45,214,000.

14 “SEC. 21066. (a) Notwithstanding section 101, the  
15 level for ‘National Archives and Records Administration,  
16 Repairs and Restoration’ shall be \$9,120,000.

17 “(b) Within the amount provided by this section, the  
18 following amounts shall not be required:

19 “(1) \$1,485,000 for construction of a new re-  
20 gional archives and records facility.

21 “(2) \$990,000 for repair and restoration of a  
22 plaza surrounding a presidential library.

23 “SEC. 21067. (a) Notwithstanding section 101, the  
24 level for ‘National Archives and Records Administration,  
25 Operating Expenses’ shall be \$278,235,000.

1       “(b) Within the amount provided by this section,  
2 \$1,980,000 shall not be required for the initial move of  
3 records, staffing, and operations of a presidential library.

4       “SEC. 21068. Section 403(f) of Public Law 103–356  
5 (31 U.S.C. 501 note) shall be applied by substituting the  
6 date specified in section 106 of this division for ‘October  
7 1, 2006’.

8       “SEC. 21069. The text of section 405 of the Ethics  
9 in Government Act of 1978 (5 U.S.C. App.) is amended  
10 to read as follows: ‘There are authorized to be appro-  
11 priated to carry out this title such sums as may be nec-  
12 essary for fiscal year 2007’.

13       “SEC. 21070. Notwithstanding section 101, the level  
14 for ‘Office of Personnel Management, Salaries and Ex-  
15 penses’ shall be \$111,095,000, of which \$6,913,170 shall  
16 remain available until expended for the Enterprise Human  
17 Resources Integration project and \$1,435,500 shall re-  
18 main available until expended for the Human Resources  
19 Line of Business project; and in addition \$112,017,000  
20 for administrative expenses, to be transferred from the ap-  
21 propriate trust funds of the Office of Personnel Manage-  
22 ment without regard to other statutes, including direct  
23 procurement of printed materials, for the retirement and  
24 insurance programs, of which \$13,000,000 shall remain

1 available until expended for the cost of automating the re-  
2 tirement recordkeeping systems.

3 “SEC. 21071. Notwithstanding section 101, the level  
4 for ‘Office of Special Counsel, Salaries and Expenses’ shall  
5 be \$15,407,000.

6 “SEC. 21072. Notwithstanding section 101, the level  
7 for ‘United States Postal Service, Payment to the Postal  
8 Service Fund’ shall be \$29,000,000; and, in addition,  
9 \$6,915,000, which shall not be available for obligation  
10 until October 1, 2007, and shall be in addition to amounts  
11 provided under section 109.

12 “SEC. 21073. (a) Notwithstanding section 101, the  
13 level for ‘Federal Payment to the Court Services and Of-  
14 fender Supervision Agency for the District of Columbia’,  
15 shall be \$209,594,000, of which \$133,476,000 shall be for  
16 necessary expenses of the Community Supervision and Sex  
17 Offender Registration, \$45,220,000 shall be available to  
18 the Pretrial Services Agency, and \$30,898,000 shall be  
19 transferred to the Public Defender Service of the District  
20 of Columbia.

21 “(b) Notwithstanding section 101, the level for ‘Fed-  
22 eral Payment to the Office of the Chief Financial Officer  
23 of the District of Columbia’ shall be \$20,000,000, and  
24 shall be used only for upgrading and expanding public  
25 transportation capacity, in accordance with an expenditure

1 plan submitted by the Mayor of the District of Columbia  
2 not later than 60 days after the enactment of this section  
3 which details the activities to be carried out with such  
4 Federal Payment. Such Federal Payment may be applied  
5 to expenditures incurred as of October 1, 2006.

6 “(c) Notwithstanding section 101, any appropriation  
7 or funds made available to the District of Columbia pursu-  
8 ant to this division for ‘Federal Payment for School Im-  
9 provement’ which are made available to expand quality  
10 public charter schools in the District of Columbia shall  
11 remain available until expended to the extent that the ap-  
12 propriation or funds are used for public charter school  
13 credit enhancement and direct loans.

14 “(d) Notwithstanding section 101, no appropriation  
15 or funds shall be made available to the District of Colum-  
16 bia pursuant to this division with respect to any of the  
17 following items in the District of Columbia Appropriations  
18 Act, 2006 (Public Law 109–115; 119 Stat. 2508 et seq.):

19 “(1) The item relating to ‘Federal Payment for  
20 the National Guard Youth Challenge Program’.

21 “(2) The item relating to ‘Federal Payment for  
22 Marriage Development and Improvement’.

23 “(e) Notwithstanding section 101, the level for ‘Fed-  
24 eral Payment for Emergency Planning and Security Costs  
25 in the District of Columbia’ shall be \$8,533,000.

1       “(f) Notwithstanding section 101, the level for ‘De-  
2 fender Services in District of Columbia Courts’ shall be  
3 \$43,475,000.

4       “(g) Notwithstanding any other provision of this divi-  
5 sion, except section 106, the District of Columbia may ex-  
6 pend local funds for programs and activities under the  
7 heading ‘District of Columbia Funds’ for such programs  
8 and activities under title V of H.R. 5576 (109th Con-  
9 gress), as passed by the House of Representatives, at the  
10 rate set forth under ‘District of Columbia Funds, Sum-  
11 mary of Expenses’ as included in the Fiscal Year 2007  
12 Proposed Budget and Financial Plan submitted to the  
13 Congress by the District of Columbia on June 5, 2006  
14 as amended on January 16, 2007.

15       “(h) Section 203(c) of the 2005 District of Columbia  
16 Omnibus Authorization Act (Public Law 109–356; 120  
17 Stat. 2038) is amended by striking ‘6 months’ and insert-  
18 ing ‘1 year’.

19       “(i) Not later than 60 days after the enactment of  
20 this section, the Mayor of the District of Columbia shall  
21 submit a plan for the expenditure of the funds made avail-  
22 able to the District of Columbia pursuant to this division  
23 to the Committees on Appropriations of the House of Rep-  
24 resentatives and the Senate.

1       “SEC. 21074. Within the amount provided by this di-  
2 vision for ‘Other Federal Drug Control Programs’, the fol-  
3 lowing amount shall not be required: \$1,980,000 as a di-  
4 rected grant to the Community Anti-Drug Coalitions of  
5 America for the National Community Anti-Drug Coalition  
6 Institute, as authorized in chapter 2 of the National Nar-  
7 cotics Leadership Act of 1988, as amended.

8       “SEC. 21075. Within the amount provided by this di-  
9 vision for ‘Other Federal Drug Control Programs’,  
10 \$1,980,000 is provided, as authorized, under the Drug-  
11 Free Communities Support Program, for training, tech-  
12 nical assistance, evaluation, research, and capacity build-  
13 ing for coalitions.

14       “SEC. 21076. Notwithstanding section 101, no funds  
15 shall be appropriated or otherwise made available by this  
16 division for the following accounts of the Department of  
17 the Treasury: ‘Air Transportation Stabilization Program  
18 Account’; and ‘Treasury Building and Annex Repair and  
19 Restoration’.

20       “SEC. 21077. For purposes of this division, section  
21 206 of Public Law 109–115 shall not apply.

22       “SEC. 21078. (a) The Federal Election Commission  
23 may charge and collect fees for attending or otherwise par-  
24 ticipating in a conference sponsored by the Commission,  
25 and notwithstanding section 3302 of title 31, United

1 States Code, any amounts received from such fees during  
 2 a fiscal year shall be credited to and merged with the  
 3 amounts appropriated or otherwise made available to the  
 4 Commission during the year, and shall be available for use  
 5 during the year for the costs of sponsoring such con-  
 6 ferences.

7 “(b) This section shall apply with respect to fiscal  
 8 year 2007 and each succeeding fiscal year.

9 **“CHAPTER 11—DEPARTMENT OF**  
 10 **HOMELAND SECURITY**

11 “SEC. 21101. Not to exceed \$155,600,000 shall be  
 12 transferred to ‘Department of Homeland Security, Trans-  
 13 portation Security Administration, Expenses’, to liquidate  
 14 obligations incurred against funds appropriated in fiscal  
 15 years 2002 and 2003, of which \$150,300,000 shall be  
 16 from unobligated balances currently available to the  
 17 Transportation Security Administration, \$300,000 shall  
 18 be from unobligated balances currently available to the Of-  
 19 fice of the Secretary and Executive Management, and  
 20 \$5,000,000 shall be from unobligated balances currently  
 21 available to the Under Secretary for Management: *Pro-*  
 22 *vided*, That the Transportation Security Administration  
 23 shall not utilize any unobligated balances from the fol-  
 24 lowing programs: screener partnership program; explosive  
 25 detection system purchase; explosive detection system in-

1 stallation; checkpoint support; aviation regulation and  
2 other enforcement; air cargo; air cargo research and devel-  
3 opment; and operation integration: *Provided further*, That  
4 of the funds transferred, \$2,000,000 shall be from the ‘Se-  
5 cure Flight Program’; \$100,000 shall be from the ‘Imme-  
6 diate Office of the Deputy Secretary’; \$100,000 shall be  
7 from the ‘Office of Legislative and Intergovernmental Af-  
8 fairs’; \$100,000 shall be from the ‘Office of Public Af-  
9 fairs’; and \$5,000,000 shall be from ‘MAX-HR Human  
10 Resource System’.

11 “This division may be cited as the ‘Continuing Ap-  
12 propriations Resolution, 2007’.”.
