Mr. CALVERT (for himself, Mr. CAMPBELL of California, and Mr. GARY G. MILLER of California) introduced the following bill; which was referred to the Committee on Natural Resources

A BILL

To authorize the Secretary, in cooperation with the City of San Juan Capistrano, California, to participate in the design, planning, and construction of an advanced water treatment plant facility and recycled water system, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “South Orange County
5 Recycled Water Enhancement Act”.

1 **SEC. 2. PROJECT AUTHORIZATIONS.**

2 (a) IN GENERAL.—The Reclamation Wastewater and
3 Groundwater Study and Facilities Act (Public Law 102–
4 575, title XVI; 43 U.S.C. 390h et seq.) is amended by
5 adding at the end the following:

6 **“SEC. 16xx. SAN JUAN CAPISTRANO RECYCLED WATER SYS-**
7 **TEM.**

8 “(a) AUTHORIZATION.—The Secretary, in coopera-
9 tion with the City of San Juan Capistrano, California, is
10 authorized to participate in the design, planning, and con-
11 struction of an advanced water treatment plant facility
12 and recycled water system.

13 “(b) COST SHARE.—The Federal share of the cost
14 of the project authorized by this section shall not exceed
15 25 percent of the total cost of the project.

16 “(c) LIMITATION.—The Secretary shall not provide
17 funds for the operation and maintenance of the project
18 authorized by this section.

19 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
20 is authorized to be appropriated to carry out this section
21 \$18,500,000.

22 “(e) SUNSET.—The authority of the Secretary to
23 carry out any provisions of this section shall terminate 10
24 years after the date of the enactment of this section.

1 **“SEC. 163X. SAN CLEMENTE RECLAIMED WATER PROJECT.**

2 “(a) **AUTHORIZATION.**—The Secretary, in coopera-
3 tion with the City of San Clemente, California, is author-
4 ized to participate in the design, planning, and construc-
5 tion of a project to expand reclaimed water distribution,
6 storage and treatment facilities.

7 “(b) **COST SHARE.**—The Federal share of the cost
8 of the project authorized by this section shall not exceed
9 25 percent of the total cost of the project.

10 “(c) **LIMITATION.**—The Secretary shall not provide
11 funds for the operation and maintenance of the project
12 authorized by this section.

13 “(d) **AUTHORIZATION OF APPROPRIATIONS.**—There
14 is authorized to be appropriated to carry out this section
15 \$5,000,000

16 “(e) **SUNSET.**—The authority of the Secretary to
17 carry out any provisions of this section shall terminate 10
18 years after the date of the enactment of this section.”.

19 (b) **CONFORMING AMENDMENTS.**—The table of sec-
20 tions in section 2 of Public Law 102–575 is amended by
21 inserting after the item relating to section 163X the fol-
22 lowing:

“Sec. 163X. San Juan Capistrano Recycled Water System.

“Sec. 163X. San Clemente Reclaimed Water Project.”.
