AN ACT

To amend the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users to make technical corrections, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **TITLE I—HIGHWAY PROVISIONS**

4 **SEC. 101. SURFACE TRANSPORTATION TECHNICAL COR-**
5 **RECTIONS.**

6 (a) CORRECTION OF INTERNAL REFERENCES IN DIS-
7 ADVANTAGED BUSINESS ENTERPRISES.—Paragraphs
8 (3)(A) and (5) of section 1101(b) of the Safe, Account-

1 able, Flexible, Efficient Transportation Equity Act: A
2 Legacy for Users (119 Stat. 1156) are amended by strik-
3 ing “paragraph (1)” each place it appears and inserting
4 “paragraph (2)”.

5 (b) CORRECTION OF DISTRIBUTION OF OBLIGATION
6 AUTHORITY.—Section 1102(e)(5) of the Safe, Account-
7 able, Flexible, Efficient Transportation Equity Act: A
8 Legacy for Users (119 Stat. 1158) is amended by striking
9 “among the States”.

10 (c) CORRECTION OF FEDERAL LANDS HIGHWAYS.—
11 Section 1119 of the Safe, Accountable, Flexible, Efficient

21 year may be used for signage identifying public
22 hunting and fishing access; and

23 “(3) not more than \$10,000,000 for each fiscal
24 year shall be used by the Secretary of Agriculture to
25 pay the costs of facilitating the passage of aquatic

1 species beneath forest roads (as defined in section
2 101(a) of title 23, United States Code), including
3 the costs of constructing, maintaining, replacing,
4 and removing culverts and bridges, as appropriate.”.

 24 and coordination activities between trans-
 25 portation and public safety agencies; and

1 “(ii) improvements to the transpor-
2 tation system, such as traffic detection and
3 surveillance, arterial management, freeway
4 management, demand management, work
5 zone management, emergency manage-
6 ment, electronic toll collection, automated
7 enforcement, traffic incident management,
8 roadway weather management, traveler in-
9 formation services, commercial vehicle op-
10 erations, traffic control, freight manage-
11 ment, and coordination of highway, rail,
12 transit, bicycle, and pedestrian oper-
13 ations.”.
