## A BILL

To amend the National Trails System Act to designate the

Washington-Rochambeau Revolutionary Route National Historic Trail.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Washington-Rocham-*  
5 *beau Revolutionary Route National Historic Trail Designa-*  
6 *tion Act”.*

7 **SEC. 2. ADDITION TO NATIONAL SCENIC AND NATIONAL**  
8 **HISTORIC TRAILS.**

9 *Section 5(a) of the National Trails System Act (16*  
10 *U.S.C. 1244(a)) is amended by adding at the end the fol-*  
11 *lowing:*

12 *“(\_\_\_\_) WASHINGTON-ROCHAMBEAU REVOLUTIONARY*  
13 *ROUTE NATIONAL HISTORIC TRAIL.—*

14 *“(A) IN GENERAL.—The Washington-Rocham-*  
15 *beau Revolutionary Route National Historic Trail, a*  
16 *corridor of approximately 600 miles following the*  
17 *route taken by the armies of General George Wash-*  
18 *ington and Count Rochambeau between Newport,*  
19 *Rhode Island, and Yorktown, Virginia, in 1781 and*  
20 *1782, as generally depicted on the map titled ‘Wash-*  
21 *ington-Rochambeau Revolutionary Route National*  
22 *Historic Trail’, numbered T01/80,001, and dated*  
23 *June, 2007.*

1           “(B) *MAP.*—*The map referred to in subpara-*  
2           *graph (A) shall be on file and available for public in-*  
3           *spection in the appropriate offices of the National*  
4           *Park Service.*

5           “(C) *ADMINISTRATION.*—*The trail shall be ad-*  
6           *ministered by the Secretary of the Interior, in con-*  
7           *sultation with—*

8                     “(i) *other Federal, State, tribal, regional,*  
9                     *and local agencies; and*

10                    “(ii) *the private sector.*

11           “(D) *LAND ACQUISITION.*—*The United States*  
12           *shall not acquire for the trail any land or interest in*  
13           *land outside the exterior boundary of any federally-*  
14           *managed area without the consent of the owner of the*  
15           *land or interest in land.”.*

16 **SEC. 3. ENERGY.**

17           *Nothing in the amendment made by section 2 of this*  
18           *Act shall prohibit or hinder the development, production,*  
19           *conveyance, or transmission of energy.*
