Mr. GRIJALVA introduced the following bill; which was referred to the Committee on Natural Resources

A BILL

To amend the Reclamation Wastewater and Groundwater Study and Facilities Act to authorize the Secretary of the Interior to participate in the Avra/Black Wash Reclamation and Riparian Restoration Project.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Avra/Black Wash Rec-
5 lamation and Riparian Restoration Project”.

6 **SEC. 2. PROJECT AUTHORIZATION.**

7 (a) IN GENERAL.—The Reclamation Wastewater and
8 Groundwater Study and Facilities Act (Public Law 102–

1 575, title XVI; 43 U.S.C. 390h et seq.) is amended by
 2 adding after section 16____ the following:

3 **“SEC. 16____. AVRA/BLACK WASH RECLAMATION AND RI-**
 4 **PARIAN RESTORATION PROJECT, PIMA**
 5 **COUNTY, ARIZONA.**

6 “(a) AUTHORIZATION.—The Secretary, in coopera-
 7 tion with Pima County, Arizona, may participate in the
 8 planning, design, and construction of water recycling fa-
 9 cilities and to enhance and restore riparian habitat in the
 10 Black Wash Sonoran Desert ecosystem in Avra Valley
 11 west of the metropolitan Pima County area.

12 “(b) COST SHARING.—The Federal share of the cost
 13 of the project described in subsection (a) shall not exceed
 14 25 percent of the cost of the project.

15 “(c) LIMITATION.—Federal funds provided under
 16 this section shall not be used for operation or maintenance
 17 of the project described in subsection (a).

18 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
 19 is authorized to be appropriated to carry out this section
 20 \$14,000,000.”.

21 (b) CLERICAL AMENDMENT.—The table of sections
 22 for Public Law 102–575 is amended by inserting after the
 23 item relating to section 16____ the following:

“Sec. 16____. Avra/Black Wash Reclamation and Riparian Restoration
 Project.”.
