## A BILL

To designate the Federal building located at 131 East 4th Street in Davenport, Iowa, as the “James A. Leach Federal Building”.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. DESIGNATION.**

2       The Federal building located at 131 East 4th Street  
3 in Davenport, Iowa, shall be known and designated as the  
4 “James A. Leach Federal Building”.

5 **SEC. 2. REFERENCES.**

6       Any reference in a law, map, regulation, document,  
7 paper, or other record of the United States to the Federal  
8 building referred to in section 1 shall be deemed to be  
9 a reference to the “James A. Leach Federal Building”.

10 **SECTION 1. DESIGNATION.**

11       *The United States courthouse located at 131 East 4th*  
12 *Street in Davenport, Iowa, shall be known and designated*  
13 *as the “James A. Leach United States Courthouse”.*

14 **SEC. 2. REFERENCES.**

15       *Any reference in a law, map, regulation, document,*  
16 *paper, or other record of the United States to the United*  
17 *States courthouse referred to in section 1 shall be deemed*  
18 *to be a reference to the “James A. Leach United States*  
19 *Courthouse”.*

Amend the title so as to read: “A bill to designate the United States courthouse located at 131 East 4th Street in Davenport, Iowa, as the ‘James A. Leach United States Courthouse’.”.
