Mr. RENZI introduced the following bill; which was referred to the Committee on Natural Resources

## A BILL

To designate segments of Fossil Creek, a tributary to the Verde River in the State of Arizona, as wild and scenic rivers.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Fossil Creek Wild and  
5 Scenic River Act of 2007”.

6 **SEC. 2. FINDINGS.**

7 Congress finds that—

8 (1) the restoration of stream flow to Fossil  
9 Creek resulting from the decommissioning of the  
10 Childs-Irving Hydroelectric Project by the Arizona

1 Public Service Company is a demonstration of re-  
2 markable corporate stewardship resulting in the re-  
3 birth of a river;

4 (2) the spring-fed waters of Fossil Creek are  
5 exceptional for central Arizona and the travertine  
6 geological formations are rarely found anywhere in  
7 the United States;

8 (3) the restoration of stream flow to Fossil  
9 Creek will provide riparian habitat for native fish,  
10 birds, plants, mammals, amphibians, and reptiles;

11 (4) the Yavapai-Apache Nation considers Fossil  
12 Creek to be a sacred place, with significant spiritual  
13 and cultural values;

14 (5) the Verde River, into which Fossil Creek  
15 flows, has previously been added to the National  
16 Wild and Scenic Rivers System;

17 (6) the Northern Arizona University has in-  
18 vested significant resources in studying the restora-  
19 tion of Fossil Creek and the unique geological,  
20 hydrological, and biological characteristics of Fossil  
21 Creek;

22 (7) State and Federal land and resource man-  
23 agement agencies have invested significant resources  
24 in restoring the native fish populations of Fossil

1 Creek through barrier construction and stream ren-  
2 ovation activities;

3 (8) the Fossil Creek watershed will continue to  
4 provide opportunities for hiking, swimming, camp-  
5 ing, horseback riding, wildlife viewing, hunting, and  
6 livestock grazing;

7 (9) the Forest Service has determined that Fos-  
8 sil Creek is eligible for inclusion into the National  
9 Wild and Scenic Rivers System based on the free-  
10 flowing condition and outstandingly remarkable geol-  
11 ogy, ecology, fish, wildlife, cultural, and scenic values  
12 of the creek; and

13 (10) this reborn river deserves long-term pro-  
14 tection secured by a sustainable management plan  
15 that recognizes and maintains the remarkable values  
16 of the Fossil Creek area.

17 **SEC. 3. DESIGNATION OF WILD AND SCENIC RIVERS.**

18 Section 3(a) of the Wild and Scenic Rivers Act (16  
19 U.S.C. 1274(a)) is amended—

20 (1) by redesignating the last 3 paragraphs as  
21 paragraphs (167) through (169), respectively; and

22 (2) by adding at the end the following:

23 “(170) FOSSIL CREEK, ARIZONA.—

24 “(A) UPPER FOSSIL CREEK.—From the  
25 source at Fossil Springs below Sand Rock and

1 Calf Pen Canyons to where the water leaves the  
2 Fossil Spring Wilderness Area, as a wild river.

3 “(B) MIDDLE FOSSIL CREEK.—From the  
4 border of the Fossil Spring Wilderness Area to  
5 the Mazatzal Wilderness Boundary, as a scenic  
6 river.

7 “(C) SEGMENT.—The 6.6 miles from the  
8 Mazatzal Wilderness Boundary down to the  
9 confluence with the Verde River, as a wild  
10 river.”.

11 **SEC. 4. MANAGEMENT OF RIVER SEGMENTS.**

12 The Secretary of Agriculture shall—

13 (1) manage the river segments designated in  
14 section 3; and

15 (2) submit a river management plan for the  
16 designated segments to Congress not later than 2  
17 years after the date of enactment of this Act.

18 **SEC. 5. ALLOWANCE FOR RESTORATION ACTIVITIES.**

19 (a) ARIZONA PUBLIC SERVICE COMPANY.—Without  
20 further consultation under section 7 of the Wild and Scenic  
21 Rivers Act (16 U.S.C. 1278), Arizona Public Service  
22 Company, the former licensee for the Childs-Irving Hydro-  
23 electric Project (FERC project number 2069), may con-  
24 duct project decommissioning and restoration activities  
25 agreed to in the surrender application and relevant dock-

1 eted filings with the Federal Energy Regulatory Commis-  
2 sion.

3 (b) FEDERAL AND STATE AGENCIES.—Any Federal  
4 or State agency may conduct stream restoration and bar-  
5 rier maintenance activities in accordance with the environ-  
6 mental assessment and finding of no significant impact  
7 for the Fossil Creek Native Fish Restoration Project dated  
8 2004.

9 **SEC. 6. STREAM MONITORING.**

10 Notwithstanding the amendment made by section 3,  
11 the United States Geological Survey or any permittee of  
12 the Forest Service may undertake any necessary activities,  
13 including access by any existing road, to install, operate,  
14 maintain, or otherwise manage 1 or more stream flow  
15 gauges on Fossil Creek in cooperation with the Forest  
16 Service for the purpose of monitoring and collecting  
17 stream flow and other water resource information.

18 **SEC. 7. AUTHORIZATION OF APPROPRIATIONS.**

19 There are authorized to be appropriated such sums  
20 as are necessary for each fiscal year—

21 (1) to prepare management plans for all river  
22 segments designated as wild or scenic rivers under  
23 section 3 not later than 2 years after the date of  
24 designation, in accordance with section 3(d)(1) of

1 the Wild and Scenic Rivers Act (16 U.S.C.  
2 1274(d)(1));

3 (2) to fund a river ranger to oversee Fossil  
4 Creek; and

5 (3) to otherwise carry out this Act.
