## A BILL

To direct the Secretary of the Interior to proclaim as reservation for the benefit of the Sault Ste. Marie Tribe of Chippewa Indians a parcel of land now held in trust by the United States for that Indian tribe.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. LAND TO BE PROCLAIMED RESERVATION.**

2       (a) *IN GENERAL.*—Notwithstanding any other provi-  
3 sion of law, the Secretary of the Interior shall proclaim as  
4 reservation for the benefit of the Sault Ste. Marie Tribe of  
5 Chippewa Indians the parcel of land now held in trust by  
6 the United States and having the legal description as fol-  
7 lows: That portion of Section 19, Township 41 North,  
8 Range 3 West, Michigan Meridian, described as: All of the  
9 NW1/4SW1/4 and all of the S1/2SW1/4 Northerly of a line  
10 described as beginning 650 feet Northerly along the center-  
11 line of Highway “Mackinac Trail” from the intersection of  
12 said centerline with the South Section line of Section 19,  
13 Township 41 North, Range 3 West, thence Northeasterly to  
14 the Southeast corner of the NW1/4SW1/4 of said Section,  
15 containing 65 acres, more or less (except the highway right-  
16 of-way and easements of record).

17       (b) *APPLICABLE LAW; EFFECTIVE DATE.*—The Sec-  
18 retary’s proclamation shall be pursuant to section 7 of the  
19 Act of June 18, 1934 (25 U.S.C. 467) and the property shall  
20 be deemed a reservation as of April 19, 1988, for purposes  
21 of the Indian Gaming Regulatory Act.
