## A BILL

To amend the Department of Education Organization Act and the Carl D. Perkins Career and Technical Education Act of 2006 to redesignate the Office of Vocational and Adult Education.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REDESIGNATION OF THE OFFICE OF VOCA-**  
4 **TIONAL AND ADULT EDUCATION.**

5 (a) AMENDMENTS TO THE DEPARTMENT OF EDU-  
6 CATION ORGANIZATION ACT.—The Department of Edu-  
7 cation Organization Act (20 U.S.C. 3401 et seq.) is  
8 amended—

1           (1) in the table of contents in section 1, by  
2           amending the item relating to section 206 to read as  
3           follows:

“Sec. 206. Office of Career, Technical, and Adult Education.”;

4           (2) in section 202 (20 U.S.C. 3412)—

5           (A) in subsection (b)(1)(C), by striking  
6           “Vocational and Adult Education” and insert-  
7           ing “Career, Technical, and Adult Education”;  
8           and

9           (B) in subsection (h), by striking “Voca-  
10          tional and Adult Education” both places it ap-  
11          pears and inserting “Career, Technical, and  
12          Adult Education”;

13          (3) in section 206 (20 U.S.C. 3416)—

14          (A) in the section heading, by striking  
15          “VOCATIONAL AND ADULT EDUCATION” and in-  
16          serting “CAREER, TECHNICAL, AND ADULT  
17          EDUCATION”;

18          (B) by striking “Vocational and Adult  
19          Education” both places it appears and inserting  
20          “Career, Technical, and Adult Education”; and

21          (C) by striking “vocational and adult edu-  
22          cation” both places it appears and inserting  
23          “career, technical, and adult education”;

1           (4) in section 212(d)(6) (20 U.S.C. 3423a), by  
2           striking “vocational education” and inserting “ca-  
3           reer and technical education”; and

4           (5) in section 217(e) (20 U.S.C. 3424), by  
5           striking “vocational education” both places it ap-  
6           pears and inserting “career and technical edu-  
7           cation”.

8           (b) AMENDMENT TO THE CARL D. PERKINS CAREER  
9           AND TECHNICAL EDUCATION ACT OF 2006.—Section  
10          114(b)(1) of the Carl D. Perkins Career and Technical  
11          Education Act of 2006 (20 U.S.C. 2324(b)(1)) is amended  
12          by striking “Vocational and Adult Education” and insert-  
13          ing “Career, Technical, and Adult Education”.
