## A BILL

To provide a biennial budget for the United States  
Government.

1       *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; FINDINGS.**

4       (a) SHORT TITLE.—This Act may be cited as the  
5 “Biennial Budgeting Act of 2008”.

6       (b) FINDINGS.—The Congress finds that—

7           (1) the annual appropriations and budget proc-  
8       ess increasingly dominates the congressional agenda

1 and Congress regularly fails to meet the deadlines of  
2 the Congressional Budget Act of 1974;

3 (2) the design of the budget process has led to  
4 repetitive and time-consuming budget votes, decreas-  
5 ing the time available for the systematic and pro-  
6 grammatic oversight of Federal programs and delay-  
7 ing the enactment of legislation necessary to fund  
8 the Government;

9 (3) Congress's responsibility to improve the effi-  
10 ciency, economy, and effectiveness of governmental  
11 operations, evaluate programs and performance, de-  
12 tect and prevent poor administration, waste, or  
13 abuse in Government programs, ensure that execu-  
14 tive policies reflect the public interest, ensure admin-  
15 istrative compliance with legislative intent, and pre-  
16 vent executive encroachment on legislative authority  
17 and prerogatives is undermined by the current time-  
18 consuming and repetitive budget process;

19 (4) an annual budget process encourages ineffi-  
20 ciency in the management, stability, and predict-  
21 ability of Federal funding, particularly for States  
22 and localities; and

23 (5) a biennial budget process will reduce the  
24 number of budget-related votes during each Con-  
25 gress, enhance congressional oversight of Govern-

6 (a) DECLARATION OF PURPOSE.—Section 2(2) of the  
 7 Congressional Budget and Impoundment Control Act of  
 8 1974 (2 U.S.C. 621(2)) is amended by striking “each  
 9 year” and inserting “biennially”.

10 (b) DEFINITIONS.—

11 (1) BUDGET RESOLUTION.—Section 3(4) of  
 12 such Act (2 U.S.C. 622(4)) is amended by striking  
 13 “fiscal year” each place it appears and inserting “bi-  
 14 ennium”.

1           “(11) The term ‘biennium’ means the period of

15 300(b))” after “United States Code”.

18 (A) striking “fiscal year” and inserting  
19 “biennium”; and

20 (B) inserting after the second sentence the  
21 following: “On or before April 1 of each odd-  
22 numbered year (or, if applicable, as provided by  
23 section 300(b)), the Committee on the Budget  
24 of each House shall report to its House the con-  
25 current resolution on the budget referred to in

1 subsection (a) for the biennium beginning on  
2 October 1 of that year.”.

19 of the Congressional Budget Office shall, as soon as prac-  
20 ticable after the completion of each quarter of the fiscal  
21 year, prepare an analysis comparing revenues, spending,  
22 and the deficit or surplus for the current fiscal year to  
23 assumptions included in the congressional budget resolu-  
24 tion. In preparing this report, the Director of the Congres-  
25 sional Budget Office shall combine actual budget figures

1 to date with projected revenue and spending for the bal-  
2 ance of the fiscal year. The Director of the Congressional  
3 Budget Office shall include any other information in this  
4 report that it deems useful for a full understanding of the  
5 current fiscal position of the Federal Government. The re-  
6 ports mandated by this subsection shall be transmitted by  
7 the Director to the Senate and House Committees on the  
8 Budget, and the Congressional Budget Office shall make  
9 such reports available to any interested party upon re-  
10 quest.”.

11 (j) COMPLETION OF HOUSE ACTION ON REGULAR  
12 APPROPRIATION BILLS.—Section 309 of such Act (2  
13 U.S.C. 640) is amended—

14 (1) by striking “It” and inserting “Except

5 year” each place it appears and inserting “any fiscal  
6 year covered by such resolution”; and

7 (3) by striking subsection (f) and redesignating  
8 subsection (g) as subsection (f).

9 (l) SECTION 311 POINT OF ORDER.—

10 (1) IN THE HOUSE.—Section 311(a)(1) of such  
11 Act (2 U.S.C. 642(a)) is amended—

12 (A) by striking “for a fiscal year” and in-  
13 serting “for a biennium”;

14 (B) by striking “the first fiscal year” each  
15 place it appears and inserting “either fiscal  
16 year of the biennium”; and

17 (C) by striking “that first fiscal year” and  
18 inserting “each fiscal year in the biennium”.

21 Section 105 of title 1, United States Code, is amend-  
22 ed to read as follows:

23 **“§ 105. Title and style of appropriations Acts**

24 “(a) The style and title of all Acts making appropria-  
25 tions for the support of the Government shall be as fol-

1 lows: ‘An Act making appropriations (here insert the ob-  
2 ject) for each fiscal year in the biennium of fiscal years  
3 (here insert the fiscal years of the biennium).’.

4 “(b) All Acts making regular appropriations for the  
5 support of the Government shall be enacted for a biennium  
6 and shall specify the amount of appropriations provided  
7 for each fiscal year in such period.

8 “(c) For purposes of this section, the term ‘biennium’  
9 has the same meaning as in section 3(11) of the Congres-  
10 sional Budget and Impoundment Control Act of 1974 (2  
11 U.S.C. 622(11)).”.

12 **SEC. 7. MULTIYEAR AUTHORIZATIONS.**

13 (a) IN GENERAL.—Title III of the Congressional  
14 Budget Act of 1974 is amended by adding at the end the  
15 following new section:

16 “MULTIYEAR AUTHORIZATIONS OF APPROPRIATIONS

17 “SEC. 316. (a) POINT OF ORDER.—(1)(A) It shall  
18 not be in order in the House of Representatives or the  
19 Senate to consider any measure that contains a specific  
20 authorization of appropriations for any purpose unless the  
21 measure includes such a specific authorization of appro-  
22 priations for that purpose for not less than each fiscal year  
23 in one or more bienniums.

24 “(B) For purposes of this paragraph, a specific au-  
25 thorization of appropriations is an authorization for the  
26 enactment of an amount of appropriations or amounts not

1 to exceed an amount of appropriations (whether stated as  
 2 a sum certain, as a limit, or as such sums as may be nec-  
 3 essary) for any purpose for a fiscal year.

4 “(2) Paragraph (1) does not apply with respect to  
 5 an authorization of appropriations for a single fiscal year  
 6 for any program, project, or activity if the measure con-  
 7 taining that authorization includes a provision expressly  
 8 stating the following: ‘Congress finds that no authoriza-  
 9 tion of appropriation will be required for [Insert name of  
 10 applicable program, project, or activity] for any subse-  
 11 quent fiscal year.’.

12 “(3) For purposes of this subsection, the term ‘meas-  
 13 ure’ means a bill, joint resolution, amendment, motion, or  
 14 conference report.”.

15 (b) AMENDMENT TO TABLE OF CONTENTS.—The  
 16 table of contents set forth in section 1(b) of the Congres-  
 17 sional Budget and Impoundment Control Act of 1974 is  
 18 amended by adding after the item relating to section 315  
 19 the following new item:

“Sec. 316. Multiyear authorizations of appropriations.”.

20 **SEC. 8. GOVERNMENT STRATEGIC AND PERFORMANCE**  
 21 **PLANS ON A BIENNIAL BASIS.**

22 (a) STRATEGIC PLANS.—Section 306 of title 5,  
 23 United States Code, is amended—

24 (1) in subsection (a), by striking “September  
 25 30, 1997” and inserting “September 30, 2010”;

1 (2) in subsection (b)—

2 (A) by striking “at least every three years”

3 and inserting “at least every 4 years”; and

4 (B) by striking “five years forward” and

5 inserting “six years forward”; and

6 (3) in subsection (c), by inserting a comma

7 after “section” the second place it appears and add-

8 ing “including a strategic plan submitted by Sep-

9 tember 30, 2010, meeting the requirements of sub-

10 section (a)”.

11 (b) BUDGET CONTENTS AND SUBMISSION TO CON-

12 GRESS.—Paragraph (28) of section 1105(a) of title 31,

13 United States Code, is amended by striking “beginning

14 with fiscal year 1999, a” and inserting “beginning with

15 fiscal year 2010, a biennial”.

16 (c) PERFORMANCE PLANS.—Section 1115 of title 31,

17 United States Code, is amended—

18 (1) in subsection (a)—

19 (A) in the matter before paragraph (1)—

20 (i) by striking “section 1105(a)(29)”

21 and inserting “section 1105(a)(28)”;

22 (ii) by striking “an annual” and in-

23 serting “a biennial”;

1 (B) in paragraph (1) by inserting after  
2 “program activity” the following: “for both  
3 years 1 and 2 of the biennial plan”;

4 (C) in paragraph (5) by striking “and”  
5 after the semicolon;

6 (D) in paragraph (6) by striking the period  
7 and inserting a semicolon; and inserting “and”  
8 after the inserted semicolon; and

9 (E) by adding after paragraph (6) the fol-  
10 lowing:

11 “(7) cover each fiscal year of the biennium be-  
12 ginning with the first fiscal year of the next biennial  
13 budget cycle.”;

14 (2) in subsection (d) by striking “annual” and  
15 inserting “biennial”; and

16 (3) in paragraph (6) of subsection (f) by strik-  
17 ing “annual” and inserting “biennial”.

18 (d) MANAGERIAL ACCOUNTABILITY AND FLEXI-  
19 BILITY.—Section 9703 of title 31, United States Code, re-  
20 lating to managerial accountability, is amended—

21 (1) in subsection (a)—

22 (A) in the first sentence by striking “an-  
23 nual”; and

24 (B) by striking “section 1105(a)(29)” and  
25 inserting “section 1105(a)(28)”;

1 (2) in subsection (e)—

2 (A) in the first sentence by striking “one  
3 or” before “years”;

4 (B) in the second sentence by striking “a  
5 subsequent year” and inserting “for a subse-  
6 quent 2-year period”; and

7 (C) in the third sentence by striking  
8 “three” and inserting “four”.

9 (e) PILOT PROJECTS FOR PERFORMANCE BUDG-  
10 ETING.—Section 1119 of title 31, United States Code, is  
11 amended—

12 (1) in paragraph (1) of subsection (d), by strik-  
13 ing “annual” and inserting “biennial”; and

14 (2) in subsection (e), by striking “annual” and  
15 inserting “biennial”.

16 (f) STRATEGIC PLANS.—Section 2802 of title 39,  
17 United States Code, is amended—

18 (1) in subsection (a), by striking “September  
19 30, 1997” and inserting “September 30, 2010”;

20 (2) in subsection (b), by striking “at least every  
21 three years” and inserting “at least every 4 years”;

22 (3) by striking “five years forward” and insert-  
23 ing “six years forward”; and

24 (4) in subsection (c), by inserting a comma  
25 after “section” the second place it appears and in-

1       serting “including a strategic plan submitted by  
2       September 30, 2010, meeting the requirements of  
3       subsection (a)”.

4       (g) PERFORMANCE PLANS.—Section 2803(a) of title  
5 39, United States Code, is amended—

6           (1) in the matter before paragraph (1), by  
7       striking “an annual” and inserting “a biennial”;

8           (2) in paragraph (1), by inserting after “pro-  
9       gram activity” the following: “for both years 1 and  
10      2 of the biennial plan”;

11          (3) in paragraph (5), by striking “and” after  
12      the semicolon;

13          (4) in paragraph (6), by striking the period and  
14      inserting “; and”; and

15          (5) by adding after paragraph (6) the following:

16           “(7) cover each fiscal year of the biennium be-  
17      ginning with the first fiscal year of the next biennial  
18      budget cycle.”.

19       (h) COMMITTEE VIEWS OF PLANS AND REPORTS.—

20      Section 301(d) of the Congressional Budget Act (2 U.S.C.

21      632(d)) is amended by adding at the end “Each committee

22      of the Senate or the House of Representatives shall review

23      the strategic plans, performance plans, and performance

24      reports, required under section 306 of title 5, United

25      States Code, and sections 1115 and 1116 of title 31,

1 United States Code, of all agencies under the jurisdiction  
2 of the committee. Each committee may provide its views  
3 on such plans or reports to the Committee on the Budget  
4 of the applicable House.”.

5 (i) EFFECTIVE DATE.—

6 (1) IN GENERAL.—The amendments made by  
7 this section shall take effect on March 1, 2011.

8 (2) AGENCY ACTIONS.—Effective on and after  
9 the date of enactment of this Act, each agency shall  
10 take such actions as necessary to prepare and sub-  
11 mit any plan or report in accordance with the  
12 amendments made by it.

13 **SEC. 9. BIENNIAL APPROPRIATION BILLS.**

14 (a) IN THE HOUSE OF REPRESENTATIVES.—(1)  
15 Clause 2(a) of rule XXI of the Rules of the House of Rep-  
16 resentatives is amended by adding at the end the following  
17 new subparagraph:

18 “(3)(A) Except as provided by subdivision (B), an ap-  
19 propriation may not be reported in a general appropriation  
20 bill (other than a supplemental appropriation bill), and  
21 may not be in order as an amendment thereto, unless it  
22 provides new budget authority or establishes a level of ob-  
23 ligations under contract authority for each fiscal year of  
24 a biennium.

1 “(B) Subdivision (A) does not apply with respect to  
2 an appropriation for a single fiscal year for any program,  
3 project, or activity if the bill or amendment thereto con-  
4 taining that appropriation includes a provision expressly  
5 stating the following: ‘Congress finds that no additional  
6 funding beyond one fiscal year will be required and the  
7 [Insert name of applicable program, project, or activity]  
8 will be completed or terminated after the amount provided  
9 has been expended.’.

10 “(C) For purposes of paragraph (b), the statement  
11 set forth in subdivision (B) with respect to an appropria-  
12 tion for a single fiscal year for any program, project, or  
13 activity may be included in a general appropriation bill  
14 or amendment thereto.”.

15 (2) Clause 5(b)(1) of rule XXII of the House of Rep-  
16 resentatives is amended by striking “or (c)” and inserting  
17 “or (3) or 2(c)”.

18 (b) IN THE SENATE.—(1) Title III of the Congres-  
19 sional Budget Act of 1974 (2 U.S.C. 631 et seq.) is  
20 amended by adding at the end the following:

21 “CONSIDERATION OF BIENNIAL APPROPRIATION BILLS

22 “SEC. 317. It shall not be in order in the Senate in  
23 any odd-numbered year to consider any regular appropria-  
24 tion bill providing new budget authority or a limitation  
25 on obligations under the jurisdiction of the Committee on  
26 Appropriations for only the first fiscal year of a biennium,

1 unless the program, project, or activity for which the new  
 2 budget authority or obligation limitation is provided will  
 3 require no additional authority beyond one year and will  
 4 be completed or terminated after the amount provided has  
 5 been expended.”.

6 (2) The table of contents set forth in section 1(b) of  
 7 the Congressional Budget and Impoundment Control Act  
 8 of 1974 is amended by adding after the item relating to  
 9 section 316 the following new item:

“Sec. 317. Consideration of biennial appropriation bills.”.

10 **SEC. 10. ASSISTANCE BY FEDERAL AGENCIES TO STANDING**  
 11 **COMMITTEES OF THE SENATE AND THE**  
 12 **HOUSE OF REPRESENTATIVES.**

13 (a) INFORMATION REGARDING AGENCY APPROPRIA-  
 14 TIONS REQUESTS.—To assist each standing committee of  
 15 the House of Representatives and the Senate in carrying  
 16 out its responsibilities, the head of each Federal agency  
 17 which administers the laws or parts of laws under the ju-  
 18 risdiction of such committee shall provide to such com-  
 19 mittee such studies, information, analyses, reports, and  
 20 assistance as may be requested by the chairman and rank-  
 21 ing minority member of the committee.

22 (b) INFORMATION REGARDING AGENCY PROGRAM  
 23 ADMINISTRATION.—To assist each standing committee of  
 24 the House of Representatives and the Senate in carrying  
 25 out its responsibilities, the head of any agency shall fur-

1 nish to such committee documentation, containing infor-  
2 mation received, compiled, or maintained by the agency  
3 as part of the operation or administration of a program,  
4 or specifically compiled pursuant to a request in support  
5 of a review of a program, as may be requested by the  
6 chairman and ranking minority member of such com-  
7 mittee.

8 (c) SUMMARIES BY COMPTROLLER GENERAL.—With-  
9 in thirty days after the receipt of a request from a chair-  
10 man and ranking minority member of a standing com-  
11 mittee having jurisdiction over a program being reviewed  
12 and studied by such committee under this section, the  
13 Comptroller General of the United States shall furnish to  
14 such committee summaries of any audits or reviews of  
15 such program which the Comptroller General has com-  
16 pleted during the preceding six years.

17 (d) CONGRESSIONAL ASSISTANCE.—Consistent with  
18 their duties and functions under law, the Comptroller Gen-  
19 eral of the United States, the Director of the Congres-  
20 sional Budget Office, and the Director of the Congres-  
21 sional Research Service shall continue to furnish (con-  
22 sistent with established protocols) to each standing com-  
23 mittee of the House of Representatives or the Senate such  
24 information, studies, analyses, and reports as the chair-  
25 man and ranking minority member may request to assist

1 the committee in conducting reviews and studies of pro-  
2 grams under this section.

3 **SEC. 11. REPORT ON TWO-YEAR FISCAL PERIOD.**

4 Not later than 180 days after the date of enactment  
5 of this Act, the Director of the Office of Management and  
6 Budget shall—

7 (1) determine the impact and feasibility of  
8 changing the definition of a fiscal year and the  
9 budget process based on that definition to a 2-year  
10 fiscal period with a biennial budget process based on  
11 the 2-year period; and

12 (2) report the findings of the study to the Com-  
13 mittees on the Budget of the House of Representa-  
14 tives and the Senate and the Committee on Rules of  
15 the House of Representatives.

16 **SEC. 12. SPECIAL TRANSITION PERIOD FOR THE 110TH**  
17 **CONGRESS.**

18 (a) **PRESIDENT'S BUDGET SUBMISSION FOR FISCAL**  
19 **YEAR 2010.**—The budget submission of the President  
20 pursuant to section 1105(a) of title 31, United States  
21 Code, for fiscal year 2010 shall include the following:

22 (1) An identification of the budget accounts for  
23 which an appropriation should be made for each fis-  
24 cal year of the fiscal year 2010–2011 biennium.

1           (2) Budget authority that should be provided  
2           for each such fiscal year for the budget accounts  
3           identified under paragraph (1).

4           (b) REVIEW AND RECOMMENDATIONS OF THE COM-  
5 MITTEES ON APPROPRIATIONS.—The Committee on Ap-  
6 propriations of the House of Representatives and the Sen-  
7 ate shall review the items included pursuant to subsection  
8 (a) in the budget submission of the President for fiscal  
9 year 2010 and include its recommendations thereon in its  
10 views and estimates made under section 301(d) of the  
11 Congressional Budget Act of 1974 within 6 weeks of that  
12 budget submission.

13           (c) ACTIONS BY THE COMMITTEES ON THE BUDG-  
14 ET.—(1) The Committee on the Budget of the House of  
15 Representatives and the Senate shall review the items in-  
16 cluded pursuant to subsection (a) in the budget submis-  
17 sion of the President for fiscal year 2010 and the rec-  
18 ommendations submitted by the Committee on Appropria-  
19 tions of its House pursuant to subsection (b) included in  
20 its views and estimates made under section 301(d) of the  
21 Congressional Budget Act of 1974.

22           (2) The report of the Committee on the Budget of  
23 each House accompanying the concurrent resolution on  
24 the budget for fiscal year 2010 and the joint explanatory  
25 statement of managers accompanying such resolution shall

1 also include allocations to the Committee on Appropria-  
2 tions of its House of total new budget authority and total  
3 outlays (which shall be deemed to be made pursuant to  
4 section 302(a) of the Congressional Budget Act of 1974  
5 for purposes of budget enforcement under section 302(f))  
6 for fiscal year 2011 from which the Committee on Appro-  
7 priations may report regular appropriation bills for fiscal  
8 year 2010 that include funding for certain accounts for  
9 each of fiscal years 2010 and 2011.

10 (3) The report of the Committee on the Budget of  
11 each House accompanying the concurrent resolution on  
12 the budget for fiscal year 2010 and the joint explanatory  
13 statement of managers accompanying such resolution shall  
14 also include the assumptions upon which such allocations  
15 referred to in paragraph (2) are based.

16 (d) GAO PROGRAMMATIC OVERSIGHT ASSIST-  
17 ANCE.—(1) During the first session of the 110th Congress  
18 the committees of the House of Representatives and the  
19 Senate are directed to work with the Comptroller General  
20 of the United States to develop plans to transition pro-  
21 gram authorizations to a multi-year schedule.

22 (2) During the 110th Congress, the Comptroller Gen-  
23 eral of the United States will continue to provide assist-  
24 ance to the Congress with respect to programmatic over-  
25 sight and in particular will assist the committees of Con-

1 gress in designing and conforming programmatic oversight  
2 procedures for the fiscal year 2010–2011 biennium.

3 (e) CBO AUTHORIZATION REPORT.—On or before  
4 January 15, 2010, the Director of the Congressional  
5 Budget Office, after consultation with the appropriate  
6 committees of the House of Representatives and Senate,  
7 shall submit to the Congress a report listing (A) all pro-  
8 grams and activities funded during fiscal year 2010 for  
9 which authorizations for appropriations have not been en-  
10 acted for that fiscal year and (B) all programs and activi-  
11 ties funded during fiscal year 2010 for which authoriza-  
12 tions for appropriations will expire during that fiscal year,  
13 fiscal year 2011, or fiscal year 2012.

14 (f) PRESIDENT’S BUDGET SUBMISSION FOR FISCAL  
15 YEAR 2011.—The budget submission of the President  
16 pursuant to section 1105(a) of title 31, United States  
17 Code, for fiscal year 2011 shall include an evaluation of,  
18 and recommendations regarding, the transitional biennial  
19 budget process for the fiscal year 2010–2011 biennium  
20 that was carried out pursuant to this section.

21 (g) CBO TRANSITIONAL REPORT.—On or before  
22 March 31, 2010, the Director of the Congressional Budget  
23 Office shall submit to Congress an evaluation of, and rec-  
24 ommendations regarding, the transitional biennial budget

1 process for the fiscal year 2010–2011 biennium that was  
2 carried out pursuant to this section.

3 **SEC. 13. EFFECTIVE DATE.**

4 Except as provided by sections 8, 11, and 12, this  
5 Act and the amendments made by it shall take effect on  
6 January 1, 2011, and shall apply to budget resolutions  
7 and appropriations for the biennium beginning with fiscal  
8 year 2010.
