A BILL

1 **SECTION 1. PROHIBITION ON COLLECTION OF COPAY-**
2 **MENTS FOR ALL HOSPICE CARE FURNISHED**
3 **BY DEPARTMENT OF VETERANS AFFAIRS.**

4 Section 1710B(c)(2) of title 38, United States Code
5 is amended by striking subparagraph (B) and inserting
6 after subparagraph (A) the following new subparagraph
7 (B):

8 “(B) to a veteran being furnished inpatient or
9 outpatient hospice care by the Department; or”.

10 **SECTION 1. PROHIBITION ON COLLECTION OF COPAY-**
11 **MENTS FOR ALL HOSPICE CARE FURNISHED**
12 **BY DEPARTMENT OF VETERANS AFFAIRS.**

13 *Title 38, United States Code, is amended—*

14 (1) *in section 1710(f)(1), by inserting “(except if*
15 *such care constitutes hospice care)” after “nursing*
16 *home care”;*

17 (2) *in section 1710(g)(1), by inserting ““(except*
18 *if such services constitute hospice care)” after “med-*
19 *ical services”; and*

20 (3) *in section 1710B(c)(2), by striking subpara-*
21 *graph (B) and inserting after subparagraph (A) the*
22 *following new subparagraph (B):*

23 “(B) to a veteran being furnished inpatient or
24 outpatient hospice care by the Department; or”.
