## AN ACT

To establish the Thomas Edison National Historical Park  
in the State of New Jersey as the successor to the  
Edison National Historic Site.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Act Commemorating  
3 the LITE, or Lifetime Innovations of Thomas Edison”.

4 **SEC. 2. FINDINGS AND PURPOSE.**

5 (a) FINDINGS.—Congress finds the following:

6 (1) The Edison National Historic Site, located  
7 in West Orange, New Jersey, is a vital part of  
8 America’s national system of parks which preserves  
9 Thomas Alva Edison’s research and development  
10 laboratories, library, papers, and artifacts, as well as  
11 his home.

12 (2) The Site is a national historic treasure and  
13 contains the world’s largest collection of materials  
14 related to Thomas Edison, encompassing an esti-  
15 mated 5,000,000 pages of documents, over 400,000  
16 artifacts, approximately 35,000 sound recordings,  
17 and 10,000 books from Edison’s personal library.

18 (3) Thomas Edison is one of America’s greatest  
19 inventors, whose inexhaustible energy and genius  
20 produced 1,093 patents in his lifetime, more than  
21 any other American, including patents for the incan-  
22 descent light bulb, the motion picture camera, and  
23 the phonograph.

24 (4) In 1928, Thomas Edison was awarded the  
25 Congressional Gold Medal for the “development and

1 application of inventions that have revolutionized  
2 civilization in the last century.”

3 (5) In 1998, Congress again honored Thomas  
4 Edison by directing the Secretary of the Treasury to  
5 mint a commemorative coin celebrating the 125th  
6 anniversary of Edison’s invention of the light bulb,  
7 celebrated in 2004.

8 (6) The Edison National Historic Site is one of  
9 America’s most endangered historic places. The Na-  
10 tional Park Service, in its General Management Plan  
11 and Development Concept Plan, identified the need  
12 for numerous actions to preserve, protect, restore,  
13 and enhance the Site and determined that sufficient  
14 government funds are not likely to be appropriated  
15 to complete these necessary actions in the foresee-  
16 able future.

17 (7) On November 6, 1997, the National Park  
18 Service signed an agreement with the Thomas Alva  
19 Edison Preservation Foundation (now the Edison  
20 Preservation Foundation), establishing a public-pri-  
21 vate partnership to jointly raise money to fund iden-  
22 tified improvements at the Edison National Historic  
23 Site so as to leave the Site unimpaired for the enjoy-  
24 ment of future generations.

25 (b) PURPOSES.—The purposes of this Act are—

1           (1) to recognize and pay tribute to Thomas  
2           Alva Edison and his innovations; and

3           (2) to preserve, protect, restore, and enhance  
4           the Edison National Historic Site to ensure public  
5           use and enjoyment of the Site as an educational, sci-  
6           entific, and cultural center.

7 **SEC. 3. THOMAS EDISON NATIONAL HISTORICAL PARK.**

8           (a) ESTABLISHMENT.—There is established the  
9           Thomas Edison National Historical Park as a unit of the  
10          National Park System (hereafter the “Historical Park”).

11          (b) BOUNDARIES.—The Historical Park shall be com-  
12          prised of—

13               (1) all property owned by the United States in  
14               the Edison National Historic Site as well as all  
15               property authorized to be acquired by the Secretary  
16               of the Interior for inclusion in the Edison National  
17               Historic Site before the date of the enactment of  
18               this Act, as generally depicted on the map entitled  
19               the “Edison National Historic Site”, numbered  
20               20003B, and dated April 1977; and

21               (2) all property authorized to be acquired for  
22               inclusion in the Historical Park by this Act or other  
23               law enacted after the date of the enactment of this  
24               Act.

1           (c) MAP.—The map of the Historical Park shall be  
2 on file and available for public inspection in the appro-  
3 priate offices of the National Park Service.

4 **SEC. 4. ADMINISTRATION.**

5           (a) IN GENERAL.—The Secretary shall administer  
6 the Historical Park in accordance with this Act and with  
7 the provisions of law generally applicable to units of the  
8 National Park System, including the Acts entitled “An  
9 Act to establish a National Park Service, and for other  
10 purposes,” approved August 25, 1916 (39 Stat. 535; 16  
11 U.S.C. 1 et seq.) and “An Act to provide for the preserva-  
12 tion of historic American sites, buildings, objects, and an-  
13 tiquities of national significance, and for other purposes,”  
14 approved August 21, 1935 (16 U.S.C. 461 et seq.).

15           (b) ACQUISITION OF PROPERTY.—

16           (1) REAL PROPERTY.—The Secretary may ac-  
17 quire land or interests in land within the boundaries  
18 of the Historical Park, from willing sellers only, by  
19 donation, purchase with donated or appropriated  
20 funds, or exchange.

21           (2) PERSONAL PROPERTY.—The Secretary may  
22 acquire personal property associated with, and ap-  
23 propriate for, interpretation of the Historical Park.

24           (c) COOPERATIVE AGREEMENTS.—The Secretary  
25 may consult and enter into cooperative agreements with

1 interested entities and individuals to provide for the pres-  
2 ervation, development, interpretation, and use of the His-  
3 torical Park.

4 (d) REPEAL OF SUPERSEDED LAW.—Public Law 87–  
5 628 (76 Stat. 428), regarding the establishment and ad-  
6 ministration of the Edison National Historic Site, is re-  
7 pealed.

8 (e) REFERENCES.—Any reference in a law, map, reg-  
9 ulation, document, paper, or other record of the United  
10 States to the “Edison National Historic Site” shall be  
11 deemed to be a reference to the “Thomas Edison National  
12 Historical Park”.

13 **SEC. 5. AUTHORIZATION OF APPROPRIATIONS.**

14 There is authorized to be appropriated such sums as  
15 may be necessary to carry out this Act.
