## A BILL

To amend title XVIII of the Social Security Act to provide a wage index floor for hospitals and home health agencies located in certain areas under the Medicare Program.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FLOOR ON MEDICARE AREA WAGE INDEX FOR**  
4 **HOSPITALS AND HOME HEALTH AGENCIES**  
5 **LOCATED IN CERTAIN AREAS.**

6 (a) IN GENERAL.—Section 1886(d)(3)(E) of the So-  
7 cial Security Act (42 U.S.C. 1395ww(d)(3)(E)) is amend-  
8 ed by adding at the end the following new clause:

1           “(iii) FISCAL YEAR 2007 FLOOR FOR CER-  
2 TAIN AREAS.—

3           “(I) IN GENERAL.—Notwithstanding  
4 clause (i), in no case shall the area wage  
5 index for a hospital located in an area de-  
6 scribed in subclause (II) for discharges oc-  
7 ccurring on or after October 1, 2007, be  
8 less than the area wage index applicable to  
9 such hospital during fiscal year 2007.

10           “(II) AREA DESCRIBED.—An area de-  
11 scribed in this subclause is a rural area  
12 where at least 65 percent of the wages  
13 paid by all subsection (d) hospitals located  
14 in such area on October 1, 2006, not tak-  
15 ing into account reclassifications or redес-  
16 ignations under paragraph (8) or (10), is  
17 attributable to wages paid by one hospital.

18           “(III) TREATMENT AS RECLASSIFICA-  
19 TION FOR BUDGET NEUTRALITY.—Sub-  
20 clause (I) shall be treated as a decision of  
21 the Medicare Geographic Reclassification  
22 Review Board under paragraph (10).”.

23           (b) RURAL FLOOR FOR HOME HEALTH AGENCIES  
24 LOCATED IN URBAN AREAS.—

1           (1) IN GENERAL.—Section 1895(b)(4)(C) of  
2 such Act (42 U.S.C. 1395fff(b)(4)(C)) is amended  
3 by adding at the end the following: “In no case shall  
4 the area wage index for a home health agency lo-  
5 cated in an urban area in New Hampshire be less  
6 than the area wage index for a rural area in such  
7 State.”.

8           (2) EFFECTIVE DATE.—The amendment made  
9 by paragraph (1) shall apply to payment for episodes  
10 and visits ending on or after January 1, 2008.
