## CONCURRENT RESOLUTION

Providing for an adjournment of the House from Thursday, February 10, 1994, through Friday, February 18, 1994, to Tuesday, February 22, 1994 and an adjournment or recess of the Senate from Thursday, February 10, 1994, through Friday, February 18, 1994, to Tuesday, February 22, 1994.

1        *Resolved by the House of Representatives (the Senate*  
2 *concurring)*, That when the House adjourns on Thursday,  
3 February 10, 1994, Friday, February 11, 1994, Saturday,  
4 February 12, 1994, Sunday, February 13, 1994, Monday,  
5 February 14, 1994, Tuesday, February 15, 1994,  
6 Wednesday, February 16, 1994, Thursday, February 17,  
7 1994, or Friday, February 18, 1994, pursuant to a motion  
8 made by the Majority Leader or his designee, it stand ad-  
9 journed until 2 p.m. on Tuesday, February 22, 1994, or  
10 until noon on the second day after Members are notified

1 to reassemble pursuant to section 2 of this concurrent res-  
2 olution, whichever occurs first; and that when the Senate  
3 recesses or adjourns at the close of business on Thursday,  
4 February 10, 1994, Friday, February 11, 1994, Saturday,  
5 February 12, 1994, Sunday, February 13, 1994, Monday,  
6 February 14, 1994, Tuesday, February 15, 1994,  
7 Wednesday, February 16, 1994, Thursday, February 17,  
8 1994, or Friday, February 18, 1994, pursuant to a motion  
9 made by the Majority Leader or his designee, in accord-  
10 ance with this resolution, it stand recessed or adjourned  
11 until noon on Tuesday, February 22, 1994, or at such  
12 time as may be specified by the Majority Leader or his  
13 designee in the motion to recess or adjourn, or until noon  
14 on the second day after Members are notified to reassem-  
15 ble pursuant to section 2 of this concurrent resolution,  
16 whichever occurs first.

17 SEC. 2. The Speaker of the House and the Majority  
18 Leader of the Senate, acting jointly after consultation with  
19 the Minority Leader of the House and the Minority Lead-  
20 er of the Senate, shall notify the Members of the House  
21 and the Senate, respectively, to reassemble whenever, in  
22 their opinion, the public interest shall warrant it.
