Police.

Mr. TRAFICANT submitted the following concurrent resolution; which was
referred to the Committee on Rules

CONCURRENT RESOLUTION

Establishing the Ad Hoc Joint Committee on Labor
Relations for the Capitol Police.

1 *Resolved by the House of Representatives (the Senate*
2 *concurring),*

3 **SECTION 1. ESTABLISHMENT OF JOINT COMMITTEE.**

4 There is established a joint committee of the Con-
5 gress to be known as the “Ad Hoc Joint Committee on
6 Labor Relations for the Capitol Police” (hereafter in this
7 resolution referred to as the “committee”). The committee
8 shall consist of (1) three Senators appointed by the Presi-
9 dent pro tempore of the Senate, (2) two Senators ap-
10 pointed by the minority leader of the Senate, (3) three

1 Members of the House of Representatives appointed by
2 the Speaker of the House of Representatives, and (4) two
3 Members of the House of Representatives appointed by
4 the minority leader of the House of Representatives.

5 **SEC. 2. DUTIES OF THE COMMITTEE.**

6 The committee shall formulate a labor relations pro-
7 gram for the Capitol Police. The program shall be—

8 (1) based on progressive principles and prac-
9 tices of labor relations programs in the public and
10 private sectors;

11 (2) sensitive to the needs of the Congress; and

12 (3) designed to promote the efficient and effec-
13 tive operation of the Capitol Police.

14 **SEC. 3. REPORT AND AMENDMENTS TO RULES.**

15 (a) REPORT.—Not later than one hundred and eighty
16 days after this resolution is agreed to by the House of
17 Representatives and the Senate, the committee shall re-
18 port its proposed labor relations program to the House
19 of Representatives and the Senate.

20 (b) AMENDMENTS TO RULES.—The report shall
21 present the program in the form of recommended amend-
22 ments to the Rules of the House of Representatives and
23 the Standing Rules of the Senate. The recommended
24 amendments shall be deemed agreed to by the House of
25 Representatives and the Senate, respectively, thirty legis-

1 lative days after the committee reports under subsection
2 (a), except to the extent that the recommended amend-
3 ments are rejected or amended by the House of Represent-
4 atives or the Senate.

5 **SEC. 4. EXPIRATION OF COMMITTEE.**

6 The committee shall cease to exist thirty days after
7 the submission of the report under section 3.

8 **SEC. 5. DEFINITION.**

9 As used in this resolution, the term “Member of the
10 House of Representatives” means a Representative in, or
11 a Delegate or Resident Commissioner to, the Congress.
