JOINT RESOLUTION

Proposing an amendment to the Constitution of the United States providing for 4-year terms for Members of the House of Representatives.

1 *Resolved by the Senate and House of Representatives*
2 *of the United States of America in Congress assembled (two-*
3 *thirds of each House concurring therein), That the follow-*
4 *ing article is proposed as an amendment to the Constitu-*
5 *tion of the United States, to be valid only if ratified by*
6 *the legislatures of three-fourths of the several States with-*

1 in 7 years after the date of final passage of this joint reso-
2 lution:

3 “ARTICLE—

4 “SECTION 1. The House of Representatives shall be
5 composed of Members chosen by the people of the several
6 States, and the electors in each State shall have the quali-
7 fications requisite for electors of the most numerous
8 branch of the State legislature. The term of office of Rep-
9 resentatives shall be 4 years, except that in the case of
10 Representatives elected from odd-numbered districts the
11 term of office of the first incumbents elected following a
12 reapportionment of Representatives shall be 2 years and
13 in the case of Representatives elected from even-numbered
14 districts the term of office of the last incumbents elected
15 before a reapportionment of Representatives shall be 2
16 years.

17 “SECTION 2. Districts for the election of Representa-
18 tives from each State, whether composed of the whole or
19 a part thereof, shall be numbered consecutively, beginning
20 with the first, and corresponding to the number of Rep-
21 resentatives to which such State is entitled.

22 “SECTION 3. Section 1 of this article shall apply with
23 respect to terms of office of Representatives beginning
24 after the first reapportionment of Representatives after
25 the ratification of this article.

1 “SECTION 4. A Representative who officially declares
2 candidacy for another elected office of which the term be-
3 gins before the end of that Representative’s term of office
4 as Representative shall resign from the office of Rep-
5 resentative at the time of the declaration.

6 “SECTION 5. The Congress shall have the power to
7 enforce this article by appropriate legislation.”.
