A BILL

To extend until January 1, 1995, the suspension of duties on certain chemicals.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SUSPENSION OF DUTIES ON CERTAIN CHEMI-**

4 **CALS.**

5 Subchapter II of chapter 99 of the Harmonized Tar-

18 **SEC. 2. APPLICABILITY.**

19 (a) IN GENERAL.—The amendments made by section
20 1 shall apply with respect to goods entered, or withdrawn
21 from warehouse for consumption, on or after the 15th day
22 after the date of the enactment of this Act.

23 (b) RETROACTIVE PROVISION.—Notwithstanding sec-
24 tion 514 of the Tariff Act of 1930 or any other provision
25 of law to the contrary, upon a request filed with the appro-

1 priate customs officer before the 90th day after the date
2 of the enactment of this Act, any entry or withdrawal from
3 warehouse for consumption of goods to which any amend-
4 ment made by section 1 applies and that was made—

5 (1) after December 31, 1992; and

6 (2) before the 15th day after the date of the en-
7 actment of this Act;

8 and with respect to which there would have been a lower
9 duty if the amendment made by section 1 had applied to
10 such entry or withdrawal, shall be liquidated or
11 reliquidated as though such entry or withdrawal had oc-
12 curred on such 15th day.
