1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. EXTENSION OF EXISTING SUSPENSION OF**
4 **DUTY ON CERTAIN BICYCLE PARTS.**

7 ing “12/31/92” and inserting “12/31/97”:

6 **SEC. 2. RENEWAL OF EXISTING CUSTOMS EXEMPTION AP-**
7 **PLICABLE TO BICYCLE PARTS IN FOREIGN**
8 **TRADE ZONES.**

9 Section 3(b) of the Act of June 18, 1934 (commonly
10 known as the Foreign Trade Zones Act) (19 U.S.C.
11 81c(b)) is amended by striking “December 31, 1992” and
12 inserting “December 31, 1997”.

13 **SEC. 3. EFFECTIVE DATE.**

14 (a) **IN GENERAL.**—Except as provided in subsection
15 (b), the amendments made by this Act apply with respect
16 to goods entered, or withdrawn from warehouse for con-
17 sumption, on or after the 15th day after the date of the
18 enactment of this Act.

19 (b) **RETROACTIVE PROVISION.**—Notwithstanding sec-
20 tion 514 of the Tariff Act of 1930 or any other provision
21 of law to the contrary, upon a request filed with the appro-
22 priate customs officer before the 195th day after the date
23 of the enactment of this Act, any entry or withdrawal from
24 warehouse for consumption of goods to which any amend-
25 ment made by this Act applies and that was made—

1 (1) after December 31, 1992; and

2 (2) before the 15th day after the date of the en-

3 actment of this Act;

4 and with respect to which there would have been a lower

5 duty if the amendment made by this Act had applied to

6 such entry or withdrawal, shall be liquidated or

7 reliquidated as though the amendments made by sections

8 1 and 2 applied to such entry or withdrawal.
