AN ACT

To validate conveyances of certain lands in the State of California that form part of the right-of-way granted by the United States to the Central Pacific Railway Company.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Railroad Right-of-Way
5 Conveyance Validation Act”.

1 **SEC. 2. VALIDATION OF CONVEYANCES.**

2 Except as provided in section 5, the conveyances de-
3 scribed in section 3 (involving certain lands in Nevada
4 County, State of California) and section 4 (involving cer-
5 tain lands in San Joaquin County, State of California)
6 concerning lands that form parts of the right-of-way
7 granted by the United States to the Central Pacific Rail-
8 way Company in the Act entitled "An Act to aid in the
9 Construction of a Railroad and Telegraph Line from the
10 Missouri River to the Pacific Ocean, and to secure to the
11 Government the Use of the same for Postal, Military, and
12 Other Purposes", approved July 1, 1862 (12 Stat. 489),
13 hereby are legalized, validated, and confirmed, as far as
14 any interest of the United States in such lands is con-
15 cerned, with the same force and effect as if the land in-
16 volved in each such conveyance had been held, on the date
17 of such conveyance, under absolute fee simple title by the
18 grantor of such land.

19 **SEC. 3. CONVEYANCES OF LANDS IN NEVADA COUNTY,**
20 **STATE OF CALIFORNIA.**

17 **SEC. 5. LIMITATIONS ON VALIDATION OF CONVEYANCES.**

18 (a) SCOPE.—Nothing in this Act shall be construed
19 to—

20 (1) diminish the right-of-way referred to in sec-
21 tion 2 to a width of less than fifty feet on each side
22 of the center of the main track or tracks maintained
23 by the Southern Pacific Transportation Company on
24 the date of enactment of this Act;

1 (2) legalize, validate, or confirm, with respect to
2 any land that is the subject of a conveyance referred
3 to in section 3 or 4, any right or title to, or interest
4 in, such land arising out of adverse possession, pre-
5 scription, or abandonment, and not confirmed by
6 such conveyance; or

7 (b) MINERALS.—(1) The United States hereby re-
8 serves any federally-owned minerals that may exist in land
9 that is conveyed pursuant to section 2 of this Act, includ-
10 ing the right of the United States, its assignees or lessees,
11 to enter upon and utilize as much of the surface of said
12 land as is necessary to remove minerals under the laws
13 of the United States.

14 (2) Any and all minerals reserved by paragraph (1)
15 are hereby withdrawn from all forms of entry, appropria-
16 tion, and patent under the mining, mineral leasing, and
17 geothermal leasing laws of the United States.
