To extend until January 1, 1995, the existing suspension

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. EXTENSION OF EXISTING SUSPENSION OF**

4 **DUTY ON CERTAIN CHEMICALS.**

18 **SEC. 2. APPLICABILITY.**

19 (a) IN GENERAL.—The amendments made by section
20 1 of this Act shall take effect on the 15th day after the
21 date of the enactment of this Act.

22 (b) RETROACTIVE PROVISION.—Notwithstanding sec-
23 tion 514 of the Tariff Act of 1930 or any other provision
24 of law to the contrary, upon a request filed with the appro-
25 priate customs officer before the 90th day after the date

1 of the enactment of this Act, any entry or withdrawal from
2 warehouse for consumption of goods to which the amend-
3 ment made by section 1 applies and that was made—

4 (1) after December 31, 1992; and

5 (2) before the 15th day after the date of the en-
6 actment of this Act;

7 and with respect to which there would have been a lower
8 duty if the amendment made by section 1 had applied to
9 such entry or withdrawal, shall be liquidated or
10 reliquidated as though such entry or withdrawal had oc-
11 curred on such 15th day.
