AN ACT

To make boundary adjustments and other miscellaneous changes to authorities and programs of the National Park Service.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Minor Boundary Ad-
5 justments and Miscellaneous Park Amendments Act of
6 1993”.

1 **TITLE I—MINOR BOUNDARY**
2 **ADJUSTMENTS**

3 **SEC. 101. YUCCA HOUSE NATIONAL MONUMENT BOUNDARY**
4 **ADJUSTMENT.**

5 (a) **IN GENERAL.**—The boundaries of Yucca House
6 National Monument are revised to include the approxi-
7 mately 24.27 acres of land generally depicted on the map
8 entitled “Boundary—Yucca House National Monument,
9 Colorado”, numbered 318/80,001-B, and dated February
10 1990.

11 (b) **MAP.**—The map referred to in subsection (a)
12 shall be on file and available for public inspection in
13 appropriate offices of the National Park Service of the
14 Department of the Interior.

15 (c) **ACQUISITION BY DONATION.**—(1) Within the
16 lands described in subsection (a), the Secretary of the
17 Interior may acquire lands and interests in lands by
18 donation.

19 (2) The Secretary of the Interior may pay adminis-
20 trative costs arising out of any donation described in para-
21 graph (1) with appropriated funds.

22 **SEC. 102. ZION NATIONAL PARK BOUNDARY ADJUSTMENT.**

23 (a) **ACQUISITION AND BOUNDARY CHANGE.**—The
24 Secretary of the Interior is authorized to acquire by ex-
25 change approximately 5.48 acres located in the SW¹/₄ of

1 Section 28, Township 41 South, Range 10 West, Salt
2 Lake Base and Meridian. In exchange therefor the Sec-
3 retary is authorized to convey all right, title, and interest
4 of the United States in and to approximately 5.51 acres
5 in Lot 2 of Section 5, Township 41 South, Range 11 West,
6 both parcels of land being in Washington County, Utah.
7 Upon completion of such exchange, the Secretary is au-
8 thorized to revise the boundary of Zion National Park to
9 add the 5.48 acres in Section 28 to the park and to ex-
10 clude the 5.51 acres in Section 5 from the park. Land
11 added to the park shall be administered as part of the
12 park in accordance with the laws and regulations applica-
13 ble thereto.

14 (b) EXPIRATION.—The authority granted by this sec-
15 tion shall expire two years after the date of the enactment
16 of this Act.

17 **SEC. 103. PICTURED ROCKS NATIONAL LAKESHORE**
18 **BOUNDARY ADJUSTMENT.**

19 The boundary of Pictured Rocks National Lakeshore
20 is hereby modified as depicted on a map entitled “Area
21 Proposed for Addition to Pictured Rocks National Lake-
22 shore”, numbered 625–80, 043A and dated July 1992.

1 **SEC. 104. INDEPENDENCE NATIONAL HISTORICAL PARK**
2 **BOUNDARY ADJUSTMENT.**

3 The administrative boundary between Independence
4 National Historical Park and the United States Customs
5 House along the Moravian Street Walkway in Philadel-
6 phia, Pennsylvania, is hereby modified as generally de-
7 picted on the drawing entitled “Exhibit 1, Independence
8 National Historical Park, Boundary Adjustment”, and
9 dated May 1987, which shall be on file and available for
10 public inspection in the Office of the National Park Serv-
11 ice, Department of the Interior. The Secretary of the Inte-
12 rior is authorized to accept and transfer jurisdiction over
13 property in accord with such administrative boundary, as
14 modified by this section.

15 **SEC. 105. CRATERS OF THE MOON NATIONAL MONUMENT**
16 **BOUNDARY ADJUSTMENT.**

17 (a) BOUNDARY REVISION.—The boundary of Craters
18 of the Moon National Monument, Idaho, is revised to add
19 approximately 210 acres and to delete approximately 315
20 acres as generally depicted on the map entitled “Craters
21 of the Moon National Monument, Idaho, Proposed 1987
22 Boundary Adjustment”, numbered 131–80,008, and dated
23 October 1987, which map shall be on file and available
24 for public inspection in the Office of the National Park
25 Service, Department of the Interior.

1 (b) ADMINISTRATION; ACQUISITION.—Federal lands,
2 waters, and interests therein deleted from the boundary
3 of the national monument by this section shall be adminis-
4 tered by the Secretary of the Interior through the Bureau
5 of Land Management in accordance with the Federal
6 Land Policy and Management Act of 1976 (43 U.S.C.
7 1701 et seq.); and Federal lands, waters, and interests
8 therein added to the national monument by this section
9 shall be administered by the Secretary as part of the na-
10 tional monument, subject to the laws and regulations ap-
11 plicable thereto. The Secretary is authorized to acquire
12 private lands, waters, and interests therein within the
13 boundary of the national monument by donation, purchase
14 with donated or appropriated funds, or exchange, and
15 when acquired they shall be administered by the Secretary
16 as part of the national monument, subject to the laws and
17 regulations applicable thereto.

18 **SEC. 106. HAGERMAN FOSSIL BEDS NATIONAL MONUMENT**

19 **BOUNDARY ADJUSTMENT.**

20 Section 302 of the Arizona-Idaho Conservation Act
21 of 1988 (102 Stat. 4576) is amended by adding the follow-
22 ing new subsection:

23 “(d) To further the purposes of the monument, the
24 Secretary is also authorized to acquire from willing sellers
25 only, by donation, purchase with donated or appropriated

1 funds, or exchange not to exceed 65 acres outside the
2 boundary depicted on the map referred to in section 301
3 and develop and operate thereon research, information, in-
4 terpretive, and administrative facilities. Lands acquired
5 and facilities developed pursuant to this subsection shall
6 be administered by the Secretary as part of the monu-
7 ment. The boundary of the monument shall be modified
8 to include the lands added under this subsection as a non-
9 contiguous parcel.”.

10 **SEC. 107. WUPATKI NATIONAL MONUMENT BOUNDARY AD-**
11 **JUSTMENT.**

12 The boundary of the Wupatki National Monument,
13 Arizona, is hereby revised to include the lands and inter-
14 ests in lands within the area generally depicted as “Pro-
15 posed Addition 168.89 Acres” on the map entitled
16 “Boundary—Wupatki and Sunset Crater National Monu-
17 ments, Arizona”, numbered 322–80,021, and dated April
18 1989. The map shall be on file and available for public
19 inspection in the Office of the National Park Service, De-
20 partment of the Interior. Subject to valid existing rights,
21 Federal lands, and interests therein within the area added
22 to the monument by this section are hereby transferred
23 without monetary consideration or reimbursement to the
24 administrative jurisdiction of the National Park Service,

1 to be administered as part of the monument in accordance
 2 with the laws and regulations applicable thereto.

5 **SEC. 201. ADVISORY COMMISSIONS.**

 8 ~~Recreation Act of 1978 (16 U.S.C. 396d(f)(7)), is amend-~~
 9 ~~ed by striking out “ten years” and inserting in lieu thereof~~
 10 ~~“twenty years”.~~

11 (b) ~~WOMEN’S RIGHTS NATIONAL HISTORICAL PARK,~~
 12 ~~NY.—Section 1601(h)(5) of the Act of December 28,~~
 13 ~~1980 (16 U.S.C. 4101l(h)(5)), is amended by striking “ten~~
 14 ~~years” and inserting in lieu thereof “twenty-five years”.~~

15 **SEC. 202. FORT PULASKI NATIONAL MONUMENT, GA.**

16 Section 4 of the Act of June 26, 1936 (ch. 844; 49
 17 Stat. 1979), is amended by striking out “: *Provided,*
 18 *That*” and all that follows and inserting in lieu thereof
 19 a period.

20 **SEC. 203. AMENDMENT OF BOSTON NATIONAL HISTORIC**
 21 **PARK ACT.**

22 Section 3(b) of the Boston National Historical Park
 23 Act of 1974 (16 U.S.C. 410z-1(b)) is amended by insert-
 24 ing “(1)” before the first sentence thereof and by adding
 25 the following at the end thereof:

1 “(2) The Secretary of the Interior is authorized to
2 enter into a cooperative agreement with the Boston Public
3 Library to provide for the distribution of informational
4 and interpretive materials relating to the park and to the
5 Freedom Trail.”.

6 **TITLE III—GENERAL**
7 **AUTHORIZATIONS AND**
8 **REPEALERS**

9 **SEC. 301. LIMITATION ON PARK BUILDINGS.**

10 The 10th undesignated paragraph (relating to a limi-
11 tation on the expenditure of funds for park buildings)
12 under the heading “MISCELLANEOUS OBJECTS, DEPART-
13 MENT OF THE INTERIOR”, which appears under the head-
14 ing “UNDER THE DEPARTMENT OF THE INTE-
15 RIOR”, as contained in the first section of the Act of Au-
16 gust 24, 1912 (37 Stat. 460), as amended (16 U.S.C.
17 451), is hereby repealed.

18 **SEC. 302. APPROPRIATIONS FOR TRANSPORTATION OF**
19 **CHILDREN.**

20 The first section of the Act of August 7, 1946 (16
21 U.S.C. 17j-2), is amended by adding at the end the follow-
22 ing:

23 “(j) Provide transportation for children in nearby
24 communities to and from any unit of the National Park

1 System used in connection with organized recreation and
2 interpretive programs of the National Park Service.”.

3 **SEC. 303. FERAL BURROS AND HORSES.**

4 Section 9 of the Act of December 15, 1971 (16
5 U.S.C. 1338a), is amended by adding at the end thereof
6 the following: “Nothing in this Act shall be deemed to
7 limit the authority of the Secretary in the management
8 of units of the National Park System, and the Secretary
9 may, without regard either to the provisions of this Act,
10 or section 47(a) of title 18, United States Code, use motor
11 vehicles, fixed-wing aircraft and helicopters, or contract
12 for such use, in furtherance of the management of the Na-
13 tional Park System, and the provisions of section 47(a)
14 of title 18, United States Code, shall not be applicable to
15 such use.”.

16 **SEC. 304. AUTHORITIES OF THE SECRETARY OF THE INTE-**
17 **RIOR RELATING TO MUSEUMS.**

18 (a) FUNCTIONS.—The Act entitled “An Act to in-
19 crease the public benefits from the National Park System
20 by facilitating the management of museum properties re-
21 lating thereto, and for other purposes” approved July 1,
22 1955 (16 U.S.C. 18f), is amended—

23 (1) in paragraph (b) of the first section, by
24 striking out “from such donations and bequests of
25 money”; and

1 (2) by adding at the end thereof the following:

2 **“SEC. 2. ADDITIONAL FUNCTIONS.**

3 “(a) In addition to the functions specified in the first
4 section of this Act, the Secretary of the Interior may per-
5 form the following functions in such manner as he shall
6 consider to be in the public interest:

7 “(1) Transfer museum objects and museum col-
8 lections that the Secretary determines are no longer
9 needed for museum purposes to qualified Federal
10 agencies that have programs to preserve and inter-
11 pret cultural or natural heritage, and accept the
12 transfer of museum objects and museum collections
13 for the purposes of this Act from any other Federal
14 agency, without reimbursement. The head of any
15 other Federal agency may transfer, without reim-
16 bursement, museum objects and museum collections
17 directly to the administrative jurisdiction of the Sec-
18 retary of the Interior for the purposes of this Act.

19 “(2) Convey museum objects and museum col-
20 lections that the Secretary determines are no longer
21 needed for museum purposes, without monetary con-
22 sideration but subject to such terms and conditions
23 as the Secretary deems necessary, to private institu-
24 tions exempt from Federal taxation under section
25 501(c)(3) of the Internal Revenue Code of 1986 and

1 to non-Federal governmental entities if the Secretary
2 determines that the recipient is dedicated to the
3 preservation and interpretation of natural or cultural
4 heritage and is qualified to manage the property,
5 prior to any conveyance under this subsection.

6 ~~“(3) Destroy or cause to be destroyed museum~~
7 ~~objects and museum collections that the Secretary~~
8 ~~determines to have no scientific, cultural, historic,~~
9 ~~educational, esthetic, or monetary value.~~

10 ~~“(b) The Secretary shall ensure that museum objects~~
11 ~~and museum collections are treated in a careful and delib-~~
12 ~~erate manner that protects the public interest. Prior to~~
13 ~~taking any action under subsection (a), the Secretary shall~~
14 ~~establish a systematic review and approval process, includ-~~
15 ~~ing consultation with appropriate experts, that meets the~~
16 ~~highest standards of the museum profession for all actions~~
17 ~~taken under this section.”.~~

18 ~~(b) APPLICATION AND DEFINITIONS.—The Act enti-~~
19 ~~led “An Act to increase the public benefits from the Na-~~
20 ~~tional Park System by facilitating the management of mu-~~
21 ~~seum properties relating thereto, and for other purposes”~~
22 ~~approved July 1, 1955 (16 U.S.C. 18f), as amended by~~
23 ~~subsection (a), is further amended by adding the following:~~

1 **“SEC. 3. APPLICATION AND DEFINITIONS.**

2 “(a) APPLICATION.—Authorities in this Act shall be
3 available to the Secretary of the Interior with regard to
4 museum objects and museum collections that were under
5 the administrative jurisdiction of the Secretary for pur-
6 poses of the National Park System before the date of en-
7 actment of this section as well as those museum objects
8 and museum collections that may be acquired on or after
9 such date.

10 “(b) DEFINITIONS.—For the purposes of this Act,
11 the terms ‘museum objects’ and ‘museum collections’
12 mean objects that are eligible to be or are made part of
13 a museum, library, or archive collection through a formal
14 procedure, such as accessioning. Such objects are usually
15 movable and include but are not limited to prehistoric and
16 historic artifacts, works of art, books, documents, photo-
17 graphs, and natural history specimens.”.

18 **SEC. 305. VOLUNTEERS IN THE PARKS INCREASE.**

19 Section 4 of the Volunteers in the Parks Act of 1969
20 (16 U.S.C. 18j) is amended by striking out “\$1,000,000”
21 and inserting in lieu thereof “\$1,750,000”.

22 **SEC. 306. COOPERATIVE AGREEMENTS FOR RESEARCH**
23 **PURPOSES.**

24 Section 3 of the Act entitled “An Act to improve the
25 administration of the National Park System by the Sec-
26 retary of the Interior, and to clarify the authorities appli-

1 cable to the system, and for other purposes” approved Au-
2 gust 18, 1970 (16 U.S.C. 1a-2), is amended—

3 (1) in paragraph (i), by striking out the period
4 at the end thereof and inserting in lieu thereof “;,
5 and”; and

6 (2) by adding at the end thereof the following:

7 “(j) enter into cooperative agreements with
8 public or private educational institutions, States,
9 and their political subdivisions, or private conserva-
10 tion organizations for the purpose of developing ade-
11 quate, coordinated, cooperative research and training
12 programs concerning the resources of the National
13 Park System, and, pursuant to such agreements, to
14 accept from and make available to the cooperator
15 such technical and support staff, financial assistance
16 for mutually agreed upon research projects, supplies
17 and equipment, facilities, and administrative services
18 relating to cooperative research units as the Sec-
19 retary deems appropriate; except that this paragraph
20 shall not waive any requirements for research
21 projects that are subject to the Federal procurement
22 regulations.”.

1 **SEC. 202. AMENDMENT OF BOSTON NATIONAL HISTORIC**
2 **PARK ACT.**

3 *Section 3(b) of the Boston National Historical Park*
4 *Act of 1974 (16 U.S.C. 410z-1(b)) is amended by inserting*
5 *“(1)” before the first sentence thereof and by adding the fol-*
6 *lowing at the end thereof:*

7 *“(2) The Secretary of the Interior is authorized to*
8 *enter into a cooperative agreement with the Boston Public*
9 *Library to provide for the distribution of informational and*
10 *interpretive materials relating to the park and to the Free-*
11 *dom Trail.”.*

12 **TITLE III—GENERAL AUTHOR-**
13 **IZATIONS AND REPEALERS**

14 **SEC. 301. LIMITATION ON PARK BUILDINGS.**

15 *The 10th undesignated paragraph (relating to a limi-*
16 *tation on the expenditure of funds for park buildings) under*
17 *the heading “MISCELLANEOUS OBJECTS, DEPARTMENT OF*
18 *THE INTERIOR”, which appears under the heading*
19 *“UNDER THE DEPARTMENT OF THE INTERIOR”,*
20 *as contained in the first section of the Act of August 24,*
21 *1912 (37 Stat. 460), as amended (16 U.S.C. 451), is hereby*
22 *repealed.*

1 **SEC. 302. APPROPRIATIONS FOR TRANSPORTATION OF**
2 **CHILDREN.**

3 *The first section of the Act of August 7, 1946 (16*
4 *U.S.C. 17j-2), is amended by adding at the end the follow-*
5 *ing:*

6 *“(j) Provide transportation for children in nearby*
7 *communities to and from any unit of the National Park*
8 *System used in connection with organized recreation and*
9 *interpretive programs of the National Park Service.”.*

10 **SEC. 303. FERAL BURROS AND HORSES.**

11 *Section 9 of the Act of December 15, 1971 (16 U.S.C.*
12 *1338a), is amended by adding at the end thereof the follow-*
13 *ing: “Nothing in this Act shall be deemed to limit the au-*
14 *thority of the Secretary in the management of units of the*
15 *National Park System, and the Secretary may, without re-*
16 *gard either to the provisions of this Act, or section 47(a)*
17 *of title 18, United States Code, use motor vehicles, fixed-*
18 *wing aircraft and helicopters, or contract for such use, in*
19 *furtherance of the management of the National Park Sys-*
20 *tem, and the provisions of section 47(a) of title 18, United*
21 *States Code, shall not be applicable to such use.”.*

22 **SEC. 304. AUTHORITIES OF THE SECRETARY OF THE INTE-**
23 **RIOR RELATING TO MUSEUMS.**

24 *(a) FUNCTIONS.—The Act entitled “An Act to increase*
25 *the public benefits from the National Park System by facili-*
26 *tating the management of museum properties relating*

1 *thereto, and for other purposes*” approved July 1, 1955 (16
2 *U.S.C. 18f*), is amended—

3 (1) *in paragraph (b) of the first section, by strik-*
4 *ing out “from such donations and bequests of money”;*
5 *and*

6 (2) *by adding at the end thereof the following:*

7 **“SEC. 2. ADDITIONAL FUNCTIONS.**

8 “(a) *In addition to the functions specified in the first*
9 *section of this Act, the Secretary of the Interior may per-*
10 *form the following functions in such manner as he shall*
11 *consider to be in the public interest:*

12 “(1) *Transfer museum objects and museum col-*
13 *lections that the Secretary determines are no longer*
14 *needed for museum purposes to qualified Federal*
15 *agencies that have programs to preserve and interpret*
16 *cultural or natural heritage, and accept the transfer*
17 *of museum objects and museum collections for the*
18 *purposes of this Act from any other Federal agency,*
19 *without reimbursement. The head of any other Fed-*
20 *eral agency may transfer, without reimbursement,*
21 *museum objects and museum collections directly to*
22 *the administrative jurisdiction of the Secretary of the*
23 *Interior for the purposes of this Act.*

24 “(2) *Convey museum objects and museum collec-*
25 *tions that the Secretary determines are no longer*

1 *needed for museum purposes, without monetary con-*
2 *sideration but subject to such terms and conditions as*
3 *the Secretary deems necessary, to private institutions*
4 *exempt from Federal taxation under section 501(c)(3)*
5 *of the Internal Revenue Code of 1986 and to non-Fed-*
6 *eral governmental entities if the Secretary determines*
7 *that the recipient is dedicated to the preservation and*
8 *interpretation of natural or cultural heritage and is*
9 *qualified to manage the property, prior to any con-*
10 *veyance under this subsection.*

11 “(3) Destroy or cause to be destroyed museum
12 objects and museum collections that the Secretary de-
13 termines to have no scientific, cultural, historic, edu-
14 cational, esthetic, or monetary value.

15 “(b) The Secretary shall ensure that museum objects
16 and museum collections are treated in a careful and delib-
17 erate manner that protects the public interest. Prior to tak-
18 ing any action under subsection (a), the Secretary shall es-
19 tablish a systematic review and approval process, including
20 consultation with appropriate experts, that meets the high-
21 est standards of the museum profession for all actions taken
22 under this section.”.

23 (b) APPLICATION AND DEFINITIONS.—The Act entitled
24 “An Act to increase the public benefits from the National
25 Park System by facilitating the management of museum

1 *properties relating thereto, and for other purposes” ap-*
2 *proved July 1, 1955 (16 U.S.C. 18f), as amended by sub-*
3 *section (a), is further amended by adding the following:*

4 **“SEC. 3. APPLICATION AND DEFINITIONS.**

5 “(a) *APPLICATION.*—*Authorities in this Act shall be*
6 *available to the Secretary of the Interior with regard to mu-*
7 *seum objects and museum collections that were under the*
8 *administrative jurisdiction of the Secretary for purposes of*
9 *the National Park System before the date of enactment of*
10 *this section as well as those museum objects and museum*
11 *collections that may be acquired on or after such date.*

12 “(b) *DEFINITIONS.*—*For the purposes of this Act, the*
13 *terms ‘museum objects’ and ‘museum collections’ mean ob-*
14 *jects that are eligible to be or are made part of a museum,*
15 *library, or archive collection through a formal procedure,*
16 *such as accessioning. Such objects are usually movable and*
17 *include but are not limited to prehistoric and historic arti-*
18 *facts, works of art, books, documents, photographs, and nat-*
19 *ural history specimens.”.*

20 **SEC. 305. VOLUNTEERS IN THE PARKS INCREASE.**

21 *Section 4 of the Volunteers in the Parks Act of 1969*
22 *(16 U.S.C. 18j) is amended by striking out “\$1,000,000”*
23 *and inserting in lieu thereof “\$1,750,000”.*

1 **SEC. 306. COOPERATIVE AGREEMENTS FOR RESEARCH PUR-**
2 **POSES.**

3 *Section 3 of the Act entitled “An Act to improve the*
4 *administration of the National Park System by the Sec-*
5 *retary of the Interior, and to clarify the authorities applica-*
6 *ble to the system, and for other purposes” approved August*
7 *18, 1970 (16 U.S.C. 1a-2), is amended—*

8 *(1) in paragraph (i), by striking out the period*
9 *at the end thereof and inserting in lieu thereof “;*
10 *and”;* and

11 *(2) by adding at the end thereof the following:*

12 *“(j) enter into cooperative agreements with pub-*
13 *lic or private educational institutions, States, and*
14 *their political subdivisions, or private conservation*
15 *organizations for the purpose of developing adequate,*
16 *coordinated, cooperative research and training pro-*
17 *grams concerning the resources of the National Park*
18 *System, and, pursuant to such agreements, to accept*
19 *from and make available to the cooperator such tech-*
20 *nical and support staff, financial assistance for mu-*
21 *tually agreed upon research projects, supplies and*
22 *equipment, facilities, and administrative services re-*
23 *lating to cooperative research units as the Secretary*
24 *deems appropriate; except that this paragraph shall*
25 *not waive any requirements for research projects that*
26 *are subject to the Federal procurement regulations.”.*

1 **SEC. 307. CARL GARNER FEDERAL LANDS CLEANUP DAY.**

2 *The Federal Lands Cleanup Act of 1985 (36 U.S.C.*
3 *169i–169i–1 is amended by striking “Federal Lands Clean-*
4 *up Day” each place it occurs and inserting in lieu thereof,*
5 *“Carl Garner Federal Lands Cleanup Day”.*

6 **SEC. 308. CORINTH INTERPRETIVE CENTER.**

7 (a) *SHORT TITLE.*—*This section may be cited as the*
8 *“Corinth, Mississippi, Battlefield Act of 1994”.*

9 (b) *FINDINGS.*—*The Congress finds that—*

10 (1) *the 14 sites located in the vicinity of Corinth,*
11 *Mississippi, that were designated as a National His-*
12 *toric Landmark by the Secretary of the Interior in*
13 *1991 represent nationally significant events in the*
14 *Siege and Battle of Corinth during the Civil War;*
15 *and*

16 (2) *the National Historic Landmark sites should*
17 *be preserved and interpreted for the benefit, inspira-*
18 *tion, and education of the people of the United States.*

19 (c) *PURPOSE.*—*It is the purpose of this section to pro-*
20 *vide for a center for the interpretation of the Siege and Bat-*
21 *tle of Corinth and other Civil War actions in the region*
22 *and to ensure public understanding of the significance of*
23 *the Corinth Campaign in the Civil War relative to the West-*
24 *ern theater of operations, in cooperation with State or local*
25 *governmental entities and private organizations and indi-*
26 *viduals.*

1 (d) *ACQUISITION OF PROPERTY.—(1) IN GENERAL.—*
2 *The Secretary of the Interior (hereinafter referred to as the*
3 *“Secretary”) is authorized to acquire by donation, purchase*
4 *with donated or appropriated funds, or exchange, such*
5 *lands or interests therein in the vicinity of the Corinth bat-*
6 *tlefield in the State of Mississippi, as the Secretary deter-*
7 *mines necessary for the construction of an interpretive cen-*
8 *ter to commemorate and interpret the 1862 Civil War Siege*
9 *and Battle of Corinth: Provided, That such lands or inter-*
10 *ests therein shall only be acquired with the consent of the*
11 *owner thereof.*

12 (2) *Lands and interests therein owned by the State of*
13 *Mississippi or a political subdivision thereof may be ac-*
14 *quired only by donation.*

15 (e) *CONSTRUCTION OF CENTER.—The Secretary is au-*
16 *thorized to construct, operate, and maintain on the prop-*
17 *erty acquired under subsection (d) a center for the interpre-*
18 *tation of the Siege and Battle of Corinth and associated*
19 *historical events. The center shall include interpretive exhib-*
20 *its and such other features as may be necessary for public*
21 *appreciation and understanding of the Siege and Battle of*
22 *Corinth.*

23 (f) *MARKING.—The Secretary may mark sites associ-*
24 *ated with the Siege and Battle of Corinth National Historic*
25 *Landmark, as designated on May 6, 1991, if such sites are*

1 *determined by the Secretary to be protected by State or local*
2 *governmental agencies.*

3 (g) *ADMINISTRATION.*—*The lands and interests in*
4 *lands acquired, and the facilities constructed and main-*
5 *tained pursuant to this section shall be administered by the*
6 *Secretary as a part of Shiloh National Military Park, sub-*
7 *ject to the appropriate laws and regulations applicable to*
8 *the park, the Act of August 25, 1916 (39 Stat. 535, chapter*
9 *408; 16 U.S.C. 1 et seq.), and the Act of August 21, 1935*
10 *(49 Stat. 666, chapter 593; 16 U.S.C. 461 et seq.).*

11 (h) *IN GENERAL.*—(1) *Subject to paragraph (2), there*
12 *are authorized to be appropriated such sums as are nec-*
13 *essary to carry out this section.*

14 (2) *CONSTRUCTION.*—*Of the amounts made available*
15 *to carry out this section, not more than \$6,000,000 may*
16 *be used to carry out section 4(a).*
