## A BILL

To guarantee cost-of-living adjustments in fiscal year 1994 for persons receiving benefits under civil service retirement and military retirement and survivor benefit programs.

5 **SECTION 1. BENEFITS PAYABLE FROM THE CIVIL SERVICE**

6 **RETIREMENT AND DISABILITY FUND.**

7 (a) ADJUSTMENTS PROTECTED.—Any percentage  
8 adjustment provided by sections 8340 and 8462 of title

1 5, United States Code, to be made during fiscal year 1994  
2 in annuities payable from the Civil Service Retirement and  
3 Disability Fund referred to in section 8348 of such title  
4 shall be made and take effect in accordance with such sec-  
5 tions.

6 (b) REDUCTION OR SUSPENSION PROHIBITED.—  
7 During fiscal year 1994, an adjustment described in sub-  
8 section (a) shall not be subject to reduction or suspension  
9 under any Presidential order or any provision of law, ex-  
10 cept applicable provisions of chapters 83 and 84 of such  
11 title.

12 **SEC. 2. MILITARY RETIREMENT AND SURVIVOR BENEFIT**  
13 **PROGRAMS.**

14 (a) ADJUSTMENTS PROTECTED.—Any percentage  
15 adjustment provided by sections 1401a and 1451(g) of  
16 title 10, United States Code, or any other provision of law,  
17 to be made during fiscal year 1994 in amounts payable  
18 under military retirement and survivor benefit programs  
19 shall be made and take effect in accordance with such  
20 laws.

21 (b) REDUCTION OR SUSPENSION PROHIBITED.—  
22 During fiscal year 1994, an adjustment described in sub-  
23 section (a) shall not be subject to reduction or suspension  
24 under any Presidential order or any provision of law, ex-  
25 cept applicable provisions of title 10, United States Code.

1 (c) DEFINITIONS.—For purposes of this Act:

2 (1) The term “military retirement and survivor  
3 benefit programs” means—

4 (A) the provisions of law creating entitle-  
5 ment to, or determining the amount of, retired  
6 or retainer pay for members of the uniformed  
7 services; and

8 (B) the programs providing annuities for  
9 survivors of members and former members of  
10 the uniformed services, including chapter 73  
11 such title, section 4 of Public Law 92–425 (10  
12 U.S.C. 1448 note), and section 5 of Public Law  
13 96–402 (10 U.S.C. 1448 note).

14 (2) The term “uniformed services” has the  
15 meaning given that term in section 101(3) of title  
16 37, United States Code.
